#### State Auditors Report.

Present: TrusteesGoodness and Wilson, Treas. Theresa P. Smith, Atty. Nesbitt, and Clerk Fisk.

Dept.Audit

& Control: Mr. James Kill

Criticisms: 1. Purchase of 91 day U.S.Govt.bills bering interest should have a receipt on file for the funds until returned.

- 2. Hotel Bills and traveling expense bills should be attached to "vouchers" and receipted.
- 3. Certification of Town Clerk who reports vital statistics to Albany-for village, that "reports were made on time"
- 4. Options for purchase of real property should be paid by Board of Trustees and not reimbursed to attorney.
- 5. Classification ledger should be kept by Treasurer or deputy Treasurer appointed so clerk may do it.
- 6.Bank accounts could be consolidated to care for Foreign Fire Insurance account, Social Security, Blue Cross, and accounted on one page in columns.
- 7. Board of Trustees should "designate" people who are to collect moneys for village.
- 8. Warrant on tax roll 1957-58 was not completed (all taxes were collected nevertheless).
- 9. Account "Tax Arrears Board" not suitable for tax collector. (no account is provided inManual at this time for tax ")

- 10. Capital accounts are specific as to the particular purpose for which they were intended to be spent, vague. Should be for definite purpose.
- Duplicate receipts should be numbered by cemetery collector and are not presently numbered.
- 12. Water billing and collecting should be separate employees, also applies to cemetery.
- 13. Tree removals 1957-58 let on bid-but invoice does not clearly indicate amount of bid and mixes tree trimming costs with removals.
- 14. Resolution should be in minutes for extra work which is over and above bid.
- 15. Civil Defense funds from U.S. Govt. should be all contributed to village and all expenditures by village-not to fire company.
- 16. Compensation insurance premiums should be divided between general fund and water fund, and not all charged to General "unallocated" fund.
- 17. Police Chief phone bill paid by village and is listed under private name. Should be listed under "Village-Police Chief". (inquiry from phone company-costs would be \$4.00 per month extra)
- 18. No bids were made for fire hose (\$1020.00). If annual purchases of salt or meters or other merchandise is approaching accumulative purchases of \$1000.00 bids should be put out before purchase reaches \$1000.00.
- 19. No red ink should be in single entry books for disbursements. Treasurer should deposit all moneys from sale of bonds and withdraw for additional purchases rather than cash bonds and make purchase without having made deposit.

- 20.0n Trust Accounts separate columns should be kept for principal and income. Another type of sheet purchased for this accounting.
- 21. Authorization for purchase of securities should be in minutes each time purchases are made.
- 22. Capital Funds for both General and Water should be in separate bank account and not mixed with General or Water funds, and accounted in colums for the various specific purposes that they were intended to be used. A transfer of present capital funds should be made.
- 23. Should appoint a Youth Commission from Community Center directors to approve vouchers for payment of Center bills and be paid from village funds, which contributions from Center and State Youth Commission be shown as income. Town should do same.
- 24. Trustees should audit annually Police Justice and Treasurers accounts.
- 25. Designate someone to set up bank account for park meter fines for forwarding to Albany Dept.of Audit and control.
- 26. Deposits in Columbia Savings & Loan are not legal as they have not been approved by N.Y. State as depositories, even tough insured by U.S. Government up to \$10,000.00. (Present deposits are under \$10000.)
- 27. Water contracts with three water districts are not legal due to terms. Collections from districts should be deposited in separate account by water collector and remitted to town supervisor.
- 28. Living quarters furnished to Police or Water Plant Operator should be included in annual Board meeting as income other than wages and social security be provided for over cash wage.
- 29. Ordinance Book should be brought up to date and revised.
- 30. No resolution in minutes for creation of the "Dump reserve fund" and its purpose.
- 31. Parking meter funds should be double locked, one key with police and one key with funds custodian. A police officer should be present to watch the counting of the funds.
- 32. Acting police justice overlooked remitting fines for one quarter to Albany and he brought in check to cover full amount.
- 33. Neither Treasurer nor clerk made affadavit and oath of office in oath book for 1957-58.
- 34. Trust fund bonds should be registered, rather than coupon type bonds. Also registration should be in name of particular fund rather than "Village of Palmyra" only.

WHEREAS, the Sewage Commission of the Village of Palmyra has recommended to the Board of Trustees of the Village of Palmyra that further test borings be made for the completion of plans for a sewer system and a sewage treatment plant, and

WHEREAS, it appears that there are no moneys available or provided in the general village funds for such test borings and that the estimated cost thereof will not exceed the sum of \$1,500.00; and

WHEREAS, it further appears that the present balance in the Capital Reserve Fund known as the Highway Machinery Fund is in excess of that which this Board feels will be needed for expenditure during the current year,

NOW, THEREFORE, BE IT RESOLVED, that there be established a Capital Reserve Fund known as Sewage System Test Boring Fund the purpose of which shall be to provide moneys to pay for test borings in connection with the Completion of plans for a sewer system and a sewage treatment plant, and
