Present:

Warner H. Strong, Mayor; Trustees James Elliott, John Vrubel & Penelope Frontuto. Absent: C. D. Gilmore, Trustee. Present also - JohnB. Nesbitt, Esq., Village Attorney.

MOS:

The Mayor req. a moment of silence prior to conducting the business of the Bd. - asking that special remembrance be mde. for Village employee, Forest Huff, whose father passed away - and for the survivors of those aboard the U.S. Stark which was attacked - and the families of those who perished.

Agenda:

The Mayor read the Agenda as adopted @ the 4/13/87 Bd. Mtg. He asked the Clk. to read additions rec'd after the Friday a.m. deadline; Listed were: Assessor J. Roney; communic. frm. HUD; communic. frm. Ogdensburg; Veterans' Administration; Fed. Management re Flood Ins.; Franchise (J. Roney); communic. frm. Binghamton re NYCOM meeting; Mr. Palmer; Clk. req. Exec. Sess.; and bid awards. Trustee Vrubel moved inclusion/Agenda; Trustee Frontuto seconded. Voting "aye" were Trustees Vrubel & Frontuto; voting "nay" were Trustee Elliott & Mayor Strong. Impasse reached by Bd. - Mayor req. that the above be stricken frm. Agenda - placement on Agenda @ nxt. Bd. mtg.

5/4/87 Minutes:

Trustee Frontuto motioned Bd. acceptance as written; Trustee Elliott seconded. Voting "aye" were Trustees Elliott & Frontuto & Mayor Strong; Trustee Vrubel abstained. Carried by majority.

Trustee Elliott:

Trustee Elliott sd. that Plng. Bd. met and approved variance as req. by P. T. Freund (Box Factory).

Trustee Vrubel: Trustee Vrubel reported that furniture ordered re use in conjunction wth. computer shld. arrive in couple of wks. He related request frm. JC's re their purchase of draperies for rm. they use (upper east) - and their desire to have a ltr. for permanent use. Referred to Atty. Nesbitt. Painting trim/P&C Rms. - Mr. Vrubel to obtain estimates locally. No rpt. frm. Dog Warden at this time.

Chamber of Commerce:

Mr. Harold Boerman, Pres., CofC, approached the Bd. re his prior communication - approx. 50 Chamber members who are committed to improving the Palmyra business district/community, concentrating on Main St. He had previously present "Guidelines frm. Bldg. Owners" for Bd. approval; to hand out to their tenants. He spke. of obtaining discarded drums frm. Garlock (gratis) - shld. be painted and placed strategically around Vill. Mayor sd. that prev. sme. had disappeared, req. H-Way Supt. to look at situation. Short disc. on "Dumpster Days"/ ramp built/placement @ H-way Barns. Trustee Vrubel sd. that Mrs. L. Green had been looking for Boy/Girl Scout Proj. Good

Mr. Boerman sd. more flower boxes to be added to Main St. Disc. on locust trees' growth/roots coming thru sidewlks. in places. Need for trimming stated. Lot nxt. to upholstery store disc. - private land. Disc. on street-cleaning - State & H-Way sweep Main St., per P. Retan. CofC wished success in campaign "Palmyra Awakening."

Trustee Frontuto:

Trustee Frontuto sd. Bicentennial Committee mtg. held prior Thurs - developing Executive Committee which will be working on history of the community - plans for publication re legends of the area/"Old Timers" - nxt. mtg. in Sept.

Mayor sd. assessed prop. value went down - have to reduce budget by \$3,000. - money carried forward less than anticipated. Where wld. money come frm. P. Retan sd. bill wld. not come for 30 day - nxt. yr.'s budget? Mayor sd. to cut P.O./take out of nxt. yr.'s funds - commit up to \$2500. to have crane/fix Flagpole & fix unit which makes Flag go up and dwn. Mayor so motioned; Trustee Frontuto seconded. Voting "aye" were Trustees Frontuto, Elliott & Vrubel. Carried.

Auction:

Assessor Roney:

Can't reduce tax rate/have to reduce budget by approx. \$1,000. \$13.94/\$13.90 disc. Assessed base going dwn. instead of up. Mayor to ck. wth. Roy McMasters on following day.
