

Quest. of Clean. HmeOwner Sewers: An article in the Times Union indicated that the Village of Newark charges a fee for the cleaning of a home-owner's sanitary sewer line from the home to the lateral in the main. Clerk indicated that Ray Smith, highway foreman is called about once a week for such a chore. Consensus of the board indicated that at the present time the clerk keep a record of these calls which should be brought to the attention of the board at a later time.

Civil Defense: A memo indicated that the Office of Civil Defense in Lyons would be open the 2nd and 4th Tuesday of the month.

Workshop Syracuse: Mayor Nussbaumer informed the board that the workshop that he attended at Syracuse on January 15, 1972 was most informative.

Shut-Off Former Abbott Rest. : Clerk informed the board that the water bill had not been paid by Conrad Skorc, owner of the former Abbott Restaurant on East Main Street, restaurant which is leased to a couple who are striving to have a good eating place. Water Operator VanEtten had informed the clerk that it was not possible to shut the water off due to the fact that the meter was located in a pit which was not easily reached by a man, let alone attempt to work on the meter which has been stopped for some time. Board informed the clerk to advise Operator VanEtten to demand that the owner arrange the plumbing so that the meter could be worked on and if he resisted, the police should be called in.

O.&M. State Aid : A letter from the State of N.Y. Department of Environmental Conservation advised that State Aid in the amount of \$1,808.28 would be forthcoming for assistance in the operation and maintenance of the Sewage Disposal Plant for the fiscal year 1970-71 (6/1/70 - 5/31/71) (Note: This is based on 1/3 of the operation and maintenance costs attributable to the Sewage Disposal Plant. Actually, we had applied for \$4,102.62, but because of audit adjustments from 6/1/64 - 5/31/69, items which the auditor informed us were not eligible, an amount of \$2,294.34 was deducted leaving a net amount of \$1,808.28, to be received at this time.)

American LaFrance Rep. : Robert Ellis, a representative of the American LaFrance Co., of Elmira, N.Y. discussed with the board a 1,000 gallon tanker pumper. Fire Chief Culver and Asst. Fire Chief White were present to pose any questions that they might have regarding the mechanism. Mr. Ellis recommended to the board specs for a standard tanker. He commented that a rumor had been circulated that "American LaFrance" was moving from the Elmira area. He emphasized that this rumor was quite false.

General Code Publish: John F. Zea, of the General Code Publishers, Spencerport, N.Y., briefly commented that the Village of Palmyra ordinances were coded in 1964, updated in 1966 and as he expressed it, "in limbo" ever since. It was his suggestion that any ordinances and local laws passed since 1966 be brought up to date in the code book. The next procedure would be to adopt the code as the "law of the community". Mr. Zea remarked that the General Code Publishers have done 300 villages in the State of New York. It would be his suggestion that most all the local laws adopted since 1966 should be copied in total with the exception of the Fire Code, which according to Mr. Zea, could be referred to.

Village Attorney, Henry B. Nesbitt, informed the board that he had discussed adoption of the Code with Mr. Kipp in Albany who advised that a hearing can be held relative to adopting the code which would be satisfactory to the Secretary of State of New York. (Attorney Nesbitt further commented that in 1964 when the ordinances were coded, it appeared that the total code would have to be printed in full in the newspaper, cost of which would be enormous!!!) According to Mr. Zea, it would be his suggestion that (1) Bring the code up to date; (2) Adopt as a code; (3) Then go through to bring traffic and vehicle ordinance in focus.

Itemizes
Cost:

According to Mr. Zea, there are approximately 622 pages in all, but, it would be his suggestion to refer to only the housing and fire codes, thereby cutting the pages down to 162 for a cost of approximately \$20.00 per page. If this were done, it would be possible to have printed pamphlets of the code printed for a cost of \$380.00 for 100, \$445.00 for 200, and \$510.00 for 300. They could then be sold to the public for a fee of at least \$1.00.

Multiple
Housing:

Luther Sheldon, Chairman of the Zoning Board of Appeals, and Jay Wiley, Chairman of the Planning Board, discussed with the board the recent hearing relative to the multiple housing proposed change. Attorney Nesbitt interjected that he felt the proposed changes be reworded, a new hearing date set and then the board could decide if it wished to pass the amendment.

H.B. Nesbitt, Attorney, commented that he felt that if this amendment were passed, many of the old large homes, which in the past have been one family mansions, could not be retained by a new owner and eventually the building would deteriorate to the point where it would be so badly run-down, it could be classified in the category of a "ghost-area". In other words, it was Mr. Nesbitt's inference that many of the large old homes could be maintained if they were converted into 2 family dwellings, but as a single house, could become a drag on the market. Zoning Officer Bruce Wideman informed the board that the Village of Palmyra is the only village in Wayne County which allows multiple dwellings in an R-1 Area with a Special Permit.

Dedicat. of Ambulance Bldg. : An invitation addressed to the Village Board informed board members of the dedication of the ambulance building on Prospect Drive on Sunday, February 27, 1972 from 2:00 P.M. to 5:00 P.M. at which time board members and their families are urged to be present.

Resig. Patrol. J. McClellan: A letter received from Patrolman John T. McClellan revealed that he wished to be relieved of his duties with the Palmyra Police Department effective as of February 9, 1972 due to help problems in his personal business. Motion by Trustee Green, 2nd by Trustee Alderman and carried to accept the resignation.

Div.Hsg. & Comm. Renewal: A letter addressed to Mayor Nussbaumer from the State of New York, Division of Housing & Community Renewal, advised that Palmyra, New York "Project N.Y.R--212 (Main Street UR Area)" had been reviewed and found acceptable.

NYS Histor. Trust : A letter addressed to Mayor Nussbaumer from Cornelia E. According to his prognostication, there is a potential future use of the dump for the next fifteen (15) years. Attorney Nesbitt interjected that undoubtedly the Town of Palmyra would increase in population much more rapidly in this period than the village primarily because of the geographical area for expansion and building. Moreover, it would be the general consensus of the board that the land that is presently owned by the village should be used and filled up. In all probability at the end of this time, a county landfill or disposal site would be in operation and it would be mandatory for the village to share the burden of the cost.

Mayor Nussbaumer called the hearing to order by reading the subject of the hearing relative to a proposed amendment to the Zoning Code, Local Law #3, 1967, by deleting "Multiple family dwelling or dwelling group containing three or more units together with parking therefor" from Section 401.3 entitled "Used requiring a Special Permit in accordance with Section 702.2 and 710.4."

Proof of Publication in the Palmyra Courier-Journal on February 9, 1972.

Comments:

Zoning Board Chairman, Luther Sheldon, mentioned that the R-1 District was originally designated for the quiet enjoyment of all residents with allowance for multiple housing by request of a Special Permit. Special Permits in the past, he commented, had been granted inasmuch as all technicalities had been met by the appellant.

Mrs. Barbara Watson of West Jackson Street indicated that because a petition was filed with the Zoning Board of Appeals at the time a proposed 4 family dwelling was requested, the request was denied. Mr. Sheldon pointed out that such a petition was filed, but the special permit was denied because the lot size together with required parking spaces did not meet the zoning code requirements. The denial was not because of the petition of the residents.

Donald Sinclair interjected that if this deletion in the Zoning Code is passed, in effect, it would appear that an inference is cast on the Zoning Board of Appeals to the effect that they are not sufficiently versed to evaluate the situation. In addition, according to Mr. Sinclair, there could be the possibility that the village would be eliminating the possibility of enticing attractive buildings in an R-1 provided all requirements for construction are met.

Bruce Wideman, Zoning Officer, mentioned as a point of interest that the Village of Palmyra is the only village in Wayne County that allows multiple housing in an R-1 by Special Permit. Other questions, such as what protection does the home owner have if he lives in an R-1?, some places there are multiple housing existing but the owner does not live in the building or near by, consequently, he is not aware of the problems.

Comments: Further comments by Bruce Wideman which were affirmed by Luther Sheldon that the primary reason the Zoning Board wrote to the Village Board suggesting a change was that the intent of the R-1 District was to preserve the peace and quiet feasible to have two families living in some of the larger, older homes in the R-1 District, if the owner should so choose to remodel. It was revealed that any pre-existing use of a building or home prior to the adoption or change of the zoning ordinance can continue.

Hsg.Code Governs Lodgers: A question was asked in connection with the harboring of veterans or lodgers in an R-1 District. At this point, Mr. Wideman pointed out that the number of lodgers would be governed by the HOUSING CODE and not the Zoning Code.

General comments centered around the proposed multi-million dollar project proposed for Laurentian Drive Area. A question was asked why this was an R-1 District to which the group was informed that when this area in question was annexed in 1962, it became an R-1 District in accordance with the Zoning Code. Any annexed area is automatically classified R-1 until re-zoned by the Village Board.

Hearing Closed: Mayor Nussbaumer asked if there were any further comments relative to the suggested change and if not the hearing would be closed.

BE IT RESOLVED THAT, Lozier, Inc., Rochester, New York, be contacted to make such a survey, the cost of which would not exceed \$1,000.00, such survey to include a valuation of the recent Pitometer Report, the Water System Study by K. G. Woodward Associates in 1968 and the operation of the Canandaigua Lake Pumping Station.

Police Report: The Police Report was reviewed by the board for the month of February, 1972. On motion by Trustee Green, 2nd by Trustee Leysath, the report was ordered filed. Highlights of the report indicated that complaints numbered 176, 5 petit larceny cases, and 70 illegal parking.
