Regular Meeting

Present:

James G. Elliott, Mayor; Trustees Penelope K. Frontuto, C. D. Gilmore, Daniel S. Pope III and Daniel E. Wooden. Absent: Vill. Atty., J. Nesbitt.

Call to Order:

At 7:04 p.m. Mayor Elliott called the meeting to order, following which he requested a moment of silence.

Minutes 6/12/89:

Trustee Pope moved that the 6/12/89 VB Mtg. Minutes be accepted as written; Trustee Wooden seconded. Voting "aye" were Trustees Pope, Wooden, Gilmore & Mayor Elliott. Trustee Frontuto abstained. Carried.

Minutes 6/19/89:

Trustee Wooden moved that the 6/19/89 VB Mtg. Minutes be accepted as written; Trustee Frontuto seconded. Voting "aye" were Trustees Wooden, Frontuto, Pope & Gilmore & Mayor Elliott. Carried.

Minutes 6/27/89:

The Clerk did not submit the brief 6/27/89 Minutes, therefore, held until 9/6/89 mtg.

Minutes 7/10/89:

Corrections to the Minutes of the meeting on the proposed Nolan sub-division/Burnham Hts. between the Town Board of Macedon and the VOP were submitted by Trustee Pope as follows: Pg.4, 13th line...where Mr. Nesbitt is speaking, word "more" shld. be added ("more spent") "municipal" not "county" services; Pg. 5 change word "motion" to "move" (mde. by Mayor Elliott); phrase (near bottom of page)..."no role of records"....cld. be "no role on record," however, determination mde. that "no record of authorization" would provide better explanation; Pg. 6 and Pg. 8 - Burnham Hts. lady's name was "Mrs. Morrison"; Pg. 9 - near bottom of long paragraph where it was stated that deep hole tests performed..instead of "curbs and swales"...should be "question of whether to have storm sewers or swales".....(there will be no curbs there). With the above changes, Trustee Pope moved Minutes acceptance; Trustee Frontuto seconded. Voting was unanimous.

Minutes 7/17/89:

Trustee Frontuto moved VB acceptance, as written, of the 7/17/89 VB Mtg.; Trustee Gilmore seconded. Voting "aye" were Trustees Frontuto, Gilmore, Pope & Mayor Elliott. Trustee Wooden abstained due to his absence until 9:00 p.m.

P.D .:

Chief David Dalton reported that Police Officer David Freeland hired and began duty on 8/15/89; Chief Dalton brt. to the VB's attention a Statemandated (financed by the State) training course which he would like to attend (Amherst, N.Y., 9/5, 6 7/89); Trustee Frontuto moved the Chief's attendance; Trustee Pope seconded. Voting was unanimous by the VB.

Barb.Bsh. Remov.:

Trustee Pope moved that C&P Supt., R. Weaver, remove the Barberry bush and flowering Quince @ the residence of Mr. Stephen Vinci, Corner of Canandaigua/W. Jackson St. in exchange for not restoring the ground at the intersection after shrubbery removal. Trustee Gilmore seconded. Voting "aye" were Trustees Pope, Gilmore, Wooden & Frontuto & Mayor Elliott. Carried.

PO Box Removal:

Trustee Pope said he wld. like for the VB go on record requesting the Postmaster to remove the PO Box @ Corner of E. Foster & Canandaigua Sts. due to

two serious accidents having occurred within past 60 days. VB discussion. Chief Dalton stated that the Postmaster had previously agreed to place wherever desired. VB agreed although no formal vote was taken.

Abstract #4 & Abst. #5:

Trustee Pope moved that the Treas. be authorized to pay Voucher Nos. 201-207 in the amt. of \$6,563.50 (#4); and Voucher Nos. 208-306 (with the exception of V-#234 in amt. of \$28.) totalling \$86,839.76. (#5) on which appear the initials of three VB members. Mayor Elliott seconded. Voting "aye" were Trustees Pope, Wooden, Gilmore & Frontuto & Mayor Elliott. Carried.

F.D.:

Trustee Gilmore moved to have the F.D.'s Sanford Custom Pumper (E-22) repaired, per estimate frm. Sanford Fire Apparatus Corp. @ a cost of \$9,300., sd. monies to be taken frm. Reserve for Fire Equip. (HR-2), thereby constituting necessity for a permissive referendum. Trustee Wooden seconded. Discussion on need for going out to bid (if necessary) - cld. be bid simultaneously wth. perm. ref. waiting period. Mayor Elliott recommended amending...up to \$10,000. Trustee Gilmore accepted amendment; re-seconded by Trustee Wooden. Voting "aye" were Trustees Gilmore, Wooden, Pope & Frontuto & Mayor Elliott. Carried.

F.D. Lawnmower:

Trustee Gilmore cited the F.D.'s need for a new lawn mower, following which he moved that perm. ref. be published and posted for amt. of \$5,000. (from the HR-5 Code) to purchase sd. lawnmower; Trustee Wooden seconded. Voting "aye" were Trustees Gilmore, Wooden, Pope & Frontuto & Mayor Elliott. Carried.

Town/Items 3 & 4:

Mayor Elliott moved that the VOP request exemption frm. Town Highway Items 3 & 4 in the Town of Palmyra's 1990 budget cycle; Trustee Pope seconded. Voting "aye" were Mayor Elliott & Trustees Pope, Wooden & Frontuto. Trustee Gilmore voted "nay" - his reason being that he felt both municipalities have a good rapport & spirit of cooperation.

Am.Legion (Cuy. St.):

Regarding the verbal request frm. the American Legion to close off Cuyler St. Sat. eve. during Canaltown Days, the VB did not arrive @ a decision. Mayor Elliott moved that the issue be tabled; Trustee Wooden seconded. Voting "aye" were Mayor Elliott & Trustees Wooden, Frontuto & Pope. Trustee Gilmore voted "nay". Carried by majority.

UFPO:

Communication rec'd from the Underground Facilities Protective Organization re the VOP joining sd. organization (a firm which contractors may call prior to commencing any excavating) @ an annual cost of \$100. VB discussion, following which Trustee Pope moved the VOP's participation. Trustee Frontuto seconded. Voting "aye" were Trustees Pope, Frontuto & Wooden & Mayor Elliott (Trustee Gilmore was out of the room during VB vote). Carried.

Clerks' Conf.:

Mayor Elliott moved authorization for two (2) persons frm. the Central Office to attend the Annual Clerk's Conference frm. 9/25-29/89 to be held @ the Nevele Hotel. Trustee Wooden seconded. Voting "aye" were Mayor Elliott & Trustees Wooden, Gilmore, Frontuto & Pope. Carried.

Hwy./C&P School:

Mayor Elliott moved that Hwy. Supt. Retan & C&P Supt. Weaver be authorized to attend the Public Wks./Park Maintenance School @ Poughkeepsie frm.

On Monday, August 28, 1989, the New York State Operation Lifesaver Committee in cooperation with Conrail will sponsor a special train carrying the "Operation Lifesaver" grade crossing safety message. The special train will be traveling from Lancaster to the New York State Fairground in Syracuse. The purpose of this special train is to publicize the Operation Lifesaver Program and to promote rail-highway safety awareness along the entire route.
