

Trustee Frontuto spke. of new lighting in Pittsford and attractiveness of sme. - they contract wth. RG&E.

Bingo Approv.: St. Anne's Church having filed application to conduct Sun. p.m. Bingo games in a timely fashion for one-yr. period, and their paperwk. in order, Trustee Frontuto motioned that VB approve sme. Trustee Elliott seconded. Voting "aye" were Trustees Frontuto, Elliott, Vrubel & Gilmore. Carried. Clk. to proceed wth. State requirements.

Abstract #13: Trustee Frontuto motioned that Mayor be authorized to sign Abstract #13 and that all Vouchers containing initials of three Trustees by end of meeting be approved for payment. Trustee Elliott seconded, adding that motion contain "Deputy Mayor's" authorization in absence of Mayor. Trustee Frontuto accepted change in motion; voting "aye" were Trustees Frontuto, Gillmore, Vrubel & Elliott. Carried.

Engineer Arthur MacNeill, having provided/mailed his in-depth report dated 11/13/87 regarding the Waste-water Treatment Plant, approached the Bd. for a re-SewerPlnt. -MacNeill: view of sd. rpt. He sd. his investigation concerned reasons why the Plant was in violation. Mr. MacNeill explained each individual graph/chart (seven pages of text & eight supporting graphs); Figure 1 is a comparison of the effluent suspended solids to the influent biochemical oxygen demand in five days (the five day process an accepted practice established in England); <u>Figures 2 & 3</u> are comparisons of effluent BOD 5 to influent BOD 5; <u>Figure 4</u> is a comparison of influent BOD 5 in lbs./day to 30-day average flow in million gallons per day; <u>Figure 5</u> compares effluent BOD 5 in lbs./day to average daily in million gallons per day; Figure 6 compares average daily flow in million gallons per day to percent BOD 5 reduction through the treatment plant; Figure 7 is a comparison of sludge wasted as gallons per month to percent BOD5 reduction through the plant (indicates that sludge be wasted to the drying bed on a regular schedule to maintain optimum quality of the supernatant being re-turned to the headworks). Mr. MacNeill submitted the following comments regarding data provided by W&WW Supt., H. Kruger:

> <u>Potable Water</u> - metals are all low & well within potable water guidelines; <u>Sludge Sample</u> - concentrations of metals in sludge are somewhat proportional to the concentrations in raw water. <u>Metal Concentration</u> - increases in chromium, lead & mercury which can be related to lead pipe & solders in hsehold. system, etc. Copper & zinc remain proportional & probably represent metals entrained in sludge and accumulating over yrs. due to poor wasting procedures. Mr. MacNeill continued rendered his opinion/calculations on sludge drying capacity.

Digestor Temperatures - from 10/6-10/28/87 temp. varied from 31 C to 33.5C. - 35 C is the optimum. Returning digested sludge frm. secondary digestor (holding tank) to primary digestor reduces the temperature - secondary tank unheated. <u>Volatile Acids</u> and Alkalinity - trend must be reversed or pH will

drop/methane-producing bacteria will not prevail. Elevating temp. will help - if this fails, alkalinity added to reverse trend. Sodium carbonate or lime may be added to primary sludge to increase alkalinity.

Several permit violations @ WW Trmnt. Plant over yrs. most common being mtg. requiremnt. for 85% reduction of organics on BOD 5 through Plant. Secondly, excess BOD 5 in effluent - did not occur simultaneously - appear not to be related. Mr. MacNeill went on to say that basic operational problems exist re solids' handling, i.e. low digestor temps., over-pumping of sludge to secondary dig., poor gas product. & high cst. of sludge disposal low digestor temp. reduces efficiency inhibiting activity of Methaneproducing bacteria. Mr. MacNeill elaborated upon poor gas reduction, sludge disposal & use of drying beds - VOP may apply for permit to transport sludge to landfill via VOP-owned truck (wld. have to be dedicated truck/cld. not be used for any other VOP business) or may be commercially hauled - also, truck wld. have to travel same route. Mr.MacN's recomm. included his opinion that the W&WW personnel appear capable of operating sd. plant wth. exception, per-haps of sludge handling/disposal, digestion & dewatering. He cited six problem areas which must be remedied & suggestions to alleviate same along wth. obtaining publications to assist the W&WW Operators in their performance(s) - (Clk. to order frm. pub-lishers provided by Mr. MacNeill). Trustee Elliott asked about running heat exchanger 24 hrs. & automating heat exchanger, for which Engineer D. Means working on proposal freeze drying sludge discussed/20% wet sludge acceptable....Sodus, Seneca Falls & Spring Meadow mentioned as depositories... it was stated that it takes 33 days to digest sludge & if heated, produces more gas - not hooked up/originally designed for this if done properly, cld. heat nine mos. out of yr heat digester off its own gas. Trustee Gilmore reiterated....two-thirds reduction in what gas bill wld. be ... Mr. MacNeill sd. 40% possible. ..also cld. save wth. pressur-ized storage tank ...floating roof mentioned. H. Kruger sd. Newark has sme. & spke. of trip to Conesus wth. Trustee Elliott. Trustee Vrubel asked about solar power to which Mr. MacNeill sd. process used down south - VOP needs during Jan., Feb., & Mar. He sd. primary digester has no insulation in roof resulting in heat loss. Disc. discontinued and Mr. MacNeill thanked by Bd. for attending mtg. and presenting his in-depth rpt.
