REGULAR MEETING

CALL TO ORDER: Mayor Husk called the regular meeting to order at 6:30 pm.

APPROVAL OF MINUTES: Motion was made by Trustee Leo, seconded by Trustee Perry to approve the minutes from November 6, 2023. Vote, 3 ayes. CARRIED.

EDU REFUND FOR ANDREW BULLARD Motion to refund one EDU for the last three years, for a total of \$975, was made by Trustee Perry, seconded by Trustee Leo. Vote, 3 ayes. CARRIED The assessor's office has had it listed as a single family since 2020 but the number of EDUs was never changed from two to one. This made the EDU count incorrect on his tax bill.

Trustee Perry – Highway Department will be doing a last round of picking up leaves in the next week. Trucks are ready to go for snow removal. Building and Grounds are also working on leaf pickup as well as pouring six foundations before snow starts.

POLICE DEPARTMENT - KYLE DINARDO Police have had 286 calls for services since November 1 including 32 vehicle and traffic stops. There was a bomb threat at the school which resulted in a D felony for a juvenile. Toys for Tots is starting to accept requests so contact the Police Department if needed. Due to resident complaints, traffic enforcement will be increased on Canandaigua Street. The Department of Transportation will be doings weights and measures to check overweight trucks on Canandaigua Street as well.

The system for evidence is up and running. Bikes that were surplused were picked up and given to an organization in Rochester to give out before Christmas. He has submitted a grant through Wayne County for a joint police/fire academy in the summer. Property Checks requests have increased. Reminder that the Police Department does them.
