Mayor Davin commented that the money will come back to the Village if the village goes after the unexpended funds of Urban Renewal by proper application.

Mayor Davin introduced Paul Szymanski, commenting that he will fill out the proper forms of the Village of Palmyra.

Paul Szymanski: Mr. Szymanski commented that the Village of Palmyra is eligible to receive some \$66,000. from the Community Block Grant, of unspent federal dollars from the Urban Renewal Agency. The other is a part of the Community Development Program. The village must hold two (2) public hearings and must make application. Qualif. Activ.:

Mr. Szymanski advised that certain types of activities qualify for funds such as the purchase of property, funds could be used for historic significance, public facilities for a senior citizen center, parking, code enforcement, clearance of unsafe buildings, provision for public services, such as drugs, recreation facilities, public works and street work.

Melvin Bushart: Quaker Rd. resident, and President of the Palmyra Community Center, advocated that the funds be used for a Community Center Bldg. The building, he advised, can be built on land to be leased from the Palmyra Agricultural Society. A future park in this area could be envisioned. Senior citizens would have access to the building for their programs, an ice rink adjacent could be built. Bldg. itself would encompass some 10,000 sq.ft. Storage area together with rest rooms, snack area and recreation would be available. Total cost is estimated at \$150,000.

Gene Spanganberg: Bear Hill Drive resident, advised that he was a Fire Dept. Commissioner, and urged that the funds be used for a fire house, if this is the feeling of the group. However, he continued, as much as he would like to see a new firehouse, perhaps the funds could be used for better advantage for a Community Center, thereby freeing up space in the Village Hall.

H. Van Etten: Spring Street resident, Operator of the Water & Sewer Treatment Plant for the Village of Palmyra, commented that his selection for use of the funds to prevent further flooding in the area of Spring Street. He advised that this is probably the most neglected street in the village as it is short at the base of Prospect Hill. Water Treatment Plant is located here. When spring thaw or heavy rains descend, street is flooded. As a result, water ultimately dumps into Spring Brook, flowing north and overruns its banks in the vicinity of Fayette and Prospect Drive. He commented, that to his knowledge, no residents have complained about this flooding on Spring Street. Another area that needs attention is between Hyde Park and Stafford Street, north of West Jackson. New storm sewers for both of these areas would eliminate much of the spring or heavy rain flooding.

Prospect Hill -- could be made into a nice park, with better roads, a planned program for clean up of debris, installation of tables, benches and grill facilities, along with sanitary facilities.

Lastly, Spring Street should have a good resurfacing job.

Peggy Barcomb: Resident of 221 Stafford, commented that she is a member of the Palmyra Fire Department. She advised that when she was younger, she taught herself to ski, ice skate, and was able to find things to entertain herself, and while she feels there is a need for a Community Center, there is a greater need for a place to house the fire department equipment. The Fire Department, she countered, is a <u>public service</u>. The Fire Department needs help, too. She advised that she is concerned about the community. Eventually the Village Hall will give out and the trucks do need housing.
