## BOARD OF TRUSTEES 12/5/88

7:00 p.m.

Regular Meeting

Present:

James G. Elliott, Mayor; Trustees P. K.Frontuto, D. Wooden; & Atty. J. Nesbitt. Trustees C.D. Gilmore & D. Pope III arrived shortly after the meeting began.

Moment of Silence:

Public Hrng./LL Mayor Elliott requested a moment of silence prior to conducting the business of the Bd.

Mayor Elliott opened the public hearing for discussion - the Clerk read the Legal Notice. When no comments were received the Mayor moved that the hearing be closed; Trustee Frontuto seconded. Voting "aye" were Mayor Elliott & Trustees Frontuto & Wooden.

Trustee Frontuto then moved that action on the hearing be tabled until a full Bd. present and presented in proper legal form. Trustee Wooden seconded. Voting "aye" were Trustees Frontuto & Wooden & Mayor Elliott. Carried.

<u>Minutes</u> 11/21/88:

Trustee Frontuto moved that the 11/21/88 Bd. Mtg. Minutes be accepted as written, however, the matter was placed on "hold" until the arrival of remainder of Bd. as the Mayor stated that he had been absent for much of sd. mtg. and felt ineligible to vote upon same.

<u>Trustee</u> Frontuto:

Trustee Frontuto deferred to C&P Supt. R. Weaver who give a brief report on his areas. Mrs. Frontuto sd. of Christmas decorations that she was waiting to hear frm. Chamber. Citizens upset, per Mayor Elliott, because decorations aren't up. Rumored that Fire Dept. to place same - choice of banners limited per Trustee Frontuto, however, approx. ten to be purchased/hung.

Discussion held on repair of Hwy. chipper - shipping to Ohio for repair - estimated cost, \$2500.

Trustee Frontuto reported on Bicentennial mtg. and progress being mde. - specific organizations' plans for the yr.-long celebration related.

Brief discussion on "trees"; also on chipper - VOP shld. have documentation on employees' knowledge of operation of chipper. Hwy. Supt. Retan related costs involved if damage to fiber-optics going across raw water line - exorbitant, he sd. Mr. Retan said street signs being placed, burden on P.D. to enforce 2-hr. parking. The persistent problem of the motor home on Hansen disc. by Bd.

Trustee Gilmore:

Trustee Gilmore spke. of Federal Drivers' License Law to become effective which will increase cost of truck drivers' licenses above the \$35. currently charged - Mr. Gilmore so moved Bd. approval; Trustee Frontuto seconded. Discussion. Amt. of increase an unknown factor @ this time. Mayor Elliott sd. matter cld. be a negotiable benefit re contract/VOP picking up cost. Trustee Gilmore disagreed. Contract negotiations to begin in 1/89 per Mayor. Cld. be 1991 before Law takes effect. Standards are not out yet according to the Mayor calling for a Bd. vote. Voting "aye" was Trustee Gilmore; voting "nay" were Mayor Elliott & Trustees Wooden, Pope & Frontuto. Motion defeated.

Nesbitt ample time to review prior to 1/16/89, he sd.; Trustee Pope seconded. Voting "aye" were Trustees Gilmore, Pope, Wooden & Frontuto & Mayor Elliott. Carried.

Est.Vill. Hall Gtrs.:

Trustee Gilmore spke. of est. rec'd frm. Adams for gutters wth. three downspouts in amt. of \$800. Bd. disc. on VOP receiving other estimates. Doubtful for current budget cycle. Disc., also, on few shingles high winds blew off roof.

Appointment wth. HUD rep., Mr. Leonard Skrill -10:00 a.m. Wed., 12/7/88, according to Trustee Wooden, regarding available grants and assistance wth. completion of same. Mayor sd. that rep. frm. Landmark Society felt a prior application on file somewhere...talk of enlarging VOP's "Historic District."

Assessmnt.

Disability

Place Vill. Hall handicapped ramp in nxt. budget, per Mayor. Review to be mde. of prior specs; need emphasized to comply wth. State law.

<u>Changes:</u> The Mayor spke. of assessment changes which will impact on nxt. budget; all the building - new construction in VOP - will be negated.

Organiz.: The Bd. did not indicate a desire for VOP membership in the National Organization on Disability.

Cable T.V.: Communication, dated 11/30/88, frm. Cable T.V. re rate increase over which municipalities have no control. Also, second Cable letter rec'd - only way to regulate is if in area where municipalities can receive only three channels. In talking with Lyons' Mayor, Legislator Louise Slaughter on committee re "de-regulating" Cable (at which time Mayor Elliott spke. of having called Mrs. Slaughter's office to engage her as speaker for WCVOA dnr.-mtg. 1/18/89 when VOP hosts sme.) If Louise cannot speak, VOP to ask WC Sheriff Pisciotti.

CSEA Con-Tract:

Mayor Elliott asked the Trustees to begin putting their thoughts together for CSEA Labor Contract which expires 5/31/89 - suggested, also, talking to respective department hds. re their concerns. VOP Policy Manual goes hand-in-hand wth. Contract.

Model Flood Ordinance again placed on hold as was VOP obtaining employee I.D. Cards; Simplex Alarm

Misc.:

Retirement Eligible Lst.: System for Vill. Hall tabled as money does not exist in budget for same (\$750.) - in addition, need electrician's estimate/looking @ approx. \$1500. build into nxt. yr.'s budget. Trustee Gilmore suggested obtaining est. frm. Mr. M. Smith; Bd. discussion on Market St. property owned by VOP and possible sale/lease of sme. Bd. did not reach a decision re leasing for \$1.00 per yr. - VOP to maintain in meantime (clean up and plow in winter). Mayor sd. sm. area wth. right-of-way on it. Rightof-way approx. 13' per Mr. Wooden. Mayor felt in best interest of VOP to be retained as public parking lot. Trustee Gilmore pointed out that room needed for fire trucks to enter/exit. Parking wld. be reserved, per Trustee Wooden for business parking. His wish wld. be to make VOP parking area there as in other areas of Vill. VOP must be careful to avoid criticism per Mayor. Clk. requested to retain on Bd. Agenda. Bd. rec'd communication re Telepone Co. assessments. No comment/action by Bd.

Mayor spke. of "Eligible List" re Retirement..... he felt only option VOP shld. utilize was first on list...wld. cost VOP \$4,894. to reopen Sect. 384 of Retirement Law. Union Contract specifies sme. - VOP has three officers who are not included...VOP cld. reopen/must be in place in proper form by 12/31/88. Different opinions frm. Albany. The Mayor further explained then read and so moved that the Bd. adopt the State resolution as previously explained; Trustee Frontuto seconded. Trustee Gilmore spke. of complexity of the resolution. Mayor sd. resolution had to be filed wth. State; Chief Dalton sd. benefits wld. come @ retirement not an immediate one. Per Mayor Elliott, VOP currently in violation of Union Contract...shld. have been receiving right along - Patrolmen Coleman, Murdock & Gumaer presently under 375-C - automatic if not filled in

Minutes 11/21/88: Trustee Gilmore, not having had opportunity to review 11/21/88 Bd. Mtg. Minutes, moved that sme. be tabled until 12/19/88 Mtg. Trustee Wooden seconded. Voting "aye" were Trustees Gilmore, Wooden & Pope. Voting "nay" were Mayor Elliott & Trustee Frontuto. Carried by majority.

Exec.Sess.: At 8:50 p.m. Mayor Elliott moved that the Bd. exercise Exec. Sess. for matters of personnel with Bd. in attendance; Chief D. Dalton & J. Nesbitt, Esq., Village Attorney. Trustee Frontuto seconded for discussion purposes.

Citizen Frontuto: Mrs. Frontuto sd. that newspaper prior week stated that possibility existed that VOP might be naming a person in the Palmyra P.D. to the position of Sergeant...one person in audience wld. like to make statement. Mayor Elliott withdrew motion. Mr. J. Frontuto stated that Police Officer P. Coleman seemed to be in line for sd. appointment and stated that he was not satisfied wth. the results of a P.D. investigation and wanted his wishes known to Bd., however, not prepared to make a statement. Mayor Elliott then moved Exec. Sess. again; Trustee Frontuto seconded. Voting "aye" were Mayor Elliott & Trustees Frontuto, Wooden, Pope & Gilmore. Carried.

Re-Convene: At 9:55 p.m. Mayor Elliott moved that the Bd. emerge frm. Exec. Sess. wth. above persons present; Trustee Pope seconded. Voting "aye" were Mayor Elliott & Trustees Pope, Gilmore, Wooden & Frontuto. Carried. Trustee Gilmore asked for reiteration of persons present for Exec. Sess. and Mayor repeated sme.

Officer Coleman Named Sergeant:

Mayor Elliott moved that the VOP appoint Patrolman Patrick L. Coleman, provisionally, to the position of Police Dept. Sergeant subject to passing the Civil Service Sergeant's examination @ a salary of **\$21,177**. Trustee Pope seconded. Trustee Wooden asked for separate motions, i.e. appointment/salary. Voting "aye" on the provisional appointment were Mayor Elliott & Trustees Gilmore, Pope & Wooden; voting "nay" was Trustee Frontuto. Carried by majority. The Mayor then moved that Mr. Coleman's salary be increased frm. **\$20,427. to \$21,177**. Trustee Pope seconded. Voting "aye" were Mayor Elliott & Trustees Pope, Gilmore & Wooden. Voting "nay" was Trustee Frontuto. Carried by majority.
