The following letter was read by the Clerk Treasurer, Theresa P. Otte,

Dear Mayor Wilson and Board of Trustees:

I am addressing you at this time to let you know that the last twenty-five and one half years, as I look back, seem to be but a mere twenty-four hours or less. This was probably due to the fact that I was happy in what I was doing. During that quarter of a century, the Village of Palmyra has steadily grown, somewhat in size geographically, and by head count, but basically, the Village has remained a friendly, attractive community of which we can all be proud.

Few people have had the privilege, as has been accorded to me, to be a part of the hub and spokes which have held this Village aloof in the ensuing years.

The first big change was the adoption of State Village Law in 1958, as was recommended by the State of New York. We did not, however, scuttle the Charter which had been drafted so efficiently by Pliny T. Sexton, a philanthropist, inasmuch as most of the principles envisioned and recorded by him revealed foresight which apply to even many conditions today.

With the advent of the sixties, the Village was disheveled with the installation of the sanitary sewer system. With the quieting of the bowels of the Village, the water line, which was installed in the middle thirties, now came into focus. It was deemed necessary to install a pumping station adjacent to Canandaigua Lake to insure constant flow of the lake water, which flowed by natural gravity to the Village of Palmyra Filter Plant, where it was purified and stored in a million gallon tank.

The Village of Palmyra Volunteer Fire Department in the late sixties, prided itself with one of the areas first snorkels.

Beginning in the seventies, the Village of Palmyra elected a mayor, the youngest person to ever hold office in the Village of Palmyra. Moreover, the Village of Palmyra elected a woman to hold a seat on the Village Board, and later voted a woman to be mayor. Such was a first in this area. The two party system, brought vibrant and enthusiastic persons to shackle the reins of government.

The undercurrent erupted for annexation to the Village, thereby automatically entailing the extension of the Village of Palmyra's two precious commodities - - - Water & Sewerage.

During the interim, the Urban Renewal Agency had come into being, which prompted the formation of Historic Palmyra. To appease one and not ruffle the feathers of the other, was like walking a tight rope without a net.

Safely on the other end of the rope, the platform was not adequate for standing or parking. With outside help, the land was turned into a beautification parking area, followed by attractive housing for Senior Citizens.

Now, the one and only piece of land unoccupied, owned by the Village, and, about which there had been much bickering between the Village Boards and the Village Clerk, proved to be the most desirable place for the erection of a firehouse. It took great finesse, time consuming hours, but the finished product proved to be the long awaited "brain-child" of many dedicated persons.

Silence Mayor Wilson opened the meeting with a period of silence.

Minutes Trustee McGrath advised that it was Trustee DePoint who proposed  
the resolution to the retention of Village Attorney, Laura Jane  
Poyzer, to represent the Village of Palmyra in connection with  
the grievance of the New York Telephone.

On motion by Trustee DePoint, 2nd by Trustee Abbott and carried  
the minutes of the previous meeting, May 5, 1980 were approved  
with the correction of the name of Trustee DePoint, who proposed  
the resolution to retain Village Attorney Laura Jane Poyzer  
with any expense incurred to be paid directly to her and is not  
to be construed as a part of her stipulated village salary.

Vouchers On motion by Trustee Green, 2nd by Trustee Abbott and carried,  
vouchers were approved for payment in the amount of \$65,896.88  
excluding vouchers to Harris, Beach, Wilcox in the amount of  
\$355.27.

Vil. Trustee McGrath informed the board that Robert Sherman has  
Hall prepared preliminary plans for the layout of the Village Hall.  
Plans: Mayor Wilson advised the board to go over the layout with Trustee  
McGrath, at leisure, rather than reviewing them tonight. Trustee  
McGrath commented that according to the plans for the Police  
Department to be housed in the former rear fire barn, the holding  
cells do not appear to have any toilet facilities. Trustee  
McGrath added that if it is necessary to move walls, it is

Plans: conceivable that new electrical wiring would be needed.

Barn: Trustee McGrath advised that the present village barn on the corner of Division, Canal and Market Streets, is in need of a new roof. Trustee DePoint indicated that he was under the impression that the Town of Palmyra had indicated recently that there would be room for some of the Village crew and equipment. Trustee DePoint indicated that it would be worthy of asking the Town of Palmyra if such is the case. Trustee McGrath added that she noted that there is an old piece of equipment being stored in the barns that appears to be "just in the way."

Comm.  
Ctr.: Trustee McGrath volunteered that the Community Center is in need of funds to move ahead. Trustee DePoint advised that he knows that Mobil Chemical has pledged some \$30,000. but will not be forthcoming until later. The Village Board has appropriated some \$5,000.00 in the new budget from Revenue Sharing. Trustee McGrath indicated that she felt the Town of Palmyra should help the Community Center.

Comm.to review: On motion by Trustee DePoint, 2nd by Trustee Abbott and carried,  
 the bids submitted were turned over to the Highway Committee  
 for review.  
 The representative from Walter M. Roberts commented on their  
 machine.

Celebra- Trustee McGrath advised that she hopes everything is in readiness  
 tion in for the celebration in the Village Park on Saturday, May 24, 1980  
 Park: from 6:00 P.M. to 9:00 P.M.

Vil. Trustee McGrath commented that the Village Barn on the corner of  
 Barn: Division, Canal and Market Streets, is in sad shape. The roof  
 leaks and the back area is in a state of decay. Trustee  
 McGrath advised that she felt that the Village Board should talk  
 to the Town Board relative to placing some of the equipment, at  
 least, in the Town Barns.

Police Trustee Abbott advised that a new patrolman, Thomas Putnam, will  
 Dept. start work on May 26th, 1980.  
 Siren Trustee Abbott informed the board that he has contacted a firm  
 Needed: for a price on a siren, which is needed for use on the 2nd car.  
 This would be a smaller size.

P.D. Trustee Abbott informed the board that they have cleaned the  
 Office: Police Department Office, and painted the files. The attitude  
 of the department personnel appears to have been raised.

Seized & Stolen Articles: Trustee Abbott advised that there are 27 bicycles in the cellar which have not been claimed and may be sold at an auction. In the possession of the police department is some marijuana which has been there since 1974 in storage.

Work Wk.: Trustee Abbott advised that he has a breakdown of every man's work week.

Patroling 5/24/80: Trustee Abbott was informed that the people who purchase beer must stay within the confines of the Village Park. Mayor Wilson asked if Auxiliary would be available for assistance with the crowd that may attend on Saturday evening the fun nite in the park. Trustee Abbott advised that he would discuss the matter further with the police department.

Dog Control: Mayor Wilson asked Trustee Abbott if he had any information relative to the dog control. Trustee Abbott advised that he had tried a number of times to contact Councilman Wheeler to discuss the matter with him as far as the town may be concerned, but unfortunately, he has not been able to find him at home.

Historic Survey: Mark Vande, Harnish & Lookup, Newark, conferred with the board to learn that there were approximately 400 homes in the village that were surveyed. The first phase of the work was a complete survey of the village to determine the possible homes that might qualify for being placed in the historic register. The second phase, he recounted was getting further information which was submitted to the Historic Preservation Office, who would review the material submitted. A special committee of the state would then determine if the property was eligible for being submitted to the federal level for reviews and documentation.

Target Date: November 30, 1979 was the final date for submission. The grant for the Village was \$4,900.00. The Village has to match this with money or donated services. The village was only able to provide \$1,500.00 in cash. The volunteer labor then had to make up the difference.

Final Date: Mr. Vande advised that the state will pay until September 1, 1980. Therefore, it is expedient that all bills be submitted by that date. The grant has been set aside for the Village of Palmyra, so, therefore, the Village should receive it. Trustee McGrath questioned if there were certain streets designated. Mr. Vande informed the board that the only street at the present time in the Historic Register is Market Street. The new survey takes in other streets. Mr. Vande added that the "windshield" survey color coded the houses. There are some that will be considered to be on the borderline for inclusion in the Historic Survey.

L. Warner Praised: Mr. Vande commented that Miss Lorene Warner, West Jackson Street, has done most of the historic work and research.

Vil. Park. Policy Quest: Mrs. Betty McEwen, 235 Birdsall Parkway, inquired of the Village Board, the policy of the village in relation to parking of cars on lawns. She advised that she lives next to the brook and on either side, there are unregistered vehicles. She added that when she attempts to exit from her drive, her view is obstructed because the cars block her view. Many cars park onto the lawn area. What is the width of the street and where does her property line begin.

Width of Streets: Trustee Green commented that the majority of the streets have a different width. The general measurements taken commence at the center of the blacktop street or road and extend east, west, north, south in relation to the lot. Clerk Otte indicated that the majority of streets are 40 or 50 feet wide.

Creek - Mrs. McEwen questioned who is responsible for the cleaning out  
Who Owns? of the brook that is adjacent to her property. She recounted  
that last summer when the creek dried up, there were lots of  
dead fish, that she eventually cleaned up because of the odor.  
Trustee Green volunteered that the creek belongs to each  
property owner who borders the brook.

Opinion: Clerk Otte read an excerpt from the minutes of the Board of  
Property Trustees recorded June 23, 1969, at which time the then Village  
Owner Attorney, Henry B. Nesbitt, Esq., commented: "The creek belongs  
Owns to the land owners and not the village. It has been a myth  
Creek that the village owns and is responsible for the creek.  
Bed & Moreover, he commented that should the land owner so desire,  
NOT he could block off the creek at either end of his property.  
Village: line, but by so doing he could cause more of a problem. Many  
deeds indicate that the lot line is the center of the creek  
bed or brook and for this reason the village has no right to  
trespass on private property to clean out."

Mun.Aff. Clerk Otte further read an opinion from the Municipal Affairs  
Review Review, February, 1978 as follows: "New York case law has  
Cited: clearly and repeatedly held that a municipality is under no  
obligation to dredge or clear obstructions from natural streams  
to prevent their overflowing onto privately owned property,  
unless, of course, the municipality has caused the over-flowing  
producing obstruction or condition."

Prospect Trustee Green commented that he has asked Harnish & Lookup to  
Drive: prepare levels, including the water line pattern for the  
possibility of lowering the grade of Prospect Drive in order to  
prepare the street for a better traffic flow as well as  
reducing the number of traffic fatalities and accidents on this  
particular section of Prospect Drive which veers to either  
the right or left so quickly, depending on which direction a  
vehicle might be moving. Trustee Green added that it is quite  
possible that the street will need to be lowered which will  
undoubtedly entail a cost of approximately \$60,000.

Vienna Trustee Green informed the board that the water line on Vienna  
St.: Street is not one of the ones that should be replaced as  
indicated by a survey done by Woodward Associates in 1968.

Specs. Trustee Green revealed that he would have the specs for Vienna  
Paving: Street, Johnson Street, and Tremont Street for repaving for the  
next board meeting.  
Trustee Green summed up that the engineering work for Prospect  
Drive could cost considerable.

Register Trustee Green reflected that several years ago he had suggested  
Bikes: the possibility of having a "Bicycle Registration" in the  
village, so that if a bicycle is lost or stolen and possibly  
found by the police department or turned in to the police  
department, it would be easier to inform the owner. If the bikes  
were registered, at least, the person would have a better chance  
of recovering.  
Trustee Abbott advised that he would work on the above suggestion  
and report back later.

Conifer Village Attorney, Laura Jane Poyzer, advised that she had

Willow Village Attorney Poyzer informed the board that Richard Watson, Street Garlock Inc. has requested that a survey be done in relation (Path- to the narrow strip of property that is owned by Garlock, Inc. way): but, which they, Garlock, Inc. would like to deed over to the Village of Palmyra, in the vicinity of Willow Street, so-called, but which has never been dedicated to the Village of Palmyra. Attorney Poyzer indicated that a cost of such a survey by Harnish & Lookup would cost approximately \$200.00. The area to be conveyed to the Village of Palmyra would measure some 40 feet on the west side of the gravel drive. The Village Board agreed that Village Attorney Poyzer should instruct Harnish & Lookup, Newark, New York, to make the survey and at the time of making the survey, place markers to indicate the proper width of forty (40) feet.

Trial Village Attorney Poyzer commented that she had had a request Request: from the Village Justice that he (the Village Justice) had had a request for a trial. Board agreed the matter would be discussed in executive session.

Beaut. Village Attorney Poyzer informed the board that the Bill in Bill: relation to extending the time of payment for the Beautification Statutory Installment Bond, has been approved in the Senate, but is still in the Ways & Means Committee of the Assembly.

Prop.Ord. Mayor Wilson commented that in order for the passage of a Local re: No Law relative to No Parking on Various Streets During Special Pkng.Var. Events, be adopted by the first of August, 1980, the Village Sts.Spec. Board should set a public hearing date.

Events: Village Attorney Poyzer commented that it will be possible to name various streets and exclude Route #31 and Route #21, those being Main Street West and Main Street East, as well as Canandaigua Street. Attorney Poyzer added that Sgt. Morgenthaler of Canandaigua is to come to the Village to review the streets involved, those being Rt. #31 and Rt. #21.

In addition to, and notwithstanding any other provisions of this Chapter permitting or prohibiting parking, the stopping, standing or parking of vehicles upon any street or portion thereof, or public area, (excepting state highways) within the Village of Palmyra, may be prohibited by resolution of the Board of Trustees of the Village of Palmyra, for such period of time as is required, in the opinion of the Board of Trustees, to provide for the safe passage of vehicles, pedestrians and/or emergency vehicles.

Local Law No. 2 of the year 19 80

A local law to amend Chapter 25, Vehicle and Traffic, of the Code of the Village of Palmyra, to authorize the Board of Trustees to prohibit the stopping, ~~standing~~ standing, or parking of vehicles at designated times, by resolution.

Be it enacted by the Board of Trustees of the

as follows:

Section 1. Article II, Parking, of Chapter 25, Vehicle and Traffic, of the Code of the Village of Palmyra, is hereby amended by the addition of Section 25-26.1 to read as follows:

§25-26.1 Prohibition of parking by Village Board during special events.

A. In addition to, and notwithstanding any other provisions of this Chapter permitting or prohibiting parking, the stopping, standing or parking of vehicles upon any street or portion thereof, or public area, (excepting state highways) within the Village of Palmyra, may be prohibited by resolution of the Board of Trustees of the Village of Palmyra, for such period of time as is required, in the opinion of the Board of Trustees, to provide for the safe passage of vehicles, pedestrians and/or emergency vehicles.

B. A resolution adopted by the Board of Trustees pursuant to this section shall designate the area, street or portion thereof within which the stopping, standing or parking of vehicles is prohibited, and the period of time of such prohibition.

C. If a resolution is adopted by the Board of Trustees pursuant to this section, the Board of Trustees shall direct the posting of temporary signs or markings in the area affected in accordance with the applicable provision of the Vehicle and Traffic Law of the State of New York, and such resolution shall not take effect until signs or markings giving notice thereof are posted.

D. Whenever a vehicle is parked on any street or public area within the Village of Palmyra during such time as parking thereon is prohibited pursuant to this

## Regular Board Meeting

## Board of Trustees

7:00 p.m.

Present: Mayor Mary Lou Wilson, Trustees: Mary Kay McGrath, George Abbott and James DePoint. Absent: Trustee Lloyd Green.

Approval of 6/2/80 Minutes: Trustee DePoint made a motion to accept the June 2, 1980 Board Minutes, seconded by Trustee Abbott. All voted aye, motion carried.

Committee Reports: Trustee Abbott spoke of a request from the Fire Department to utilize the Fairgrounds for a mutual aid exercise on Saturday, June 21, 1980. Mayor Wilson felt that the request should be made to the officials of the Fair Association and not a matter for the Board to handle.

Use of Fire Hall for Elec.: Mayor Wilson spoke of having received a request from the Town Board for the use of the Fire Hall on East Main Street as a polling place for General and Primary Elections for District #6. The Town would reimburse the Village \$25.00 for the use of the building. Motion by Trustee DePoint, seconded by Trustee McGrath to allow the Town to use this space for future elections. All voted aye, carried.

Underground Storage Tanks: Trustee Abbott reported that a hazardous condition exists in local gas stations which are no longer in business. He felt that the underground tanks should be filled with water or completely emptied of the gasoline. The Fire Chief alerted Mr. Abbott of this dangerous situation and suggests that means be taken to rectify the problem.

Two-Hour Parking: The Board was advised by Trustee Abbott that "warning" tickets for the two-hour parking violations on Main Street are being prepared and should be ready to place on cars soon.

Rotating Police Shifts: Trustee Abbott spoke of plans to hold a meeting with the entire Police Department to discuss patrolmen working on a rotating shift so that the men can get to know the citizens in the Village. He feels that the Chief should also work on this rotating shift.

New Assess. Wat. Line: Water & Sewer Superintendent, Harold Kruger, appeared before the Board to inform them of the recent increases in assessments of the Village's water line from Canandaigua Lake to the Village boundaries. The City of Canandaigua has increased our taxes \$118.00 based on 944 feet of pipe. The Town of Hopewell increased the assessment to \$122,150.00 from the previous year. An increase from the Town of Gorham was \$31,900.00 on 2400' of pipeline. It is the opinion of Judson Roney, Village Assessor, that the proper way to value the water line is the market value less depreciation. It was the Board's feeling that necessary papers should be filed grieving this assessment. The Board asked Attorney Poyzer to prepare the complaints on these assessments and asked Mr. Kruger to attend the various towns on Grievance Day, June 17, 1980, and report back to the Board.

Towpath & Salzburg Assess. Compl.: Assessor Judson Roney reported that the Town of Palmyra has elected to retain the present assessments for Towpath Manor and Salzburg Village - and that the assessment on Towpath Manor #2 is \$472,000.

Conf. of Mayors: Mayor Wilson reported that Trustees Abbott and McGrath accompanied her to the Conference of Mayors at Grossinger's on June 9-12, 1980.

Water Billing Mach.: Trustee DePoint informed the Board that the old water billing machine presently in use is becoming quite costly to maintain and he suggested that the Board place bids for a new electronic accounting machine. Upon a motion by Trustee McGrath, seconded by Trustee Abbott, the clerk was instructed to advertise for bids on a new machine. Bids to be opened on July 7, 1980, at 7:30 p.m. All voted aye, motion carried.



- Water Contracts: Trustee DePoint reported to the Board on the various Water Contracts which are expiring; he will confer with Mr. Kruger, Water Superintendent, on proposed water rates for forthcoming negotiations.
- Unregistered Vehicles: Mr. Jack Ryan, Zoning Officer, appeared before the Board to report that unlicensed vehicles will be towed on Saturday, June 21, 1980, beginning at 9:00 a.m. This applies to unregistered vehicles on private and public property.
- Janitorial Service: Trustee McGrath feels that the present janitorial service is doing a poor job in cleaning the Village Hall - and Park & Club Building.
- Band Concert: Mayor Wilson requested authorization to give the High School Band a donation of \$200.00 and the Canaltown Chorale a donation of \$25.00 for their concerts in the Park on June 13, 1980. Trustee Abbott made the motion, seconded by Trustee McGrath. Trustee DePoint voted "nay". An "aye" vote by Mayor Wilson passed the motion.
- Prospect Dr.: It was the consensus of the Board that lowering the grade of Prospect Drive was too expensive and that other means of traffic control would have to be studied.
- Iranian Hostages: Mayor Wilson read a letter from Ms. Sally Lynch reminding citizens of the "Yellow Ribbon" Campaign for the return of the Iranian hostages.
- Compressor Bd.: Trustee Abbott made a motion, seconded by Trustee McGrath, that the Clerk place a Legal in the local newspaper for bids on a portable air compressor for use by the Highway and Water Departments. Bids will be opened on July 7, 1980, at 7:45 p.m. All voted "aye," motion carried.
- Public Hrg. re N.D.C.: Mayor Wilson reminded the Board of the Public Hearing to be held on June 24, 1980, at 7:30 p.m. re the establishment of a residential facility at 255 Cuyler Street by the New York State Office of Mental Retardation and Development Disabilities. She urged that each Board member attend this important hearing.
- Skorck Property: Mayor Wilson has had a request from a local realtor as to the Village's position in regard to the unpaid taxes on the Conrad Skorck property at 644 E. Main Street. The realtor has a possible buyer for this property and the outstanding taxes amount to nearly \$5,000.00 (Village taxes only). Some discussion was held as to whether or not some of the taxes could be excused. Attorney Poyzer felt that taxes on property cannot be excused.
- Auxiliary Police: Mr. Elmer Kniest made an inquiry to the Clerk that since no specific monies had been budgeted for the Auxiliary Police Department, would there be some funds available if the need arose. It was felt that funds could be made available through the contingency account through proper transfer procedures.
- Spec. Bd. Mtg. Minutes: Trustee DePoint made the motion, seconded by Trustee Abbott, to accept the Minutes of the Special Board Meeting held on June 16, 1980, at 8:00 a.m. relating to adopting a resolution to authorize the issuance of a Statutory Installment Bond with a maturity date of June 14, 1988, with Marine Midland Bank. All voted "aye", motion carried.
- Vouchers: Motion made by Trustee DePoint, seconded by Trustee Abbott to pay the Vouchers in the amount of \$27,007.69. All voted "aye, motion carried.
- Adjournment: Trustee DePoint made the motion at 10:15 p.m. to adjourn the meeting; Trustee Abbott seconded. All voted "aye," motion carried.
