Expenditure of reserve fnds subject to premissive referendum. Trustee Frontuto seconded. Voting "aye" were Trustees Elliott, Frontuto, Gilmore and Vrubel. Carried.

Trustee Elliott motioned that a contract be negotiated w/ Dennis Means, for his services to do design work and drawings of physical plant, writing of bid specs and other services that may be needed to complete sewer plant construction. Trustee Frontuto seconded. Voting "aye" were Trustees Elliott, Frontuto, Vrubel and Gilmore. Carried.

Mayor Strong motioned that mtg be adjourned at 9:50 pm. Trustee Vrubel seconded. Voting "aye" were Trustees Vrubel, Gilmore, Elliott and Frontuto. Carried.
