With these corrections, Trustee Frontuto moved acceptance of 1/3/89 Minutes; Trustee Wooden seconded. Voting "aye" were Trustees Frontuto, Wooden & Gilmore & Mayor Elliott. Carried.

Cld. better use two-channel portable type radio through which one cld. receive and talk back...will place in his budget for review. Mayor Elliott commented that the "Beepers" were not as effective as had been hoped. The Bd. & dept. hds. present discussed alternatives; Trustee Frontuto will ck. wth. C&P Supt. his feelings re "Beeper." Consensus, however, was to return "Beepers" to company.

Trustee Wooden:

Trustee Wooden distributed copies of proposeed changes in Zoning and hearing date discussed wth. 2/21/89 as tentative date. Note: Atty. Nesbitt to review 'regular' Zng. Law in addition to Local Law. Trustee Wooden sd. that he had talked to the CofC; suggestion mde. that Trustees Wooden & Frontuto work together on the project....Mayor agreed that Trustees Frontuto & Wooden cld. work on together. Trustee Wooden had ideas, he sd., wherein it might not cost VOP any money (knew an electrician who wld. do work gratis, however, VOP wld. supply wires). Mayor sd. NYSEG's permission needed for work on poles. Trustee Wooden sd. he wld. like to talk to NYSEG re painting the utility poles. Borrowing Newark's "bucket truck" for hanging decorations discussed - possible to rent one, also, per D. Wooden; Trustee Wooden sd. amt. cld. be placed in Econ. Development's budget for 1989; he wld. like to work on the decorations wth. CofC - a member of sme. he sd. Mr. Wooden thought one person frm. VOP wld. be better - his interests are the light poles on Main St....CofC cld./wld. split cost wth. VOP. He wanted to know amt. allotted to CofC; amt. of \$500. per Mayor - they order decorations, VOP pays wth. CofC. paying their pt. to VOP. Use of VOP's snorkel fire truck disc. by Bd. - Trustee Gilmore voiced his disapproval of snorkel's use (if parts broken, expensive for repairs). Bd. did not arrive @ a decision.

Trustee Frontuto:

Trustee Frontuto referred to Cemetery Rules & Regs. re Winter burials in which it is stated no burials in VOP wld. occur between 12/15 and 3/15 of nxt.yr. Supt. wld. like to bury as far into Winter as possible, she sd...easier for families/less storage space needed. She asked for Bd.'s input. Closing Cemetery to public when rds. hazardous was discussed and allowing only families to enter. Trustee Gilmore felt that people shld. be allowed in Cemetery. Bd. unopposed to Supt.
