GARY LABERGE- Spoke regarding the programs and functions of the Palmyra Community Center

#### **TRUSTEE REPORTS**

Trustee Luke- Annual Health Inspection was done at the Water Plant. Other than the gas detector not working, this was replaced quickly, everything else was fine.

Trustee Denniston- As he wasn't here on December 20 meeting, he wanted to thank Trustee Luke for setting up the Horse Carriage Ride event until he was able to get there.

Trustee Leo- Monthly activity report for the Fire Department. This will be on file in the Village Clerk's office.

Trustee Parkison- Code and Zoning department is working on organizing old property files and closing out old permits. Business will be opening at 208 East Main St. Discussion regarding combining tickets with police department to lower costs and separating residential and commercial building permits. Mayor Perry- Highway department is working on snow and salting. When now doing that they are

working on their vehicles as two as older. The truck we ordered three years ago (was delayed by COVID and a shortage of parts) should be arriving in January. Building and Grounds have been working on foundations as weather allows. They are responsible for the safe route to school and cleaning off the four corners.

#### **DEPARTMENT HEAD REPORTS**

Mikel Hallings- Fire Chief- He did maintenance on rescue trucks including work on 21 and 22 primary valves. They will be doing 5-inch hose testing when the weather gets better. Mayor Perry mentioned repairing the handicapped ramp at the Fire Hall soon. Pancake breakfast is this weekend.

Kyle DiNardo- Police Chief- The department had 377 calls in December, 4772 for 2024. This is up 521 from last year. Looking to see if there is a discount on code system software with Tyler Technologies by purchasing it in conjunction with the county.

He would like to add code enforcement information to the police parking tickets to cut the price of purchasing the tickets.

They were able to provide 46 children with the Toys for Tots program. He thanked Officer Bryant and Ryan Darling for their help. He is hoping by next year they will have a 501(c)3 so they will be able to get donations.
