VILLAGE OF PALMYRA BOARD OF TRUSTEES

Regular Meeting

May 1, 1995

7:30 pm

PRESENT: Mayor James G. Elliott, Trustees Kathleen C. Drews, Frederick Celentano, Daniel E. Wooden, and Ann F. Guest.

<u>CALL TO ORDER:</u> Mayor Elliott called the meeting to order with a moment of silence for Mrs. David (Charlene) Lyon wife of David Lyon Supervisor of the Town of Palmyra.

Mrs. M. DeNeef asked for agenda time to alledgedly M. DeNeef: discuss cemetery stones and problems. Mayor Elliott stated that at no time was Mrs. DeNeef to mention any specific employees noting that should be done in Exec. Session. 7:35 p.m. Mrs. DeNeef began with the missing of cemetery stones and urns, reappearing stones and urns, trees planted, knocked down, and the investigations of Chief Dalton and another gentlemen as well as three (3) cemetery employees. No ones anything about the missing stones, she (DeNeef) said. DeNeef continued alledging that she attended a VB meeting and she was speaking with Trustee Wooden when alledgely the Clerk grabbed her arm and alledgely pushed her out the door and slammed the door in her face. DeNeef alledged that she went to the Pal. PD and swore out a warrant for the Clerk's arrest. Why hasn't anything been done DeNeef questioned. Mayor Elliott spoke up at this time stating that if she had a problem with an employee it had to be discussed in This was the employees right said Mayor Elliott exec. session. followed by noting the cemetery problem was a matter for the PD. DeNeef at this point began to raise her voice saying she (DeNeef) wanted the Clerk to be arrested no matter what she thought (the Clerk) said! Again Mayor Elliott re-emphized to her (DeNeef) that complaints about employees were strictly for Exec. Sess. that was a law and employees are due their legal rights. Mayor Elliott then said that the incident was a police matter and that is where DeNeef had to refer her problem. At that time DeNeef held up a letter written by the Clerk with a freedom of information form attached from Chief Dalton which noted there were no grounds for the accusations against the Clerk and therefore there was no paper work. DeNeef noted she had asked Mayor Elliott if he knew what the ltr was and before the Mayor could respond DeNeef answered her own question. No, DeNeef stated, the Mayor had indicated he had not seen the letter. At this point DeNeef At this point DeNeef asked if Mayor Elliott wanted the ltr. passed around so that the citizens of Palmyra could see what's going on? Mayor Elliott told DeNeef that was enough and if she (DeNeef) continued he (Mayor) would adjourn the mtg. This was a PD matter the Mayor said. At this point, DeNeef began demanding why she should Mayor Elliott read the two (2) most recent freedom of information forms and the responses on the forms. Which were that DeNeef would need to be more specific with what info she wanted.

CITIZENS PRIEM: Residents at 114 E. Jackson St. concerned about the cars and vans parked on either side of their driveway. Points were; no visibility, dangerous, parking on grass between curb and sidewalk near Cook's. Chief Dalton said that no laws were being broken unless the driveway was blocked. Nothing that PD could do. Trustee Guest spoke up noting that an arrangement for using the Reformed Church parking lot for the employees of St. Annes' school was being worked on. This would address the situation. Trustee Guest noted that a letter with particulars on the parking lot will be coming at least by the end of next week. Mr. Priem asked Chief Dalton what the reg. were on heavy trucks. None at this time at that location on Jackson St.

Mr. Priem stated his concern about the repaving of Jackson and when it would be done. Trustee Celentano noted that Jackson St. was on the list of high priorities. He (Priem) also had an interest in being on the Historic Preservation Comm.

UNION CONTRACT FOR PD: Mayor Elliott reported that a package has been sent to the Union negotiating specialist with two (2) proposals for a flex plan.

ABSTRACT #23: Mayor Elliott moved to authorize the Treasurer to pay abstract #23 vouchers 1289 - 1337 totalling \$23,822.51, seconded by Trustee Guest, vote, 5 ayes, <u>CARRIED</u>.

M & T AGREEMENT FOR COLLATERIZATION: Mayor Elliott moved to authorize the Treasurer to sign the M & T collaterization agreement which is a State regulation in a third party plan, seconded by Trustee Wooden, vote, 5 ayes, CARRIED.

BUDGET FOR 1995/1996 FISCAL YEAR: MAYOR ELLIOTT MOVED TO APPROVE

WAYNE COUNTY VILLAGE OFFICIALS: Mayor Elliott moved to authorize the Village Board, office staff, Village attorney, Police Chief and Fire Dept. rep. to attend the WCVO on May 17th, 1995, hosted by Sodus Point, seconded by Trustee Wooden, CARRIED.

The effective date of my resignation is May 5, 1995.
