PRESENT: Mayor James G. Elliott, Deputy Mayor Thomas N. Lynch, Trustees C. D. Gilmore, Daniel E. Wooden, and Kathleen C. Drews, Treasurer Darlene E. Matteson, and Bernard Donegan Representative, Roy McMaster.

<u>CALL TO ORDER:</u> Mayor Elliott called the meeting to order at 7:05 with a thanks to all Village of Palmyra Employees who all worked extremely hard during the recent water and weather conditions.

<u>PUBLIC HEARING OPENED AT 7:06 p.m. for the 1993/1994 BUDGET:</u>
Mayor Elliott directed the Village Clerk to read the Legal Notice as follows:

The Village of Palmyra will hold a public hearing (in conjunction with the regular Board Meeting) on Monday, April 5, 1993, at 7:00 p.m. The hearing will be held in the Trustees' Room of the Village Hall, 144 East Main Street, Palmyra, Wayne County, New York.

The hearing is for the purpose of allowing the Village residents to provide the Board of Trustees written or oral comments or ask questions on the tentative 1993/1994 budgets of the Village funds.

Compensation proposed to be paid to each member of the Village Board of Trustees is \$4,000; and to the Mayor \$5,000. A copy of the "Tentative 1993-94 Budget" will be on file and available for public inspection in the Office of the Village Clerk during normal office hours.

Village of Palmyra Bonnie J. Hays Village Clerk Dated: March 14, 1993

Roy McMaster covered the following items during the public hearing as follows: Summary of general, water, and sewer funds. History of assessed values and property values, explaining that the tax rates will drop in 1/2 from 16.88 to 8.22/M stating that the property taxes due on individual properties will be approximately the same as last year unless the house or property was undervalued.

Summary of revenues, General fund history and tax rate analysis. Water and Sewer fund expenses and appropriations, Capital reserves giving each item requested for the coming year with the amounts in the respective funds. A brief discussion on self insurance. A question of tax rate was raised by G. Ruliffson which was reviewed by R. McMaster. Being no more questions, hearing closed at 7:50 p.m.

MINUTES: Trustee Wooden moved to table the minutes of 3-15-93 making them available to the public seconded by Deputy Mayor Lynch, vote, 5 ayes, CARRIED.

A motion was made by Dpty Mayor Lynch to approve the minutes of 3-11-93 and 3-22-93 as written seconded by Trustee Wooden, vote, 5 ayes, <u>CARRIED</u>.

MAYOR ELLIOTT REPORTS:

BUDGET: A motion was made by Mayor Elliott to adopt the proposed budget as currently presented for the Village of Palmyra fiscal year of 1993-1994, seconded by Dpty. Mayor Lynch, vote, 4 ayes, 1 nay by Trustee Wooden, CARRIED 4-1.

<u>CROP WALK:</u> A motion to approve the route of the Crop Walk was made by Trustee Wooden and seconded by Dpty. Mayor Lynch, vote, 5 ayes, <u>CARRIED</u>.

ABSTRACT #20 AND ABSTRACT #21: Mayor Elliott moved to authorize the Treasurer to add the following vouchers 977 through 980 totalling \$456.07 to abstract #20 and authorize the Treasurer to pay vouchers #981 through 1056 less #986 and #1050 totalling \$33,530.50 on abstract #21 on which appear the initials of three (3) or more Village Board members, seconded by Trustee Gilmore, vote, 5 ayes, CARRIED.

WATER EXPANSION MEETING WITH TOWN OF PALMYRA: A meeting was set up by the Village Board to meet with the Town Board on Tuesday, April 6, at 8:00 p.m. at the Town Offices to discuss the proposed sewer on Division Street and Maple Avenue and water to North Creek Road area all located in the Town of Palmyra.

OFFICER C. CUMMINGS: An announcement was made concerning the injury that Officer Cummings received after being assaulted on Friday night, April 2, at the corner of Throop and Main when called out on an intoxicated person in the middle of the road. The person in question was arrested and is in jail on \$15,000 cash bond.

ISO REPORT: A meeting was held on March 29 with the Village Clerk, Mayor Elliott, Dpty Mayor Lynch, Fire Dept. 1st Assist. Chief, J. Brueing, Water Super., Harold Kruger, J. Lester of E. Pal. and John Harrington, Rep. of ISO. The report and results were explained thoroughly and with some minor changes and documentation the Class 5 rating for the VOP can remain.

<u>DAVE BECKER AWARD:</u> Mayor Elliott announced that the Palmyra Mason were giving local businessman Dave Becker an Outstanding Service Award which will be given in the Trustees' Room on Saturday, April 10, 1993.

REPORT ON FINGER-LAKES WATER MEETING: Mayor Elliott relayed information he had received at the water meeting on Zebra Mussells and the different methods of removing the problem. Mayor Elliott noted that because of the water temp. of below 54 degrees F. the VOP lines were not in danger of Zebra mussells.

PUBLIC HEARING ON PROPOSED LOCAL LAW #4, 1993, RESTRICTION ON FIRST FLOOR RESIDENTS IN C-1 DISTRICT; Public hearing opened at 8:02 p.m. by Mayor Elliott and legal notice was read by Village Clerk as follows: The Village of Palmyra will hold a public hearing in (conjunction with the regular Board Meeting) on Monday, April 5, 1993, at 8:00 p.m. on Local Law No. 4, 1993, Amendment to Chapter 29-16 Central Commercial (C-1) Districts that residential dwelling units are prohibited on the first floor of any building. The hearing will be held in the Trustees' Room of the Village Hall, 144 E. Main Street, Palmyra, Wayne County, New York.

The hearing is for the purpose of allowing the Village residents to provide the Board of Trustees written or oral comments or ask questions on the proposed Local Law No. 4, 1993. By order of the Village Board, VILLAGE OF PALMYRA, Bonnie J. Hays, Village Clerk, Dated March 24, 1993.

Mayor Elliott explained the proposed LL and explained the boundaries of the C-1 district. J. Merrick noted that the commercial district was not good now and the burden is on the property owner. Mr. Merrick suggested a survey be taken to see how long businesses stay in the VOP. Mayor Elliott noted that this LL did not originate in Historic Pal. Mrs. Larsson, stated once start turning into apts. the Comm. District would be destroyed. Businesses should advertise. J. Merrick said his property on Main St. has decreased in value since he bought it 6-8 years ago. G. Morell noted that he did not want to see residents on first floor but did not want another regulation. Mr. Morall noted the beautification project which costs the property owners more saying that at first offered foot patrol police but not anymore, bldgs. have broken windows need more police, part-time police maybe. Park & Ride takes half of the

parking places up in back of the bldgs. Main St. owners are afraid and no evening appts. are made because of that. More PD are getting hurt. Damage to G. Morell car in back lot a number of times. Mr. Morell noted that if the VB was so interested they would put on more PD and keep Main St. safe. Owners need to put in 5/8" glass in windows, heavier doors, and security systems—great expense to owners. G. Morell noted that the assessments are going up the value is going down. Mayor Elliott noted that the beautification project had ended and it was paid on about 20 years.

- G. Morell noted that the community and the owners have a difference of opinion on what Main St. property is worth. Mrs. Larsson suggested the Chamber and Historic Pal. work together to improve. Don Seconi, D. Nussbaumer, and G. Morell were all concerned about more govt. control, more crime and radical elements on Main Street as well less income and less profit with property values down. All agreed that they would rather see business in first floors not residents but VOP and TOP need to help. Why didn't property owners in C-1 receive letters on the Public Hearing and why aren't owners involved. G. Morell, if Main St. keeps getting rougher you can't save the buildings. Trustee Wooden asked how apt. in store fronts would help the climate on Main St.? G. Morell responded that this LL would be taking away an alternative on real estate giving owners one less alternative. Main St. is not catching on, more PD are needed, the Village residents should help it's our VOP possibly all pay an extra tax, suggested G. Morell Trustee Wooden said that more store fronts are rented now than when he came on the VB. Trustee Wooden asked how first floor apts. would change the economics of downtown? J. Merrick and G. Morell the property owners need encouragement to bring business back to VOP.
- R. Leopard noted some other locations which improved the downtown areas by using and staying original such as Corning and Canandaigua as well as Clifton Springs. These areas are on an upswing and filling store fronts. Other examples of original buildings which are successful are Lima Hotel, Avon Hotel, East Bloomfield Inn. People are willing to drive to these places noted Mr. Leopard who also stated that once a viable commercial district is gone it is gone.
- R. Reinwald said he doesn't want to convert bldgs, and noted that it costs money to convert. The VB cannot legislate economics. Which would be better asked R. Reinwald, an empty store or a nicely done apt? There has been no economic activity for 6 months and a tatoo parlor wanted to come in. Mr. Reinwald emphasized that the VB can't legislate economics or good taste, many signs look ugly. An apt. can be made to look as good as anything although commercial rental is preferred. E. Hartnagel noted that if there are first floor apts. in C-1 no one would come to VOP. D. Seconi said he cannot rent office space and gave rental prices of local malls compared to those in VOP saying that business are willing to pay more to have the mall exposure. R. Smith stated that this LL would be another obstacle for individuals to do something with their property. The VOP doesn't need more laws the owners need to turn a profit and make ends meet. R. Smith asked the VB not to pass LL#4, 1993.
- S. Vinci noted the decline in the cliental that wonders on Main St. after certain hours. If LL#4, 1993, is not passed and owners can convert the first floors to apts. what type of cliental or renter would the owners rent to. What would that do to the other businesses—force them out? L. Larsson asked if LL has to be passed tonight or can be tabled? Continuing L. Larsson asked if a task force committee could offer a plan to revitalize the VOP. All businessmen work together see if we can make a safer downtown. G. Morell noted that the constructive way to do something is more PD power noting that the owners have spent a lot of money to improve the Main Street and we don't want vigilantes in our community. A foot patrol presence may help. The PD has too much demand on their time now said Mr. Morell.

However, just the presence would be helpful. D. McCarthy, homeowner, noted the attractive beauty of the buildings and charm of Main St. He stated that he admired what the owners have done, but agrees with the law since apts on the first floor would only move the problem now on the second floor to the first floor.

K. Masker noted a security problem and put more responsibility on tenants. D. Seconi said it was not just tenants that hung out on Main St. and that there are 10 to 15 kids all the time some with open containers and not charged. J. Blazey said need to promote business, noted the empty lots east of the Village, and that the land owners pay taxes. Mayor Elliott mentioned the group of business people started by the TOP and VOP which died for lack of interest. Mayor Elliott also noted that the VB was trying and D. Macomber that the residents needed to support ideas. mentioned the bad attitude in the room and stated that all should work together, the bldg. owners, merchants, and VB. There is alot of scum on the Main St. said D. Macomber who then inquired about the loitering law and referenced too much noise on Main St. D. Macomber finished by saying that Palmyra has nice character and something needs to be done the same thing is happening to Reference was made to the poor condition of Webster also. Abbott's bldg and Crane's debris on the side of his bldg. D. Banks said girls will not park out back we are all victims, stating that there are too many undesireables on Main St., asking why does VOP have so many? Why can't a foot patrol be used to address the problem of kids hanging out downtown. It was suggested to put out a questionnaire, trying to do something not just complaining. What can the VB do for the merchants to get undesireables off the streets and clean up? Trustee Wooden noted that he is in favor of LL#4 and doesn't want to see first floor apts. around him. People come to Trustee Wooden's store from out of town and comment on what a nice Village Pal. is. Wooden suggested that businesses and merchants get together. Mayor Elliott said that he had spoken to C.E.O. Dundas who questioned the need of the LL#4 when a permit needs to be acquired prior to useage change for any commercial property according to the State Bldg. Code. Mayor Elliott noted, to date no permits had been applied for and received to change any C-l storefronts to apts.

Agnes Griffith said that she understands the problems and challenges of the business people and property owners, however, when the property diminishes in value it attracts tax consumers not tax payers. A. Griffith noted her attendance at a mtg on Village life. An ex. of a success is Clifton Springs, northside A women arch. worked on this grants were of Main Street. received and property developed making 12 store fronts and apts. which are all occupied. The money is available, can take one bldg. block see if VOP can do something similar. It the VOP if the people on Main St. can't make money. It is bad for noted there are too many absentee landlords. All have to work for quality not quantity. Funds are available for matching grants noting D. Nussbaumer's windows as a perfect example of where the Griffith-McLouth Foundation could help. Possibly an arch. could come to a mtg. and present ideas of what can be done allowing all to talk directly to each other instead of newspapers. Deputy Mayor Lynch said he was in favor of LL#4, but can see the problems of property owners, stating that all need to work together.

Tuesday, April 20th, mentioned as a good meeting night. Mayor Elliott stated that the property owners need to help themselves. G. Morell said that parking and undesireables is the problem and two hr. parking is not enforced. D. Seconi suggested to move Rt. 31 North of the Main St. to go around PAL. Trustee Gilmore referred to a letter from J.Hudak who supports the LL#4. and that K. Dudinski is opposed to LL#4. Trustee Gilmore noted that he is in favor of LL#4 and thinks people should get together. D. Seconi said that the deteriorating downtown means less income and people not willing to put money into bldgs. Mayor Elliott said that bldgs with Commercial on the first floor carry a greater

value. D. Seconi replied that everytime a restriction made on bldgs. the bldg. goes down in value. Chief Dalton responded to the need for foot patrol stating that this weekend the PD made 9 assault arrests each taking at 3 hrs. for paperwork. The PD can only do so much with what they have. Chief noted that the people are renting from the landlords asking whose at fault? People have legal rights to be on the street and the parking is done by upstair tenants and merchants themselves. Mayor Elliott closed by saying that anyone interested show up on Tuesday, April 20, an ad will be in the paper and the time will be determined later.

Mayor Elliott closed the Public Hearing on LL#4, 1993, at 9:34 p.m.

WATER QUESTIONS: T. Wilson asked if competitive bidding was necessary on MHPC services. Mayor Elliott responded that it is considered professional services which do not require comp. bidding per the VOP procurement policy. W. Kwan noted she had check Dun & Bradstreet on MHPC with interesting and erronious information.

T. Wilson asked about the water billing to tenants and why he was only notified this past month for a water bill owed all year. Mr. Wilson said he did not feel responsible for 3/4 of the Water bill because he never received a reminder notice and was just notified. Attny. Nesbitt noted that the bill can be sent to the landlord instead of tenants that sending the bill to tenant was a benefit that the VOP chose to offer and did not have to offer. Trustee Wooden noted that the landlord is always responsible for non-payment of bill and that ultimately the unpaid bill ends up in the taxes. Mayor Elliott answered a question about shut offs saying that a charge to shut off and re-start are charged to the landlord. Any unpaid amounts are charged to the tax bill in June and that April 30th is the last date to pay. Trustee Wooden said it might be easiest to bill landlord and Mayor Elliott added that the landlords job is to protect his/her interest.

<u>DEPTY MAYOR LYNCH REPORTS:</u> The drainage project is underway. Trustee Wooden noted that particular interest be paid to the culverts and check for clogs. Mayor Elliott said that E. Henry felt his drainage situation was better.

Mrs. Anthony remarked what a good job the Highway Dept. did on Friday night.

TRUSTEE GILMORE REPORTS: Noted to table LL#4 and put on the agenda for May 3, 1993, board mtg.

TRUSTEE DREWS REPORTS: Entry signs are moving along. Trustee Drews met with D. VanGorden and some of the organizations have been heard from. Depty. Mayor Lynch noted that the Rotary wanted a copy of the sign to help determine their donation. Trustee Drews said she, Ed. Dundas, and NYS DOT rep. Larry Russell will meet on Monday at 3:00 p.m. April 12 to check out locaitons for the signs. First sign should be ready in June.

TRUSTEE WOODEN REPORTS: Canal Development Group is working on information on property owners on the Canal and what the VOP owns. The comm. will decide the areas to work with after they come to the VB at the end of June or July.
