**CALL TO ORDER:** Mayor Wilson called the Village Board meeting to order at 7: 35 p.m.

Phil Retan, past Village Superintendent, has worked with Nelson Cook in the past and feels that Nelson is highly qualified. Issues regarding grievances, overtime, insurance, contract price, inventory of equipment, and emergencies were discussed. Trustee Guest tabled her questions until Village Attorney Nesbitt could be in attendance.

Supervisor Lyon reported that the Town attorney has approved the contract.
