Review of Wat. Contract:

Attorney Tyo commented that the former Trustee F. Alderman emphasized that the Village of Palmyra has had to pay very high taxes on the water line which stretches through the Town of Manchester but there was no demand that the

Manchester Comments:

Village of Manchester would be the recipient of a water bill for unused water. The situation was complicated by the fact that the Village of Palmyra was being "milked" by taxes which, if assessments could be lowered, would help the financial picture of the Village of Palmyra Water Fund. With this thought in wind of attack to love the assessment the Village of mind, of attempting to lower the assessment, the Village of Manchester was surprised to receive a bill of \$23,130.00, in early June, when almost simultaneously, the Village of Palmyra received a notice from the Town of Manchester indicating a decrease of assessment of \$12,000. on the water line.

Questions & Comments:

Trustee Strong queried if the Village of Manchester planned to renew the contract in years to come.

Mayor Liberty intimated that he felt the Village of Manchester probably would want to keep the contract.

Trustee Brown interjected that with the reduction of the assessment and ultimately, taxes, all of this should be taken into

Landfill Users:

Mr. Granger informed the board that Dugan Enterprises, a refuse collector for Garlock, Inc., is presently dumping in the Village landfill. By agreement with Dugan, Mr. Granger commented that he is receiving \$15.00/load in cash from Dugan, and the Village is to receive \$3.00. In addition, Ontario Refuse, who is the collector for Salzburg Village, off Laurentian Drive, has agreed on a price of \$20.00/container, with Granger to receive \$12.00 and the Village, \$8.00. Board commented that refuse tickets should be obtained at the village clerk's office by the haulers.

School Traffic Hyde Pk. & W.Main: C. G. Hutt, Superintendent, Palmyra-Macedon School, wrote a detailed letter to the board outlining the need for additional time to be allocated for the police women who guide the children across strategic intersections adjacent to the Canandaigua Street School and assist car traffic at the corner of Hyde Park & West Main. Trustee Strong commented that he would agree with extra coverage at Canandaigua & East Jackson, for an earlier hour, but would like further explanation from Mr. Hutt relative to having someone assist the buses in moving out into the early morning traffic. Request Slo-Children: Mrs. Ronald Rhinewald, 116 East Charlotte, called the office to request that the village place signs on this street to warn vehicle traffic of children at play. Board agreed that most streets in the village have this same problem and if signs are placed in one area, they should be placed in all.

Police Justice: Board made no decision on the appointment of an assistant police justice. Tabled for further applications.

Revenue Sharing:

Clerk advised that a Planned Use Report must be submitted to the Federal Gov't by September 14, 1973 relative to the receipt of the allocated funds from July 1, 1973 - June 30, 1974, which may be in the amount of \$26,794.00. Matter tabled for next board meeting.

Invest. Suggest. of Funds: A letter received from Mr. R. V. Callahan, Asst. Sec'y., Marine Midland Bank, suggested the selling of various funds in both the P. T. That the Town of <a href="Palmyra">Palmyra</a> annually levies and collects taxes against real property within the Village of Palmyra to pay for items provided for by subdivisions 3 and 4 of Section 141 of the Highway Law.

3. That taxes levied and collected against real property within the Village of Palmyra for subdivision 3 of Section 141 of the Highway Law are used for the purchase, repair and custody of highway machinery, tools and implements used on town highways, which highways are located outside the

village limits.

4. That taxes levied and collected against real property within the village of Palmyra for subdivision 4 of Section 141 of the Highway

a procedure whereby a Town Board may exempt real property owners in villages from taxes levied by towns for items 3 and 4 of the Town Highway Budget. That such authority to exempt real property owners in villages

from such town highway taxes was granted to town boards by the state beginning ture in recognition of the unjust double burden of taxation paid by village real property owners for the maintenance of highways. \* 8. That, on information and belief, none of the money levied for the removal of snow from town highways by the town government has been used for the removal of snow from village streets. 9. Hsg. Auth.:

N.Y. State Assoc. of Renewal & Housing Officials, Inc. informed the Village on August 9, 1973 that the N.Y.S. Legislature earlier this year had created a housing authority for the Village of Palmyra. General discussion ensued relative to who might be members of the Housing Authority, such as village board members. Inasmuch as the Village of Newark, under the supervision of Jack Kenny as Housing Authority Director, has had some experience in this matter, it was suggested that he be asked to attend the next regular board meeting as well as William Roche, Urban Renewal Director for the Village of Palmyra.

Canal Tn. Nursery School: Mayor Fitzgerald read a letter which he had received from the Planning Board relative to the establishment of a Nursery School in the Presbyterian Church. Clerk advised a hearing had been held and the Zoning Board would be conferring on 8/28/73 at which time a decision would be made, whether or not to allow the use as requested in the R--2 Zone. Findings and decision would then be drawn by the Village Attorney and the Nursery School would receive a copy of the findings and decision.

Flood Ins.: Trustee Green asked Attorney Poyzer to draft two (2) resolutions for the board relative to flood insurance for village residents.

Landfill:

Addendas have been drawn by Trustee Green, who gave them to Attorney Poyzer for her to draft in legal terminology. The rules and regulations were originally drafted in 1968 for materials that might be dumped in the landfill. The Town of Palmyra patterned an ordinance incorporating most of the rules and regulations suggested by the village. It is the prerogative of the Town of Palmyra to amend the ordinance.

Airplane Complaint:

Trustee Green advised that he had received calls relative to airplanes swooping too low over various parts of the village. Trustee Green commented that he had called the Aeronautical Board which informed him that unless the complainers were able to obtain the number on the plane, that they could do nothing.

Wideman Letter to Fair: Zoning Officer Wideman sent a copy to the Mayor of a letter which he had written to the Palmyra Fair Association complimenting them on the cooperation on their part for the installation of electrical facilities and more important of sewerage holding tanks for use of the trailers temporarily at the fair.

Mutual Fire Aid Drill: Permission was received from John Blazey, owner of the property adjacent to the Canal over which the Fire Companies desired to transport trucks on September 8, 1973 beginning at noon, for a Mutual Aid Drill. Prime target would be the Webaco Oil Co. on Division Street. Village crews will prepare the roadway as requested by the fire department.

Lozier Request: A letter from Wayne Ackart, Lozier Engineers, indicated that any rubble from demolished buildings in Urban Renewal could be placed in the Erie Canal Bed. However, he emphasized that the Dept. of Environmental Conservation at Avon should be contacted prior to doing this.

Conf. of May. Letter re: Tax Relief: A letter from the Conference of Mayors urged all village officials to petition the Town Board to exempt the Village from certain town taxes such as on highway machinery and for removal of snow from town highways, as well as cutting of brush in the town. Petition was signed by all board members and clerk instructed to submit to the Town of Palmyra.

Citizenship Day: A request from the U.S. Dept. of Justice Immigration & Naturalization Service has requested that the Mayor of the Village proclaim September 17, 1973 as Citizenship Day.
