**ANNOUNCEMENTS:** Mayor Wilson started the meeting with a couple of general announcements. First of all, the spending for the Olympic Torch event will be kept within \$1000.00. The municipal equipment auction netted the Village approximately \$50,000 which will go into the equipment reserve.

**PERMISSIVE REFERENDUM:** Trustee Gunkler moved to adopt the following permissive referendum:

## LEGAL NOTICE OF ADOPTION OF RESOLUTION

NOTICE IS HEREBY GIVEN that the Board of Trustees of the Village of Palmyra, Wayne County, New York, adopted a resolution during a meeting on May 25, 1996, subject to a Permissive Referendum as follows:

BE IT RESOLVED that a sum up to and not to exceed THIRTY-FIVE THOUSAND DOLLARS (\$35,000) shall be expended from the Capital Reserve Sewer Fund (HR4), THIRTY-FIVE THOUSAND DOLLARS (\$35,000) shall be expended from the Capital Reserve Water Fund (HR3) and SEVENTY-FIVE THOUSAND DOLLARS (\$75,000) shall be expended from the Capital Reserve Street Repair and Improvement Fund (HR6) for use on the Gates Street Project.

Following publication, the foregoing resolution shall be posted in six (6) conspicuous places and in accordance with Section 9-902 of Village Law, shall take effect in thirty (30) days.
