Lengthy discussion held on waiving re alternator/alternator output; also, vill. bid two buckets. After discussion, Trustee Elliott moved that the Board table the above motion until next mtg. (9/17/84) giving board more time/still within 45 days of awarding; Trustee Rolland seconded tabling motion; all voted "aye," carried.
- HIGHWAY Mr. Rolland stated that Vilalge's new MEO, R. Roets, will be resigning to accept another position for which he will receive higher pay; Mr. Rolland requested that Board authorize him to accept said resignation disc. on shortage at Highway - Mr. Rolland said he is two men short/would like to fill MEO position before snow. All Vill. summer help gone; moved to accept Mr. Roets' resignation; Trustee Hays seconded. All voted "aye," carried.
- TUITION Trustee Rolland motioned that board authorize expenditure of approx. \$139 REIMBURS. full tuition rate, for Mr. R. Weaver, C&P Foreman. The courses taken by Mr. Weaver are in direct relation to his Village position; Trustee Vrubel seconded. Discussion - Mr. Rolland felt that management of which Mr. Weaver is a part, does not fall within Union policy/ contract. The Mayor did not agree payment 'up front' - not done in industry or elsewhere; Trustee modified motion that board would reimburse fully upon successful course completion; Trustee Elliott seconded. "Ayes," Trustees Rolland, Hays, Vrubel & Elliott; "Nay" - Mayor Strong.
- SEALING/ Trustee Rolland said est. rec'd for sealing parking lot at Firehouse/ STRIPING striping - also striping Vill. Hall parking lot - approx. \$1000. The Mayor req. that arrangements be made for parking prior to work being done.
- VETERANS' Discussion held on veterans' increased exemptions; local law #2, 1984, EXEMPT. Discussion held on veterans' increased exemptions; local law #2, 1984, having been presented to Bd.; Trustee Rolland moved that board conduct public hearing on 9/17/84 at 7:00 p.m.; Trustee Hays seconded. Atty. J. Nesbitt elaborated upon the law signed by the Gov. on 7/28/84 - provide for public hearing - can't change at later date. The Clerk was req. to invite Mr. C. Schwab from County to hearing - as well as J. Roney, Assessor. All voted "aye," carried.
- VOUCHERS Trustee Elliott motioned that board authorize Mayor to sign Abstract #6, in amount of \$44,028.41 on which signatures/initials of at least three trustees' names appear; Trustee Vrubel seconded. All voted "aye," carried, however, Trustee Hays did npoint out that employees buying products at places other than those approved where good terms were agreed upon with various firms (some on cost plus basis, etc.) The Board agreed.
- OPEN CONT. Dispensing with "Open Container Law" for Canaltown Days was disc. by LAW: Board - following discussion, Trustee Rolland motioned that Board dispense with OCL during two-day period of Canaltown Days in areas same as last year - beginning at Main St., corner of Cuyler & Williams, westward to Canandaigua & Church Sts., including Park and area immediately surrounding Vill. Hall Parking lot; Trustee Elliott seconded. All voted "aye," carried.
- HOSPITAL The board not having had an effective date for employee hospitalization sign-up, disc. held in this regard. Mr. Rolland stated that Union Cont. provides as a benefit suggesting effective date when Village substracts Union dues/further discussion following which Mr. Rolland moved that first eligible period following employment (20th of ea. mo.) become standard effective date; Trustee Vrubel seconded, all voted "aye," carried. The Clerk req. to notify Vill. Treas. and all dept. heads of establishment of date.

X-MAS The Bd. acknowleged receipt of communication from Mr. R. Edwards rep. DECORAT. Chamber of Commerce, re Christmas decorations and Bd.'s financial assistance. Discussion. On-and-off switches downtown suggested; hire qualified electrician; Bd. could place \$500. in next yr's budget; Trustee Elliott suggested that old decorations in P&C Rooms basement be sorted and fix ones which don't work. Trustee Hays moved that Village assume financial responsibility for hiring electrician to install adequate switches/utilities for Christmas decorations; inform C of C Village will fund/C of C furnish money for cost of materials. Trustee Elliott seconded. All voted "aye," carried. It was suggested that Village purchase materials for above/ C of C will pay Village for same. Bd. agreed.

AM. LEG. As last year, the Am. Legion requested blocking Cuyler St. (one Blk) from 7-8 p.m., 9/15/84 for Pipers' Band demonstration; and permission to cross Cuyler to William and on to Towpath Manor on Sun. The Bd. agreed to do so, upon a motion by Trustee Hays; Trustee Rolland seconded. Mayor, Trustees Vrubel, Hays and Rolland voted "aye,"; Trustee Elliott voted "nay."

PARADE SIGNS The Mayor requested Clerk to order magnetic parade signs, "Village Officials, Palmyra, N.Y.", for use in future parades.

BLOCK Mr. Peter Debes of Hathaway Place approached the Bd. re closing Hathaway
PARTY Pl. on 9/23/84 for "block party" - the Bd. having been previously approached by letter from Mrs. Sharon Brown. Discussion by Bd. Trustee Rolland motioned authorization for closing off st. for period requested, Mayor Strong seconded. Trustee Elliott was opposed - street should be open for emergency vehicles/street traveled/tie-in to W. Foster/Spring. & Fayette Sts. Further discussion/Mr. Debes said they were requested "restricted" traffic; Trustees Rolland & Vrubel and Mayor voted "aye," Trustees Hays and Elliott voted "nay". Carried by majority.

PARKING It was related that M/M B. Duffy of Cuyler St. had req. no parking REQ. in front of their residence for the morning of 9/15/84 due to family wedding, etc. Bd. discussion/due to being unable to enforce same -& opening day of "Canaltown Days," Bd. did not allow said req., however, following Cuyler St. resident's complaint of cars parking in yards, etc., Trustee Elliott moved that "no parking" be allowed on <u>all</u> of Walker/Charlotte during "Canaltown Days" to alleviate congestion; Trustee Vrubel seconded. All voted "aye," carried. This motion also contained the Bd. req. enforcement of "no parking" areas as rec. by Police Chief. discussion held on parking on one-way portion of Fayette on west side; law says "no parking" on east side from Foster to Spring.

PARKING In order to "standardize" Village parking, the mayor appointed Trustees COMMITTEE Elliott & Vrubel to review the Code, Loc. Laws, etc. as allowed parking appears to be confusing and less than adequate regarding enforcement, etc.

UNION CONT. The Mayor announced that a three-year Union Contract has been entered into with CSEA, on 8/23/84. Negotiations completed within 2 (2) months time as opposed to eleven (11) for last Cont.

RT. TURN Short discussion held re "no right turns" from Main St. - two are in SIGNAL place but difficult to see/Clerk req. to contact Mr. J. Edinger with req. to mvoe said signs - it was brought out that some citizens questioned why signs weren't placed above st. on traffic light.

ADJOURN: There being no further business to come before the Board, at 9:15 p.m. Trustee Hays moved adjournment; Trustee Vrubel seconded. All voted "aye," carried.
