Any persons violating any of the provisions of this Ordinance shall be punishable for the first offense by a fine not to exceed ten dollars, and for the second offense by a fine of not to exceed twenty-five dollars or by imprisonment for not less than two or more than fifteen A third or any subsequent offense within one year shall be punishable by a fine not exceeding one hundred dollars or by imprisonme not exceeding six months or both such fine and imprisonment.

Section 4. Repeal of Prior Ordinances.

All ordinances or parts of ordinances of the Village of Palmyr inconsistent with the provisions of this Ordinance are hereby repealed, provided, however that such repeal shall be only to the extent of such inconsistency and in all other respects this Ordinance shall be in addition to the other ordinance regulating and governing the subject matter cover by this Ordinance.

Section 5. Validity

If any of the provisions in the foregoing Ordinance be decided by any court having jurisdiction to be unconstitutional or invalid, the same shall not effect the validity of the foregoing Ordinance as a whole or any part thereof, other than the part so decided to be unconstitution or invalid.

Dump
Contract:

Mayor Nussbaumer informed the group that the village had suggested \$8,000.00 plus a \$2,500.00 closing fee, should the State decree that the dump be closed, for an annual payment by the Town of Palmyra as its share of the operating expense of the Village Dump on Garnsey Road located in the Town of Palmyra and used by both town and village residents. Trustee Sinclair discussed the costs to operate the dump -- S. Gilfus contract fee as caretaker of the dump, village crew, plus the fringe benefits of hospitalization, retirement, social security, as well as the work done by Everdyke during the summer in trenching the dump area. Moreover, Trustee Sinclair commented, it is more than likely that a new road plus a new fence and further trenching in the spring will be necessary to keep the dump sanitary and acceptable to the desires of the State Department of Health, now the Conservation Department.

Trustee Leysaht interjected that it could be assumed that a figure of \$16,000.00 might be in order to figure for an

annual cost.

Councilman Baran, of the Town of Palmyra, queried if the village had contemplated contracting the operation of the dump out to a specific person or corporation, to which Trustee Sinclair replied that this had been a possibility prior to the time when the State had OK'd the use of the dump following the trenching. Councilman H. B. Pierce commented that the Town Board wants to pay its share, not whether the work is cheap.

Trustee Leysath remarked that it was his understanding that Garlock, Inc. does not pay anything as an industry for the use of the dump and they have a key with daily access.
Supervisor Bedette advised that the Town Board does not feel there is justification for an increase of \$3,000.00 for the

coming year raising the fee to \$8,000.00.

Attorney Rubery:

Attorney Rubery for the Town of Palmyra at this point explained that a fee of \$6,000.00 as well as a stipulation of a \$2,500.00 closing fee plus a 50% share of any capital improvements -- such as fence, grading road, and bulldozing, -- might be a suitable agreement. In addition, he commented, that it might be practical to consider leasing or bidding out the operation of the dump entirely.

Attorney Nesbitt: Attorney Nesbitt suggested that the Town of Palmyra pay \$6,000.00 with the stipulation of a \$1,500.00 clause to be a maximum amount over the \$6,000.00 for any needed capital improvements for a period of one year. In addition a \$2,500.00 closing fee would be included. This seemed to meet with the approval of all and Attorney Nesbitt was informed to draw such a contract.

Fire Contract:

Town Board members informed the Village Board that they had budgeted only \$6,000.00 for a contract with the Village of Palmyra. Furthermore, they continued, in that the budget hearing has been held and the budget approved, it cannot be increased. The Village Board commented that the contract should be drawn for only one year. It would behoove the Town Board to consider a larger appropriation in the ensuing years and negotiate with the village prior to budget time.

(It is to be noted that a letter was sent by the village clerk to the Town of Palmyra on 9/17/70 informing them that a contract or budget figure of \$10,000.00 for a 2

Ins. for Firemen:

A letter was read by Trustee Leysath from VandenBout Ins. outlining additional coverage for firemen, especially pertinent for those on the Oxygen Squad, which because of the lack of any of their actions or because of their actions, in handling any patient, a patient might decide to bring suit against the department, or oxygen member, this type of insurance would be effective. The cost per year is \$40.00 and would provide professional liability coverage for all village employees as well as the firemen. The following motion was made by Trustee Leysath, 2nd by Trustee Sinclair and carried: -

Motion to: Provide insurance RESOLVED: That the Village of Palmyra inform VandenBout Insurance Agency that additional coverage to be known as "Professional Dexposure" Insurance at an annual cost of \$40.00 which would cover all village employees as well as members of the fire department, be added to the insurance coverage of the village.

Propos.: Annex. of Area Trustee Sinclair and Trustee Leysath informed the board that they have heard several people who live in the Town of Palmyra, south of West Foster Street between Canandaigua Road and Stafford Road, comment to the effect that they would be interested in annexation to the Village of Palmyra. Trustees Sinclair and Leysath suggested that Attorney Nesbitt draw preliminary annexation papers for a survey of those who might be interested in annexation.

Claremont : Park New York State Electric & Gas requested permission to install a new gas service on Clairmount Park, advising that after the service has been installed, the road surface and lawn areas would be replaced. Motion by Trustee McGuire, 2nd by Trustee Sinclair to grant request.

Stop Signs: Attorney Nesbitt commented that prior to adopting the street sign ordinance on which there was a public hearing 12/14/70, it would be his opinion that the board should wait until the State of New York clarifies the maintenance of Canandaigua Street on Route #21 in the Village of Palmyra.

Snowmobile: Ordinance

Attorney Nesbitt informed the Village Board that during the last week he had received word from the State Conservation Department advising that any adoption of a Snowmobile Ordinance within a village must also adhere to state regulations which would entail the erection the first of October special snowmobile signs on all village streets where snowmobiles would be allowed and the removal of such signs the first of May. Attorney Nesbitt commented further that he had talked to Assemblyman Joseph Finley regarding the state edict, at which time he mentioned to Assemblyman Finley that he felt the state had really "laid an egg" on this.

Table Snow .: Ordinance

On motion by Trustee Leysath, 2nd by Trustee McGuire and carried, the board unanimously agreed to table the adoption of the snowmobile ordinance until such time as less stringent sign rules be suggested.

Fire Contract: Attorney Nesbitt informed the board that he had received a fire contract from the Town of Palmyra. However, before presenting to the village board, he wished to have the content checked with Fire Chief O'Brien for his comments.

Fire Phone

Fire Chief O'Brien spoke to the board in connection with the installation of a fire phone in the village offices, one which has been in Maurice Chittenden's barber shop. Due to the discontinuance of a full-time barber shop in this location at 128 East Main Street, it would be his suggestion that this phone might be placed in the village offices. Motion by Trustee McGuire, 2nd by Trustee Leysath to have the phone installed in the village offices.

Fashion Show:

The owners of Jo Annette Fabric Shop asked for the use of the Park & Club Room for a fashion show on April 7, 1971. On unanimous approval on the board, she may be so informed.
