Mayor Wilson read the advertised "Legal Notice", attached hereto to consider the adoption of a Local Law to amend Chapter 27 of the Code of the Village of Palmyra entitled "Water Rates and Charges," increasing the water rates as follows: The minimum rate for each quarter shall be \$5.00 up to 700 cubic feet; for each 100 cubic feet thereafter, the quarterly rate shall be \$.75; and tank lots shall be \$.75 per 100 cubic feet with a minimum charge per tank of not less than \$5.00.

Mr. Roy L. McMasters, representing the Village's consultants, B. Donegan Associates, was present. Mayor Wilson said that Bd. had been discussing proposed water rate increases for past several yrs. Mr. McMasters gave a presentation with hand-outs and lantern slides in which it was shown in cubic feet and gallons how an increase would affect residents. It was pointed out that no increase had been realized in eleven (11) yrs. - since 1972. He spoke of inflation, declining rate scale, trating water, transportation network from Canandaigua Lake, basic operational cost, etc. and that proposed change will not be great enough - perhaps have to be changed in 1984. Trustee DePoint spoke of cost of purification; taxes on lines running through towns, etc.

Discussion on placing monies in Capital Reserve Fund and depletion of \$255,000 - \$285,000. for water line replacement on Vienna St. Trustee Hays, W&WW Commissioner, said taht Bd. was cautious in proposed increase for persons on fixed income; should have been scrutinized on yearly basis in past; tapping into "Fund Balance" - operating Water Dept. at a deficit. Trustee DePoint said taht Bd. would monitor - unsure about increase within nxt. yr. - and spoke of expiration date of Garlock Contract; should negotiate at a considerably higher rate. Mayor Wilson asked Mr. McMasters if proposed increase would cover expenses and was told that it would help - did not think it would "cover". Trustee DePoint suggested sending "signals" to Town Bd. - Village/Town Contract has remained same for past three years. Councilman Ed Wheeler, who was present, questioned percentage increase in round numbers - discussion followed during which it was stated that "average family" will realize no impact at all; major consumer's bill will almost double. Dear Mr. Morell:

Following our recent telephone conversation, I met with Mr. Porretta at his property located at the corner of Vienna Street and Mill Street in the Village of Palmyra to discuss the location of proposed driveway curb cuts for access to his property.

During our discussion, Mr. Porretta was advised that the new street design does not include a curb cut for Mr. Porretta's property along the northside of Vienna Street. The existing curb cut on Mill Street is not proposed to be disturbed. It was explained to Mr. Porretta that the curb cut on Vienna Street was not to be provided in an attempt to avoid street runoff from draining into his property. Mr. Porretta said that street drainage had run down his driveway and across the paved portion of his property in the past and he did not consider that to be a problem which should lead to the elimination of the curb cut on Vienna Street. Mr. Porretta said that he had been advised by the Village that a driveway entrance from his property to Vienna Street located close to the street intersection is considered a safety hazard.

Mr. Porretta was advised that a curb cut will be provided on Vienna Street for his use. As described to me at the site, Mr. Porretta would like a driveway entrance onto Vienna Street which will be capable of passing two vehicles simultaneously. The request to the Village in the letter dated October 7, 1983 to Ms. Laura Poyzer implies the need for a residential curb cut and driveway on Vienna Street. The Village has instructed Lozier to have the Contractor install a residential curb cut and driveway in a location agreeable to Mr. Porretta to allow ingress and egress on Vienna Street. However, residential driveways are not typically wide enough to pass two vehicles at the same time. The construction of the curb along the frontage of Mr. Porretta's property is planned for completion during the next week or ten days. A curb cut sufficient to provide a ten feet wide driveway will be installed unless specific instructions are given to Lozier by the Village prior to undertaking that work.

It is anticipated and expected that in return for the Village and Engineer's compliance with your request on behalf of Mr. Porretta, that a REBBASE will be prepared, on behalf of Mr. Porretta, to hold the Village of Palmyra, Lozier Architects/Engineers, and the Contractor harmless from any damage occurring as a result of drainage running from Vienna Street onto Mr. Porretta's property.
