

Present: Mayor David Nussbaumer, Trustees Frederick Alderman, David McGuire, Lloyd Green, Robert Brown, and Police Chief Donald Henry. Louis Ziegler, reporter for the Wayne County Star also attended.

Discussion was opened to appoint Officer Peter Stirpe to full Sergeant. Chief Henry was asked for his opinion which follows: The Chief felt that the Board was bypassing him by not informing him of this appointment. It is noted that the Chief was called by Trustee Alderman prior to the meeting to make him aware of this fact.

Further comments by the Chief are as follows: Chief Henry felt that a Sergeant should live in town and be readily available. He also suggested that no pay raise be given until Stirpe passed qualification test in April for rate of Sergeant. He also felt that Officer Smith was more qualified to be Sergeant. The Chief said that Stirpe did more public relations work in his job than he did police work. The board asked the Chief if he didn't feel that this was part of an officer's job. The Chief stated that public relations have nothing to do with the job of law enforcement. The Board unanimously disagreed. They felt that in today's society this was an integral part of the modern policeman's job.

After more discussion on Officer Stirpe, the Board asked the Chief why he had not approached the Board sooner when Officer Stirpe became eligible for promotion and given his opinions then. The Chief said that he only came to the Board with a problem when he was really upset over something.

The Board agreed that there was a lack of communication on the Chief's part and possibly on the Board's part. But, they felt that under any circumstances, the Chief should have a closer rapport with the Board.

The Board asked if the Chief had any suggestions about his duties. He suggested that he work no shifts so that he may check on patrolmen and cover any time of day. He felt that under the present circumstances that this was not possible.

The Board suggested that the only way the Chief could be knowledgeable of all that was going on would be to check his men at various times. They felt this was the best way for him to control his department.

The Board also brought up the fact that it had been recommended to him at an earlier date that he keep a record on file of all of his officers and that he check shifts at different intervals. The records would help to verify any complaints against an officer, infractions of rules and duties, etc.

After further discussions, the Chief recommended that we appoint Officer Stirpe to Sergeant with whatever raise we saw fit.

Motion was made by Trustee Green on the recommendation of the Chief that Peter Stirpe be appointed Provisional Sergeant until he passes the test in April and that he be given an immediate raise in salary to \$170.00 per week, seconded by Trustee Alderman, unanimous vote in favor of promotion.

The Mayor recommended that he inform Officer Stirpe and then the Chief and Police Committee would get together with him and discuss his new duties and responsibilities.

It was left up to the Chief to do this instead because of the fact that he is head of the department.

Discussion was then taken up about the fact that we had not yet received our new high-band base station through the Sheriff's Department. Trustee Alderman then stated that he had talked with Sheriff Hurley earlier in the day and had been told we would not receive it because we had not applied for it. It was noted that at a previous Board meeting, we had been told by the Sheriff we would receive one as soon as they were available. There was no mention of an application being needed at that time.

September 26, 1972

Trustee Green made motion we contact Sheriff Hurley by letter and phone to attend next meeting to discuss this matter, seconded by Trustee McGuire and carried.

There was a following discussion about the Police car leaving the boundaries of the Village for questionable reasons.

This matter will be investigated and discussed at a later meeting.

Adjourn: Trustee Green made motion to adjourn, 2nd by Trustee Brown and carried. Mayor Nussbaumer adjourned the meeting at 10:45 P.M.

Section 3. Prohibition.

a. No person shall have in his possession any open container containing an alcoholic beverage in Main Street Park or Vienna Street Park.

b. A curfew is hereby imposed on all persons using Prospect Hill Park between the hours of 12:00 P. M. and 6:00 A. M. unless said persons have a special permit from the Board of Trustees of the Village of Palmyra to be on said premises during said hours.

Section 4. Penalties. A violation of any provision of this Ordinance shall be an offense punishable by a fine of not more than One Hundred Dollars (\$100.00) or by imprisonment for not exceeding thirty (30) days or by both.

Public Hearing (Continued)

Citizens: Approximately 25-30 citizens were present.

Proposed Ordinance: Mayor Nussbaumer outlined the proposed rules as suggested in the ordinance:

- a. No alcoholic beverage in the Main Street Park or the Vienna Street Park.
- b. Curfew to be imposed from 12:00 P.M. until 6:00 A.M. on the Prospect Hill Park, unless a permit has been obtained from Village Board.
- c. Fine not to exceed \$100.00 or imprisonment not exceeding 30 days or both, if above be violated.

L.Lynch: Questioned why this matter was even brought up.

Mayor: Commented that the matter was aired by Trustee Green due to the fact that there had been noticeable abuse of the Main Street Park when small children accompanied by a parent wished to use the premises to find the grounds covered with broken glass, empty beer cans, etc. However, he continued, it was the opinion of most everyone that a ban of alcohol in the Prospect Park need not apply.

Gen. Comment: Some mothers had been reluctant to venture into the park because of the garb of some of the older teenagers in the park who apparently had nothing better to do than lie around the park during the day.

J.Leysath: Can you apply all this to drink? What about broken pop bottles?

Mayor: The main reason is drinking in the Village Park (Main St. & Vienna).

Bear Lynch: Aren't there laws that exist to take care of such conduct?

Mayor: There are disorderly conduct laws.

Bear Lynch: The majority of people do not abuse the privilege of using the park.

D.Leysath: Have you been able to get the feeling from the group of complainers? What is the age group?

Mayor: Age group of users seem to be 16-35.

Who would benefit from such rules?

Mayor: Would help in the children's park. Most complaints seem to be during the day.

L.Green: If the Prospect Park were closed at midnight, there would be no reason to check on it. He commented that he feels laws are passed for people to obey not to abuse.

Bear Lynch: If the curfew were enforced, there would be no small children involved.

Shirley Knapp: In effect, then, a person can be arrested?

Jackie Leysath: Aren't there laws now to make a person leave the parks if they are disorderly?

Mrs.Haak: Isn't there drinking enough without parks? She commented that when strangers drive into the village and see people walking around the village park drinking and tossing containers on the ground, a bad impression is formed of the village.

D.Leysath: Is this to curb rowdiness or drinking? If so, the police can ask a person to leave and if they do not, the police can force the person.

Albert Dennie: Would there be permits on Prospect Park? Would Boy Scouts be allowed to use Prospect Park.

- Albert Lawrence: Is this just a proposal?
- Mayor: Groups who apply for a permit can be allowed to have parties.
- J. Leysath: Didn't Robert Brown and David McGuire make a study? What was the result?
- Mayor: This public hearing is the result.
- Trustee Brown: Most Parks do not allow alcoholic beverages and there is a curfew.
- A. Lawrence: Commented that he would like to go on record as being opposed to drinking in village parks.
- D. Leysath: Commented that he would like to go on record that if the board finds it necessary to pass the resolution, then he would like to go on record as desiring a ban on drinking in all village property (including all village buildings).
- S. Knapp: Feels that there is a need for a playground and one for alcoholic use.
- Debbie Suhr: Feels the Village Park should be for children.
- Valerie Flynn: What Village property is involved.
- Mayor: Re-read the specific areas involved.
- Young Man: How many complaints have been lodged from people regarding others coming down from the hill in a noisy fashion?
- Pamela Lawrence: Commented that Prospect Hill should not have to have a permit.
- B. Watson: Mentioned that other towns have curfews and laws. What's so wrong with this?
- J. Leysath: Voiced her feeling that laws are creeping in to tell us what to do and soon there will be no free choice. She feels that one should be allowed to have an open can.
- Mayor: Commented that it was the feeling of the police department that it is easier to confine people who are drinking in one spot rather than having them all over the village.
- R. Bender: What about the "kid" that might get caught for drinking?
- Attorney Nesbitt: Advised that a person, regardless of age, would be arraigned. It would be up to the justice to set a penalty. There are penalty provisions in the ordinance.
- R. Bender: What is law for public intoxication?
- Attorney Nesbitt: Maximum penalty -- such as 10 days in jail. Depends on offense.
- Trustee McGuire: If someone has an open container in the park, what would happen?
- Attorney Nesbitt: Police would smell of same and take to Newark State Lab for proof.
- Pamela Lawrence: Why do people need public property to hold their parties?
- Mayor: Commented that when large groups such as 200-250 people wish to gether, most families do not have the room.

D. Leysath: Commented that in years past he and his family have gone to Prospect Park to have a box lunch and he, himself, has enjoyed a cold beer while his children had pop. He added that he would like to have the right to use the park and have his can of beer, if he wished.

Adjourn: Mayor Nussbaumer closed the hearing at 7:42 P.M.

Kirchhoff: WHEREAS, Robert Kirchhoff has been tax assessor for the Village of Palmyra for the last seven years, and,
 WHEREAS, Robert Kirchhoff has endeavored to keep the assessment of the Village of Palmyra current with the financial fluctuation of real estate prices and spot checks by the State Board of Equalization and Assessment,
BE IT RESOLVED THAT, the Board of Trustees of the Village of Palmyra acknowledge the efforts of Robert Kirchhoff by a resolution to be a part of these minutes.

Garlock Conf.: Clerk informed the board that she had received a letter from Garlock, Inc., relative to a suggested date of 10/16/72 for a conference to review some of the preliminary aspects of a new contract between the Village of Palmyra and Garlock, Inc. for the supply of water to Garlock prior to the expiration of the present contract which will expire in 1975.

Revenue Sharing Federal: Letter addressed to Mayor Nussbaumer from Governor Rockefeller indicated that the Village of Palmyra will probably receive \$16,830.00 as its share of the federal assistance under the Revenue Sharing Bill. Clerk commented that at the recent conference of Clerks, Treasurers, and other Municipal officials at Kutshers, Monticello, N.Y., John J. Feeney, Deputy Comptroller for the State of New York, indicated that moneys received will be placed in a "trust" fund by the municipality to be disbursed for priority items of public safety, transportation, health, recreation and capital expenditures. There will be a time limit, probably 18 mos. for expending of the funds. October 26th, Mr. Feeney, continued, may be the date set for distribution.

Fire Dept.: A letter received from the Palmyra Fire Department advised that the annual inspection would be October 15, 1972 at 10:00 A.M., followed by church services at the Presbyterian Church at 11:00 A.M. A special brief memorial in memory of past Chiefs James O'Brien and Dewitt Cullip would be observed. Village Board members are invited to be present.
