

Applic. R.Sov- Foreign: Former Policeman Richard Sovereign sent a letter to the Village Board applying for a position on the Police Dept. The board felt at this time that they would not honor his request.

N.Y.State Dept. Pub. Works: Trustee Sinclair informed the board that the New York State Department of Public Works, under the supervision of John Jermano and William Schlee, at the request of Assemblyman Joseph Finley by a call to Albany was able to obtain their services in the clean-up of the Village Park caused by the tornado storm.

Contant Bill: Clerk showed a bill of \$49.50 rendered by Contant & Sons for repair of their roof due to damage by Community Center youngsters prior to the removal of the fire escape. Clerk advised to send bill to Vanden Bout Insurance for payment.

N.Y.S.: Elec. & Gas: The New York State Electric & Gas requested permission to install a gas main on E. Main Street with the notation that it would be replaced as before. (Print #G-3176) Permission granted.

Nursing Home: Trustee Sinclair advised that in discussing the phase of changing the ordinance relative to Nursing Homes, (Zoning Ord.) it was the opinion of the committee that 1,000 square feet per patient should be incorporated. The board was in agreement in this and instructed the clerk to so inform the Village Attorney, Henry B. Nesbitt, to so draw up the notice of a public hearing.

Adjourn: The meeting was adjourned at 10:50 P.M. by Mayor Nussbaumer.

Present: Mayor David Nussbaumer, and Trustees David McGuire, Donald Leysath, Paul Mierke, and Donald Sinclair.

Vouchers: Motion by Trustee McGuire, 2nd by Trustee Leysath and carried to approve payment of the vouchers as presented.

Dog Warden: Alfred Campbell, Kent Street, Dog Warden for the Town of Palmyra, discussed with the Village Board shooting of dogs by the Palmyra Police Department within the village limits. **Comments:** Warden Campbell advised that dogs running at large after sun-down should be kept under control. In addition, he commented, that he was not anxious to pick up dead dogs that had been shot, primarily because it is usually his duty to inform the owner that the dog is dead.

Stop Sign: A. Campbell, Kent Street, also mentioned that he felt it would be apropos to place a Stop Sign from the roadway under the Route #21 bridge which is used by Garlock employees. Kent Street residents find it difficult to enter the highway at times when the Garlock traffic is so heavy.

Blake Duffy: Blake Duffy, 160 Cuyler Street, advised the board that his sewer bill has been increased nearly 40%. The clerk advised **Re: Sew. Bill** that all accounts were reviewed in July at which time, any increases in water consumption for the past four quarters, determined the sewer rate for the ensuing year. Clerk suggested that he talk to the water cashier, Mrs. Kruger, for further explanation.

Tree: B. Duffy further mentioned that a dead tree on the East Jackson side of his property should be removed. He was informed that it was on the list for removal when bids are let. Advised that he had obtained a piece of slate for replacement on

- Slate Walk:** the Cuyler Street side of his property and would appreciate it if the village crews would so install. Trustee McGuire informed him that this would be done within a reasonable time. (Note: Installation was done 9/21/70 at which time Ray Smith, Public Works Forman gouged his left forefinger with a chisel entailing 4 stitches at the Newark Community Hospital.)
- Narcotic Council:** As a member of the Narcotic Council, B. Duffy wondered when a meeting would be called. The board was informed that Ronald Valentine had been appointed Chairman and was his duty to call a meeting.
- Canal Town Days:** Board noted that announcements of Canal Town Days indicated that alcoholic beverages, namely beer, would be had in the Village Park, although the clerk had previously informed the organizers by letter of the ban of any alcoholic beverage on village property for sale.
- Gripe Session:** Mayor Nussbaumer, and Trustees Mierke and Leysath, were present for the "Gripe Session" on Saturday, September 12th, from 10:00 until Noon at which many citizens came forth to offer compliments as well as criticism. Citizens felt the Village departments did an excellent job in the removal of the debris from the Tornado storm on 8/30/70, but felt there were many trees that should be removed, sidewalks repaired along with requests for a noise ordinance in relation to mini-bikes, noise at the Fiddler's Fair and the Palmyra Union Agricultural Fair after reasonable hours.
- Water Meeting: Tn. Brod.** Trustees Mierke and McGuire met with the Town Board on September 10, 1970 to discuss water proposals. No definite arrangements with the town were formed except that it was the suggestion that full boards of both the Town and Village as well as Attorney H.B. Nesbitt, plan to confer on a night other than a board meeting.
- Fire Contract: Tn. of Pal.** Trustees Leysath and Sinclair mentioned that the contract that the Town of Palmyra arranges with the Village of Palmyra will expire on 12/31/70. The consensus of opinion seemed to be that a contract should run for only 2 years instead of five (5) and the contribution or fee for protection should be raised from \$5,000.00 to \$10,000.00 annually. Board asked the trustees to so inform Attorney H.B. Nesbitt of their wishes in the matter for drawing up such a contract for a two (2) year period.
- Raise Fee to \$10,000. (?)**
- Dump:** Clerk was instructed to send a bill to the Town of Palmyra for \$500.00, as previously outlined to the Town, for 1/2 of the cost of bulldozing the dump area in the Town of Palmyra on Garnsey Road to conform to the restriction and specifications by the New York State Department of Health. (Actual cost was \$1,065.00)
- Dump Contract:** Trustees Leysath and Sinclair informed the board that they would discuss the renewal of a dump contract for the Town of Palmyra on a one year basis. The consensus seemed to be the fee should be raised to either \$8,000.00 or \$10,000.00 per year with a \$2,500.00 closing fee, in the event the State Health Department were to close the operation of the dump. A final figure of \$8,000.00 was agreed upon for inclusion in the contract as an annual charge.
- Cable T.V.:** Village Attorney, H.B. Nesbitt, informed the board that Information Transer had signed the contract for a non-exclusive franchise for cable T.V.
- Sales Tax:** Mayor Nussbaumer informed the board that the meeting which he attended along with other mayors in the county at the Board of Supervisors would not bear any fruit as far as the

sales tax to be distributed in the village from the county. However, he commented, the Board of Supervisors are now aware of a County of Mayors association which will be vitally interested in such matters.

Tax Relief Vil.Res.: Village Attorney, H.B.Nesbitt, presented a letter which he had written along with a petition drawn by Attorney Sapienza, in relation to a tax exemption for village residents from the town level. It is apparent, he explained that village residents are being taxed for highway maintenance in the town as well as other departments which should be solely the responsibility of the town.

Force:** A general discussion of inquiries by the board seemed to be that this matter should be tabled for the present, the consensus seeming to be that at present this type of police might cause many problems -- those who wish to assert the flash of a badge, etc., as well as the current criticism directed to the Professional Police Department (not necessarily in our village but in general.)

Meeting:** A meeting will be held on Thursday September 24, 1970 at 2:30 - 5:30 at the Old World Inn, Newark, N.Y. to discuss Wayne County Economic Development. Trustee Mierke and Trustee Sinclair will try to attend. Motion by Trustee Leysath, 2nd by Trustee McGuire and carried for the board to pay for 2 reservations.

Police Report: The Police Report for the month of August, 1970 was read and approved. Motion by Trustee McGuire, 2nd by Trustee Leysath. The report indicated that the total fines and bail forfeitures collected during the month for motor vehicle and criminal offenses totaled \$220.00 while parking meter fines netted the department only \$7.50. Complaints numbering 161 were investigated by the department along with accidents investigated, doors found open, street lights out and assists to outside departments. Criminal matters totaled only 9 but 3 were for public intoxication and of the 17 motor vehicle arrests, 8 were caught in a speed trap.

Workable Program Recertify : Mayor Nussbaumer advised the Village Board that a letter had been received from the Department of Housing & Urban Development recertifying the Village of Palmyra application of a Workable Program for Community Improvement.

Baby Nursery: Mrs. Rosemary Breed called the clerk's office to ascertain if it would be possible for ladies who wish to bowl on Wednesday from 12:45 - 3:00 P.M. to leave their children with a babysitter in the Park & Club Rooms, meeting room approximately 15 pre-school youngsters. Discussion by the board revealed that this would not be possible, primarily because of the liability involved on the part of the village.

Lower Sewer: The owners of Canal Town, at 239 E. Main Street, M.Cornelia Griffin and son, advised by letter that they will no longer be renting the apartment on the second floor of their building. Consequently, a reduction of the sewer rate would be in order.
Motion was made by Trustee Leysath, 2nd by Trustee Mierke and carried to reduce the sewer rate from \$25.92 to \$12.96.

Youth Service Contract: The Community Center Directors had proposed that the Community Center avail itself of additional State Aid in the amount of \$1,000.00 per municipality by applying for Youth Service. The following motion was made by Trustee Sinclair, 2nd by Trustee Mierke and carried:

- B.Wideman: Zon.Offc.** Informed the Village Board that he had compiled some specs for the demolition of the Weykman Bldg., 305 East Main Street, which would be reviewed by Attorney Nesbitt before advertisement in the newspaper.
- Signs:** Zoning Officer Wideman commented that he might suggest some changes in the specifications for the size of signs in the business district in relation to zoning under Section 503.1 D-2. He advised that he would suggest in lieu of 1 sq.ft., the requirement might read 1.5 sq. ft.

- (It is to be noted that the Palmyra Motors, W. Main St., Palmyra, N.Y., did submit a bid but was not received by the clerk's office until Tuesday, September 29, 1970. Their bid was for \$1,950.00. However, it would have had to be rejected, in that it was not signed and there was no non-collusive certificate so attached.)
- 1971 Police Car:** The following motion was made by Trustee Leysath, 2nd by Trustee McGuire and carried:
- RESOLVED:** In that the Village of Palmyra has advertised in the local newspaper for bids for a 1971 Police Car with a trade-in of a 1970 Mercury,
BE IT RESOLVED THAT, the low bid of U.W.Sherburne in the amount of \$1,794.00 be accepted.
- H.VanEtten: Wat.&Sew. Plant Oper.** Hiram Van Etten, Operator of the Water & Sewer Plants informed the board that he had had 2 estimates for the replacement of the roof of the drying beds of the sewer plant which was torn off by the tornado winds the end of August. Estimates from Roch-Kimberly and Stewart & Bennett would indicate that damage was in the \$7,000.00 bracket. Official bids for the replacement will have to be noted with an advertisement in the local newspaper.
- Water Plant:** H. Van Etten commented that he feels that a control valve should be placed in the Water Plant. There is a valve in the Filter Plant but is seldom used except when there is a leak between the Filter Plant and Garlock Factory. However, the valve is so light, it is almost impossible to turn off and needs the strength of 2 men. In addition, at this point, because the valve is so old, there is a possibility it could be broken off if it were necessary to attempt

to turn it. Replacement should be considered, along with a thorough check of the line.

Town Water Contract: Trustee McGuire and H. Van Etten have discussed the Town of Palmyra Water Contract with the Village of Palmyra, many clauses of which should be reviewed when the contract is to be re-drawn next year. A suggested thought - - If the contract were not renewed, the town would have to seek water elsewhere. This would give additional water to the Village of Palmyra for their use.

Vil. Park Stumps: Quotations had been requested for the removal of the stumps left from the cutting down of the trees in the Village Park. Quotations were received from the following:

(Quotation discounted inasmuch as an item was listed for removal of a stump at #415 Stafford Street and could not be figured in with the Park & Club Fund Expenditure.

Empire Tree Surgeons, Newark, N.Y. - - \$12.85 for
each stump - - no stipulated number to be removed.

Reasonable Tree Service, Walworth, N.Y. - - 16 stumps
to be removed for a price of \$195.00.

The Village Board felt that since there seemed to be some question as to the exact number of stumps, new quotations should be requested.

T. Deagman: Water Plant Operator, H. Van Etten, related to the board that Thomas Deagman, Maple Avenue, had removed the water meter from the pipes in his home. Village Attorney, H. B. Nesbitt, informed the board that he would read the ordinance and then discuss the matter with the water committee for the appropriate action to be taken.

Dump Contract: The dump contract to be signed between the Village of Palmyra and the Town of Palmyra for the year 1/1/71 - 12/31/71 was reviewed by the board. On motion by Trustee McGuire, 2nd by Trustee Leysath, and carried, the mayor was empowered to sign the contract in behalf of the Village of Palmyra.

Code of Ethics: A proposed Code of Ethics drawn by Attorney Nesbitt was placed on the desk of the board members and is to be so noted that a public hearing will be held on October 19, 1970 at 7:00 P.M.E.D.S.T. for the edification of all concerned.

Snowmobiles: Attorney Nesbitt read a letter he had written relative to snowmobiles in the village. A letter directed to the board from Edward Dickinson, Birdsall Parkway, was also noted in which he asked for clarification of the law in relation to snowmobiles and the possible places owners could be allowed to use the snowmobile in the village.

Aldrich Drive: An offer of dedication to the proposed street to be known as Aldrich Drive jutting south from West Jackson Street was noted. However, the matter has been tabled for further clarification as to the work yet to be performed by the developer, John Martin.

DOGS: A group of ladies, spokesman for the group, Lois Lynch, Fayette Street, informed the board that they felt proper notification should have been given to the owner of the dog which

was shot a short time ago. Mayor Nussbaumer informed the group that he had asked the Palmyra Police Dept. to give him a list of dog complaints received by the department. Approximately 50 complaints for the last year. A Leash Law might be the answer - - sunset and 1 hour after sunrise a dog must be confined. There is a State Quarantine Law now in existence, which does provide that any peace officer may shoot a dog at any time.

Gripe Session:

The next Gripe Session will be scheduled for October 10, 1970 from 10:00 A.M. to 12:00 Noon.

Village Hyw.Crew:

Trustee Mierke mentioned that Public Works Forman Ray Smith, was reluctant to let George Dennie go, but felt that he was so hard of hearing that he was afraid that he would get hurt on the street. Undoubtedly, is near 70.

Industrial Develop.

Trustee Leysath spoke briefly regarding the meeting in Newark relative to the Industrial Development pointing out that long range plans should be promulgated to entice industry to move in.

Fire Tanker:

Trustee Leysath informed the board that Fire Chief James C. O'Brien is concerned about the New York Fire Underwriters inspection of the village fire fighting equipment, intimating that some action or intent should be shown or evidence relative to the conversion of the tanker. The consensus of the Village Board seems to be that the piece of Equipment which was allowed to be sent to Buffalo for an overall appraisal of possible needed alteration should be immediately returned to the Village of Palmyra premises until such time as the Village of Palmyra has funds to make any needed alterations. Clerk was so instructed to write a letter to Fire Chief O'Brien to this effect. (Letter so written 9/29/70)

Oxygen Squad:

Trustee Leysath informed the board that he had heard via the "grapevine" that the Oxygen Squad had obtained the services of a lawyer and were planning to either branch out on their own or take some further action relative to a new vehicle.

Cemetery Trees:

Caretaker William Kaveny, of the Palmyra Cemetery, advised that there were many limbs hanging and broken too high up for the village crews to reach and would like to obtain the services of tree surgeons for their removal. Board instructed the clerk to ascertain from Kaveny the number of trees and submit a list to the board.

Flu Shots:

Clerk informed the board that during the last few years, the Village Board had sanctioned the expense of flu shots for any village employees who so wished to have the shot. On motion by Trustee Leysath, 2nd by Trustee McGuire and carried, clerk was instructed to make the necessary arrangements for shots with Dr. William Braell.

A.Blair Bill:

Garlock, Inc., Palmyra, N.Y. had previously applied for water and sewer service at the former garage on Fayette Street, but more recently converted to usable space for light manufacture. At the time of application, the usual fee of \$150.00 for water and \$100.00 for sewer were paid, with the stipulation that an additional amount would be billed if it was necessary to obtain the services of other help to install the water line. A bill in the amount of \$457.00 for 8" wet tap and installation of 8" Tapping Sleeve & Valve & Box was received from Alvin Blair, Inc., Rochester, N.Y.

Motion was made by Trustee Sinclair, 2nd by Trustee Leysath, and carried to send the bill in the amount of \$457.00 to Garlock, Inc. for the above mentioned service.

- Village Park Trees:** James R. Hickey Post, #120, Palmyra as well as the Kings Daughters have inquired if they might be of service in getting some new trees planted in the Village Park. Clerk showed the board a clipping from a nursery in Lima, N.Y. who had 25' trees which they would plant in the winter. Clerk was instructed to write to the nursery for a quotation of about 10 trees.
- Night Quarantine on Dogs:** A resolution requesting a Night Quarantine on Dogs by the Wayne County Board of Supervisors was passed to become effective on April 1, 1969 for a period of 2 years, which covers the entire county.
- Steel Flag Pole:** Trustee Mierke advised that John Blazey is working on the flag pole and hopes to have it in place within the next few days.
- Urban Renewal:** A letter addressed to the Honorable Frank Horton, House of Representatives, Washington, D.C. indicated that the Village of Palmyra might qualify for a long term loan to finance construction of needed public works. This pertains to facilities such as water and sewer systems.

Elec. & Gas, commented that he felt the cooperation of our village crews, police, fire, etc., did much in minimising the potential chaos that might have developed.
- Turnkey Raffle:** The James R. Hickey, Post, Palmyra, N.Y., asked permission to use the village barns for their annual turkey raffle on 11/20/70. Board unanimously agreed to allow them to have this time.
- Fire Prevention Week:** The annual Fire Prevention Week is scheduled for October 5th through October 11th. The annual inspection of the Fire Department will be held on Sunday, October 11, 1970 at 9:00 A.M., followed by church services in the Reformed Church. The Village Board is invited to participate in this event of our local Fire Department.
