Bids for contractors will be ready for Jan.-Feby.1960 You can award contracts by March 1960. Propose two contracts dividing village mains so that small bidders can bid and accelerate work. Propose separate bid for disposal plant. Completion for operation by spring 1961.

Propose that village acquire land for disposal site: Lands owned by Thomas Hamilton on Towpath is being p

Lands owned by Thomas Hamilton on Towpath is being partially acquired by N.Y.State Highway Dept. for relocation of the present Canal Bridge to a point east of Dealers Steam Pack. Co. The remaining land of Hamilton should be purchased for site of plant and need 3 to 5 acres.

Request all maps of subdivisions, water mains and services be loaned for map location for contract. That water dept. assist engineers with pipe locater for gas and water services not mapped.

Presented sample of Fairport N.Y. "sewer ordinance" for study by village attorney, as a guide.

Recommend further borings be made in addition to the previous borings to assure contractor that no subsurface rock exists. Suggest another 50 borings-approximately, Sept. or Oct.1959.

Contract or agreement between Engineer and Village for services of engineer should be consumated. Propose a cost plus agreement to revise plans of 1948 since complete new plans are not necessary, but new streets since 1948 must be added and changes for economy of construction need to be done. Based on estimate for sewer mains \$589,000 normal charge would be 4% on estimate or bid price with minimum of \$10,000 and maximum of 4%. Likewise disposal plant cost at 4% maximum. For inspection and engineering service during construction contracts a 2% of the bid price.

Will submit proposal for village attorney in writing for engineers contract subject to approval of Trustees.

Bond anticipation notes will be required to carry on work and cost of engineering prior to bids perhaps to the extent of \$50,000.00

Village will need in addition to engineering service a "clerk of the works" for constant inspection and familiarizing with plans and future operation of the disposal plant, in addition to the 2% engineering and inspection by Woodward & Associates.

Chairman Dickinson:

Eleven members of sewerage commission has dwindled by resignation to eight members. Believe remainder of commission work can be carried out by a maximum of 5 or 6 members. Progress by engineering firm seems to be well underway and plan of proceedure is gratifying to Commission.
