The Mayor requested a moment of silence prior to conducting the business of the Board.

Agenda: The Agenda, as submitted by the Clk., was reviewed by the Mayor who asked if additions - Clk. stated Items "C", "E", "F" & "I" added 6/1/87; Trustee Frontuto moved Bd.'s approval for addition to Agenda; Mayor req. voting upon individually, i.e. - Trustee Vrubel motioned acceptance of "C" (Resol. re Supercollider), Trustee Gilmore seconded. Voting "aye" were Trustees Gilmore, Vrubel & Gilmore. Trustee Frontuto abstained. Carried by majority. "E" (Chf.'s recomm. re new Police Officer), Trustee Gilmore motioned adding to Agenda - Trustee Vrubel seconded. Voting "aye" were Trustees Gilmore, Vrübel, Elliott & Frontuto. Carried. "F" (Schooling/Code Enforce. Officer) -Trustee Vrubel motioned/Trustee Elliott seconded. Voting "aye" were Trustees Vrubel, Elliott, Gilmore & Frontuto. Carried. "I" (Comm./WC Wtr. Supply Agency) - Trustee Gilmore motioned - Trustee Vrubel seconded. Voting "aye" were Trustees Gilmore, Vrubel, Elliott & Frontuto. Carried. 5/18/87

Bd. shld. act upon - over thirty (30) days since public hrng. Atty. Nesbitt changed some wording accord. to Bd.'s wishes. (New Sect. 27-11) - Trustee Elliott so motioned passage & adoption of sd. Loc. Law.; Trustee Frontuto seconded. Voting "aye" were Trustees Elliott, Frontuto, Gilmore & Vrubel. Carried. Trustee Elliott then read new rates frm. text/rate schedule, motioning adoption of rates per fees and changes attached to sd. Law. Trustee Gilmore seconded. Voting "aye" were Trustees Elliott, Gilmore, Frontuto & Vrubel. Carried.

Chf. to assist on 6/5/87 - parking permits 'loose' throughout yr. - why examine one day. Trustee Vrubel felt having Chf. there might slow traffic dwn. somewhat. 

WC ARC Cont'd:

Pro's & Con's of area residents related - Mrs. Mahoney sd. that one individual frm. Williams St. who spke. did not represent whole street - wld. like to get on the Board; Mrs. D. McPike supported proj.; ltr. frm. M. Deys opposed proj. Mayor sd. that Vill. Bd. shld. act.upon/Bd. does not have to accept. Trustee Elliott spke. of sme. area residents having req. that prop. be taken off the market. Pay-ment in lieu of taxes, sq. footage of proposed bldg., insurance, feasibility stdy., long-term contingencies, etc. disc. by Vill. Bd. Trustee Gilmore sd. Bd. cld. accept wth. certain conditions - Bd. agreed that Palmyra 'targeted' for such a grp. home; Mr. Elliott sd. that Bd. wld. have opportunity to exercise sme. control - place in purchase offer and Trustee Frontuto asked how. Mr. Elliott's concern, along wth. area residents, was having qualified people to supervise. Trustee Frontuto had asked them about staffing & they wld. basically be 'aides.' Professional staff wld. be on call. Trustee Frontuto felt the officials had not been completely honest - patients never shld. be placed in a home who are a danger to oneself or others; pt. of Mental Health Law - cld. not back sd. proj. at present time, she sd. Reiterated by Bd. that proj. is a 'pilot proj.' - Bd. mst. decide whether or not to reject P.O. or remove frm. market. Atty. Nesbitt sd. Bd. did not want to be discriminatory - sale to the ARC not in best interest of the Vill. at this time if that is the pleasure of the Bd. ARC cld. submit another P.O., per Atty. Following disc., Trustee Elliott motioned to reject ARC's P.O.; Trustee Frontuto seconded. Voting "nay" on accepting ARC proposal were Trustees Elliott, Frontuto, Gilmore & Vrubel. P.O. officially rejected. Motion carried.
