Special Meeting

September 28, 1981

7:30 p.m.

Present:

Mayor Mary Lou Wilson; Trustees L. Green, M.K. McGrath, and F. Goulden; and Atty. L. J. Poyzer. Absent: Trustee J. DePoint.

Moment of Silence:

Mayor Wilson requested a moment of silence prior to conducting Special Bd. Mtg.

Cable T.V.:

Mayor Wilson stated that the purpose of the Special Bd. Mtg. was to arrive at a decision regarding rate increases, etc. proposed by Cable T.V. Representing Cable T.V. were Mr. Dan Nofs and A. Forand.

At the outset of the discussion, franchise taxes owed the Village were discussed at length. It was stated that 1981-82 taxes had been paid at the previous Bd. Mtg. in the amount of \$760.75, under protest. The 1979-80 taxes were turned over as unpaid to the County. Since the 1977-78 taxes had not been paid, Cable T.V. representatives were asked to explain their position in this regard. Mr. Nofs said that according to their attorneys, Cable T.V. is not liable to pay back taxes under the Real Property Tax Law - taxes were larger than franchise taxes. Atty. Poyzer explained that prior owners, Information Transfer, had gone out of operation under personal bankruptcy - Chapter 11.

Trustee Green felt strongly that back taxes, amounting to over \$1400., should be paid, adding that he did not object to rate increase, however, payment could reduce Village taxes one-fourth of one percent - money could go into General Fund. Trustee McGrath said that the Village would continue to attempt to collect the back taxes even if proposed increases granted Cable T.V. Trustee Goulden cited an example that if he bought a place and taxes weren't paid - he would pay them and try to collect from previous owner. Atty. Poyzer pointed out that the particular section of law is unclear - difference of opinion and interpretation. She spoke of going "backwards" in that '81 taxes are paid; County paid 1979-80; year of 1977-78 remain unpaid.

Mayor Wilson mentioned that 12-yr. Contract will be up for renegotiation in August, 1982. Trustee Green said that his decision would be based on only ten months remaining in Contract - taxes paid under protest, however, rate increase could not be granted under protest. Mr. Nofs stated that Contract amendment had been filed because of increased operating expenses; that Cable would still be working on taxes with Village Attorney and that it was his hope that rate increase would be taken into consideration as a separate issue, emphasizing that his Company had been in operation for 27 yrs. They had been successful, he said, in changing the system and turning it around. Mr. Nofs and Mr. Forand reviewed additional services included in the proposed increase - five additional channels of programming would be available, four of which could be received on new cable-ready sets; or at no extra charge who buy converters; or at \$2.00 month rental for a converter owned by Cable T.V. Cinemax being the fifth channel, would be available for \$9.95 monthly. Monthly rental would jump from \$8.50 to \$9.50 for one outlet - from \$1.00 to \$1.75 for each additional outlet; basic installation \$29.95 up from \$19.95; and relocation of service from \$10.00 to \$15.00.

Following the lengthy discussion, Trustee McGrath motioned that the Board grant the above increases based on the fact that citizens generally wanted the satellite services - and that the Village could continue to pursue tax money owed the Village. Mayor Wilson seconded Mrs. McGrath's motion. A roll call vote was as follows: Trustee Green, "nay"; Trustee McGrath, "aye"; Trustee Goulden, "aye"; and Mayor Wilson, "aye". Motion passed by majority. It was stated that Mr. Forand would meet with Mayor Wilson in the near future to execute documents regarding the Cable T.V. Contract Amendment.

Contracts:

Renovation Village Hall renovation contracts were submitted to the Board and discussion held. Atty. Poyzer said that contracts were the same as appeared in original specs except for an addition to Page 2, Paragraph 2.....a Certificate for Payment has been issued by the Architect, "and final payment has been approved by the VillageBd. of Trustees." The Contract amounts were compared and found to be matching. Trustee McGrath motioned that the Mayor execute the three Contracts; Trustee Green seconded. All voted "aye," motion carried. The Clerk was requested to inform Architect R. Sherman of execution of Contracts. Trustee McGrath emphasized the need for a new boiler and said that the heating contractor is anxious to order same - and that the windows must be special-ordered.

Former "Skorc" Prop.:

Mayor Wilson read a letter from Century 21 Real Estate wherein they stated that a buyer is interested in developing a commercial interest there. Back taxes, shape, etc. of said property was discussed and Mayor Wilson suggested that an appraisal be made of same. Trustee Green felt that three appraisals should be made and the Board unanimously agreed.

Villageowned Lot:

Trustee Green also spoke of Village-owned lot, three lots from Church St., which is covered with pines. No action taken on this matter.

Comm.Ctr. Dedica.:

Mayor Wilson spoke of the grand opening of the Palmyra Community Center on 9/27/81 and the good turn-out of citizens. She added that Congressman Horton was present and how nice a facility the Center is.

Mileage -Cemet. Foreman:

Discussion held on affording mileage to Mr. E. DeMay, Cemetery Foreman. It was agreed by the Board to afford Mr. DeMay retroactive pay for mileage on his personal vehicle, however, since old Highway truck transferred to Cemetery - he should avail himself use of same regarding Village Cemetery business. Trustee Goulden said that he would inform Mr. DeMay of Bd.'s decision. A question arose, also, about Mr. DeMay's salary and was he being paid the amount of prior Foreman.

P.D. Positions vacated:

Mayor Wilson stated that Mr. Walter Metz chose to take a position in Newark for more pay and that Mr. Nicholas Alvaro had decided to return to Florida, thereby creating two Patrolmen's vacancies in the P.D. in addition to existing vacancies.

Pole Barn:

Trustee Green said that he had spoken to Mr. Smith, High. Supt., about the size of a pole barn the Village would need to house its equipment - street sweeper, etc. He added that perhaps the Urban Renewal money referred to at the previous Bd. Mtg. by Mr. Rubery could be used in this regard. The Board generally agreed and Mr. Green said that he would put package together and bid same. Trustee Goulden said that Cemetery equipment would be stored in barn in wintertime, also.

Assessments;

Atty. Poyzer stated that she had appeared in court, this date, regarding the Hopewell tax reduction proceeding.
Hopewell's atty. suggested a meeting among their assessor, supervisor and a Village of Palmyra rep. along with Lozier's Engineers. She asked of the Bd. the authority to talk with Lozier's and request that data be prepared; a suggested meeting date was Oct. 10th or 14th. Mayor Wilson asked that she obtain an estimate for the above services. Mayor Wilson asked about Canandaigua and Atty. Poyzer stated that Canandaigua and Village agreed to share engineer's expenses. Atty. Poyzer spoke of reduction regarding Gorham for current year - unsure of next year.

Adjournment:

There being no more business to come before the Board, Trustee McGrath motioned adjournment at 8:10 p.m. Trustee Green seconded; all voted "aye," motion carried.

Regular Meeting

October 5, 1981

7:00 p.m.

Present:

Mayor Mary Lou Wilson; Trustees Mary Kay McGrath, Fred A. Goulden and Lloyd A. Green; and Atty. Laura Jane Poyzer. Absent: Trustee James I. DePoint.

Call to Order:

Mayor Wilson called the meeting to order at 7:06 p.m. following which she called for a moment of silence.

Committee Reports -

Brickwork -P&C Rms./ Water Pl.:

Trustee McGrath said that \$3,000. had been budgeted for masonry repairs at the water plant and Park & Club Rms. which would involve pointing and brick replacement. She said that she had been advised against sandblasting and read from a Contract received from Genesee Building & Waterproofing Co., Inc., 108 Colvin St., P. O. Box 4339, Rochester, N.Y. 14611, in which two estimates were given - Contract #1 for \$2,550. for the water plant and Contract #2 in the amount of \$2,400. for the Park & Club Rms. She spoke of "freezing" the latter price and placing same in budget for next year.

Following discussion and whether or not the above had to be bid out, Trustee McGrath moved that the Village enter into Contract #1 for \$2,550. for needed brickwork on the water plant; Trustee Goulden seconded, all voted "aye", motion carried.

Village Hall Trustee McGrath stated that a Memo had been sent to all Renovation: Village departments regarding disposing of surplus equipment, etc. stored in the Village Hall and the back garage in preparation of Village Hall renovation. She spoke, personally, with the Fire Dept. in this regard and the Clerk is to contact Historic Palmyra. Discussion held on auctioning off bikes and the necessity of placing a notice in the paper. Mayor Wilson said that Atty. Poyzer was checking on the proper disposition of unclaimed bikes - most of them are already tagged.

Wood Cutting:

Trustee McGrath said that no wood cutting would be permitted on Prospect Hill due to "good" trees having been cut down last year. She spoke of having doad trees "tagged" for cutting and Trustee Goulden volunteered to do same. Mrs. McGrath requested that the Clerk ask the Highway Dept. to place chains across both Prospect Hill entrances - Johnson St. and Spring St.

Pole Barn: Trustee Green stated that he had received from Highway Supt. the size of pole barn needed to store Highway equipment. added that he had layout of same and was asked by the Mayor if the anticipated \$29,000. from Urban Renewal would be enough to cover the cost. Mr. Green felt it would be "close."

9/21/81 & 9/28/81 Minutes:

Mayor Wilson asked for any corrections or additions to 9/21/81, Regular Bd. Mtg. Minutes. When there were none, Trustee Green moved acceptance of same; Trustee McGrath seconded all voted "aye," motion carried.

When there were no corrections or additions to Special Bd. Mt. Minutes of 9/28/81, Trustee McGrath motioned their acceptance; Trustee Goulden seconded. All voted "aye," motion carried.

Injury to Patrolman Trowbridge:

Mayor Wilson spoke of the serious hit-and-run automobile accident on 10/2/81 at 10:20 p.m. in which Patrolman Fred Trowbridge was seriously injured. She said that she had spoken with Patrolman Trowbridge's mother earlier in the evening and that a pin had been placed in his leg, 6" above the knee and that he is in traction. If traction is successful, he may not have to have his hip operated on. It is anticipated that he will be in traction for three to four months and on crutches for, possibly, as long a time. The Mayor said that she hoped the hit-and-run driver would soon be apprehended and appropriate action taken against him. She said in answer to many questions about the accident, the following statement was given by Mr. Ray Smith, Highway Supt., in conjunction with the Board:

Highway
Supt.'s
Statement:

"Four houses on the south side of East Main Street were serviced for years by small, 1 1/4" water pipes. This inadequate piping could not accommodate these houses and additionally, the pipe had deteriorated over the years thereby necessitating replacement.

In addition to digging around the respective private properties of the above-mentioned houses, permission was sought and obtained from the N.Y. State Department of Transportation to break the surface of East Main Street to accomplish the needed water line work. Within the past year, the street surface was broken three times - the last of which was last week - in an effort to complete the needed work before the onset of cold weather. kThe water line lay below several surfaces of black-topping, concrete and between the old trolley tracks—a difficult and time—consuming maneuver to penetrate, especially on such a heavily traveled highway. The barricades and warning lights were the same as those used in previous repair work, the poor visibility due to the rain notwithstanding.

Except for filling in four more inches of wet concrete and blacktopping the above work was completed, however, with the recent rains it was impossible to cover the wet surface with hot tar. The project was postponed until the rains subsided and the street was dry. This project has now been completed. The Village of Palmyra apologizes for the inconvenience caused travelers - and is especially sorry about the incident on Friday night, October 2, 1981, in which Officer Fred Trowbridge was severely injured."

P.D.Schedule: Mayor Wilson read a new Police Department schedule which included, she said, Capt. Elmer Kniest of the Auxiliary P.D. being scheduled for day-time clerk-work. She said that Jay Orlopp had been recalled on a temporary basis.

Fire
Dept.
Inspec.:

Mayor Wilson stated that Trustees McGrath and Goulden and herself attended Annual Inspection at the Firehouse at 9:00 a.m. on Sunday, 10/4/81, following which they attended church services with the Firemen. She spoke of "Open House" in the afternoon which featured displays, etc.

Former "Skorc" Prop.: Disposition of the former Skorc property was discussed and the need for appraisals of same.

Handicapped Pkg.: Discussion held on parking for the handicapped and Mayor Wilson said that it might as well all be done at once for which a public hearing would be needed regarding the Ordinance. Mrs. Millie Lynch asked about handicapped parking at banks and it was stated that this would be up to respective banks.

Police Personn.:

Mrs. Elaine Hartnagel spoke of the need for extra Police officers and suggested that Mr. Richard Baker be interviewed. Mayor Wilson said that an interview would be in order upon the return of Mr. DePoint, the Police Commissioner.

Mr. J. Elliott questioned why Patrolman Jay Orlopp had been recalled - that the Bd. had said under no circumstances could he return to work since he had served two six months' periods - he is not eligible to work any longer. Mayor Wilson said that she had spoken with Civil Service regarding this matter and Mr. Orlopp could serve on an emergency basis - he had not been a Patrolman for two six months' periods, his last tenure having been two and one-half months. She emphasized that he would be in Village's employ for month of October only and that Mr. Orlopp's age exceeds C.S. limitation of 29 years.

Citizen Eggert: Mrs. Esther Eggert questioned the Board regarding the water line work on E. Main St. where Friday night's accident happened and spoke of how quickly the street was repaired once the accident occurred. Trustee Green spoke of concrete having been poured on Friday - could not place cold patch on top of wet concrete and that he was unsure if highway crews had planned to finish the work on Saturday morning. He said that identical work had been done twice during the past year and there had been no problems. It was stated that the poor visibility on Friday night was due to the rain.

P.E.D.C.:

A representative from the Palmyra Economic Development Corporation did not appear after requesting placement on the Agenda.

Jaycees:

Representing the Jaycees, Mr. Dan LaFica approached the Board regarding the use of the upstairs room of the Village Hall for a Jaycee-sponsored "Haunted House" for the dates of 10/28/81-11/1/81, the proceeds of which would go toward the greenhouse at the high school. Discussion held on the safety factors and Trustee McGrath said that she had requested the Fire Dept. to bring a piece of equipment, in case of emergency. Mr. LaFica said that this activity would be for children 12 yrs. of age and under - and that pathway/tours would be guided. He added that the Jaycees have the manpower to manage the activity and would clean up afterwards. It was brought out that it would cost approximately \$32. to have the electricity turned on and off. Trustee Green felt the greenhouse a worthwhile project and offered to pay the \$32. if the Village did not. The question of insurance came up and Mayor Wilson said that there was insurance coverage. The Board agreed to the use of the Village Hall second floor for the above purpose and Mayor Wilson cautioned the Jaycees about any unnecessary noise in their use of upstairs Park & Club Rms. as a meeting place.

Voucher Approval:

Adjournment:

There being no more business to come before the Board, Trustee McGrath motioned approving voucher amounts of \$10,619.67; Trustee Green seconded - all voted "aye", motion carried; following which Trustee Green moved adjournment at 7:45 p.m. Trustee Goulden seconded, all voted "aye," motion carried.

Moment of Silence :

Mayor Wilson requested a moment of silence prior to conducting business of the Board.

10/5 & 10/13/82 Minutes:

Approval - Mayor Wilson asked if there were any corrections or additions to 10/5/81 Bd. Minutes. When there were none, Trustee DePoint moved that the Minutes be approved as read. Trustee McGrant seconded, all voted "aye," motion carried.

> When there were no corrections or additions to the Minutes of the Special Bd. Mtg. held on 10/13/81, Trustee McGrath moved their acceptance. Trustee DePoint seconded, all voted "aye," motion carried.

Acting P.D. Chief:

Trustee DePoint stated that he had met with the Acting Police Chief, in his capacity as Police Commissioner, with other meetings in the offing. He spoke of reviewing personnel from the Civil Service List and internal changes which are needed.

Mr. DePoint mentioned his response to recent letter which appeared in Courier-Journal regarding P.D. salary increases. He said that it was unfounded that he is "against" increases that Village is bound by CSEA Contract which runs until 6/1/83. A short discussion was held on the "differential" payment.

Cemetery Foreman:

Trustee Goulden said that Foreman DeMay requested the mere sum of \$5.00 every two weeks for mileage allowance. Trustee DePoint questioned the legality of this stipend, however, following a short discussion, Trustee Goulden moved that an amount of \$5.00 be added to Mr. DeMay's pay each two weeks per month for mileage; Trustee McGrath seconded. All voted "aye," motion carried.

Mr. Goulden spoke of a small accident to Cemetery tractor and that a young employee was at fault and would pay for the damage.

Village Hall Renovation:

Trustee McGrath stated that she would be meeting with the three contractors who were awarded renovation bids on Tuesday a.m. She recommended to the Board that Clerk's Office, Police Department and Courtrooms be moved to Park & Club Rooms due to extensive Village Hall renovation and the condition of the old boiler. She explained the necessity of the move and gave quotes on installation of the phone & radio system. The Village crews would move the equipment and furniture, she said. Mrs. Rutledge asked how long a time the departments would remain in the P&C Rms. and was told "approximately six months."

Following a lengthy discussion, Trustee McGrath moved that the Village Office, Police Department & Court be moved across the street for the interim; Trustee DePoint seconded. All voted "aye," motion carried. The remainder of the P&C Rms. would be used for storage if Courtroom to be elsewhere.

Trustee McGrath spoke of liquidation of Newark's C. H. Stuart and the possibility of obtaining needed equipment and/ or furniture. Trustee DePoint said that he had an appointment for the following day regarding same.

Fire Contract:

Trustee McGrath said that notification of a hike in the Fire Contract between the Village of Palmyra and the Town of Manchester had been sent and that acceptance had not been received from them. Town Fire Contract:

Mrs. McGrath spoke of the Town of Palmyra budget and the cost regarding their Contract with Village, which will be re-negotiated at a higher rate. Discussion held on prorating Town charges, i.e. use of Courtroom, etc.

Trustee DePoint suggested that the Village Clerk notify Park & Club by phone the organizations presently using the P&C Rms. of Rooms: the Village's need for them - and to confirm the phone call by letter. Suggestions for their use were - churches, Community Center, schools and the Firehouse.

Bid Opening: Mayor Wilson said that bids for repair to the Village Hall roof and overhang would be received at 11:00 a.m. on 10/29/81.

Snow Removal Ord.:

Mayor Wilson read from the "Snow Removal Ordinance" and said that no parking would be allowed on Village streets between 2:00 & 7:00 a.m. from 11/1/81 to 4/1/82. Trustee DePoint moved that a notice of same appear in newspaper & Timesaver; Trustee McGrath seconded. All voted "aye," motion carried. Mrs. M. Lawrence asked about designated fine and was told by Trustee Goulden that fine is \$5.00.

P.E.D.C.:

Mayor Wilson read from a communication from the Palmyra Economic Development Corporation President, Mr. Richardson, in which they requested funds toward their operation from the Urban Renewal monies slated to be returned to the Village, in some form or other.

Another communication from P.E.D.C. was read by Mayor Wilson in which an invitation was extended to attend "Open House" at Proven Designs - a new business which is operating in the old "Dealer" Factory Bldg. The date for O.H. is 11/11/81.

Pole Barn:

Discussion on a new pole barn to complement the Highway Barn on Division St. was not taken up due to Trustee Green's absence.

Resol. #81-25:

Trustee DePoint moved that Resolution #81-25 be adopted wherein the Village requests the collection of delinquent Village taxes be accomplished by the County - this process having been handled previously in February each year. Trustee McGrath seconded adoption of Resolution #81-25, all voted "aye," and announcement made that said Resolution unanimously adopted. Resolution #81-25 attached hereto.

Master Meters: Trustee DePoint said that a letter was recently sent to Town Board pursuant to agreement concerning north & south master meters. Village bills Town for water and two master meters have not been operational. He said that Town had previously agreed to put meters in proper order and functioning.

Town Items 3 & 4:

Discussion held on petitioning the Town for exemption of Highway Items 3 & 4, as authorized by Section #277 of the Highway Law. Mayor Wilson stated that Town, in the past, has exempted the Village for Item 3 (purchase, repair and custody of highway machinery, tools and implements), however, Town has maintained Item 4 (removal of snow, cutting of brush and other miscellaneous items relating to Town highways). She added that this petition must be done annually and that some Towns in N. Y. State do allow both exemptions. Trustee DePoint moved that the Town be petitioned; Trustee McGrath seconded. All voted "aye," motion carried.

Surplus Equip .:

A short discussion was held on surplus, some inoperable Village equipment, and tagged bicycles and the need to advertise same prior to auction. Atty. Poyzer was requested to look into the legalities of same.

Substitute Sch. Cross. Guard:

Discussion was held on a request from School Crossing Guards regarding a substitute. It was stated that a substitute was needed recently and that regular guard had paid her as opposed to going through Village books. No action taken on this matter until some research could be done.

Minutes:

Mrs. E. Eggert stated her desire to receive Bd. Mtg. Minutes and requested that they be read at meeting for anyone interested. Mayor Wilson said that extra copies could be made and placed on Trustees' table for interested parties to look

vice Age Limit:

Civil Ser- Mrs. J. Rutledge questioned the age limit of 29 yrs. for Patrolmen and was told by Mayor Wilson that a Bill is presently in the Legislature to eliminate age requirement, citing Jay Orlopp as an example. A short discussion was held on announcement of positions and postings re Equal Opportunity Employer, etc. Management does not have to follow this procedure.

Chief Henry:

Questions were asked about should Chief Henry win the case where would \$20,000. come from - and should he remain, would he continue to get \$21,000., also, would his salary be increased. Mayor Wilson said that Bd. would have to wait and see. Ms. C. Hall questioned the hiring of an Acting Chief eight days before Chief Henry's Hearing and it was stated that it would be some time before a decision from said Hearing. Former Patrolman, R. Mingo, raised a question and was told by the Mayor that the Village was in litigation with him and she could not respond to his questions.

Atty. Spitz' Fees:

Mrs. E. Hartnagel said that she had received a statement of legal fees from Atty. Spitz and the figures she had compiled from office vouchers showed a discrepancy of approx. \$16,000. Mayor Wilson suggested that Mrs. Hartnagel meet the Village Treasurer sometime regarding these charges.

Citizen

Mrs. Hartnagel asked why Trustee Green walked out of last Hartnagel: meeting and why he was not in attendance presently. Mayor Wilson said that he came prior to Special Bd. Mtg. on 10/13/81 and she was not sure why he was not present. Mrs. Hartnagel read from a statement prepared by the Concerned Citizens' Committee and submitted petitions to the Board containing 524 signatures on which a demand was made for the Mayor and Trustees to resign immediately. She stated that several citizens did not sign as they did not want their names to be seen by the Board.

Salzburg Sign:

Mrs. C. Hall reiterated her request for a sign announcing the approach to Salzburg Village and a short discussion held. Trustee Goulden felt it a legitimate request and those present were informed by the Mayor that a request had been made to a Patrolman to check out the need for same. The Clerk had made such a request to Patrolman Trowbridge who felt there was no need for same.

Acting Chief's Avail.:

The Treasurer said that she was waiting for doctor's report, following which he would receive two-thirds of his salary for as long a time as he was disabled, adding that this comes under Wayne County Self-Insurance Plan to which the Village subscribes. One resident wanted to know about the other one-third of Mr. Trowbridge's salary.

Bids:

Mrs. G. MacGuidwin asked about "dollar amount" for Village bids and was told the limit was \$3,500. for equipment, etc. and \$4,000. for streets, etc. Atty. Poyzer said that this is controlled by Municipal Law.

Voucher Approv.: Approval for voucher payments in the amount of \$18,942.36 was motioned by Trustee McGrath; Trustee Goulden seconded.

All voted "aye," motion carried.

Terms:

Mrs. M. Lawrence wanted to know how it was decided that Bd. members serve a four-year term and was told by Mayor Wilson that this occurred following a public hearing approx. ten years ago. She added that Trustee Green and Trustee Goulden's terms will be up in March, 1982.

Sign:

Mr. P. Buck felt sign to Salzburg would be beneficial if it prevented an accident and wondered why Police had to review. Mrs. Lawrence said that 30-mile speed limit was not enforced.

Adjournment:

At 8:06 p.m., Trustee McGrath motioned adjournment; Trustee Goulden seconded. All voted "aye," motion carried.

Moment of Silence:

Mayor Wilson requested a moment of silence prior to conducting business of the Board.

Minutes
Approv.
10/19/81:

Mayor Wilson questioned if there were additions or corrections to the regular Board Mtg. Minutes of 10/19/81. When there were none, Trustee McGrath moved acceptance; Trustee Goulden seconded, all voted "aye," motion carried.

Moving Village Offices, etc.: Mayor Wilson apologized for the inconvenience to citizens regarding the Village's takeover of Park & Club Rms. for Office, P9lice Dept. & Courtrooms, however, she explained that contractors had felt in the beginning that they could work around the offices but found out they could not. She thanked those involved, especially the Highway Dept., for their assistance in the move.

Mayor Wilson explained the 'ground rules' for placement on the Board Agenda, i.e. except in cases of emergency, requests should be made by noon of the previous Friday. She stated that this had not been strictly adhered to in recent months and that the Board had received criticism in this regard.

Mrs. L. Lynch said that if a citizen desires to ask a question of the Board, one would not know on the previous Friday. Mayor Wilson agreed that if it is a question of concern, same would be allowed.

Mayor Answers Petitions: Mayor Wilson, regarding the petitions submitted by the Concerned Citizens at 10/19/81 Bd. Mtg., said that 524 signatures were an impressive number of citizens asking for the Board's resignations, however, she said that 512 seemed to be legal Village residents - only 83 of whom had voted in 1981 - 53 in 1980, etc. She added that the citizen who had presented the petitions had not, in fact, voted since 1978. She stated that she had no intention of resigning and upon polling the Trustees, their replies were as follows: Trustee Goulden - "No"; Trustee McGrath - "No"; Trustee Deroint - "no"; and Trustee Green, who stated that his term is up in March, 1982, said he would remain if he could stop the Board from making another mistake.

Citizen Elaine Hartnagel related votes cast in March, 1980, Village Election comparing number of votes for Mayor, Trustees, etc. to number of names on Concerned Citizens' petitions.

Mrs. M. Lynch spoke of Chief Henry and her feelings for the Chief and the Mayor - and that it was not a personal thing (petitions), citing the seriousness of the Henry matter.
