Mr. Dalton to elaborate upon FBI School, which he read from brochure. He felt he'd like to attend; would be asset to Palmyra - make him better qualified to perform his duties. Trustee DePoint arrived at 8:15 p.m. and became pt. of discussion. He said that Mr. Dalton is P.D.'s Chief Investigator".
