

WHEREAS, traffic conditions during a part of the year are rendered dangerous due to snow storms, etc., and the parking of vehicles on the public streets impedes and delays the plowing and removal of snow therefrom, and efforts to have owners of such vehicles keep same off the streets having failed, now to provide for a more orderly and safe movement of traffic at all times, be it

RESOLVED by the Board of Trustees of the Village of Palmyra, Wayne County, New York, pursuant to the authority granted to said Board of Trustees by the Charter of said Village of Palmyra, and pursuant to the applicable statutes of the State of New York, that the following ORDINANCE be and the same hereby is adopted and duly enacted this 2nd day of December, 1952, with the following title:

ORDINANCE re: <u>Stop Streets, All Night Parking and</u> <u>Removal of Vehicles Parked or Abandoned</u> <u>During Snow Storms or Other Emergencies.</u>

<u>Section 1.</u> <u>Definitions</u>. The words and terms used in this ordinance unless otherwise expressly stated, or unless the context or subject matter otherwise requires, shall have the same meaning as defined in the Vehicle and Traffic Law of the State of New York.

Section 2. Prohibition of All Night Parking. No vehicle shall be parked on any public highway within the corporate limits of the Village of Palmyra between the hours of 1 A. M. and 7 A. M. during the period beginning November 1st and ending March 31st of each year.

Section 3. Removal of Vehicles in Emergency. When any vehicle is parked or abandoned on any public highway within the Village of Palmyra during a snow storm, flood, serious fire or other extreme public emergency which affects that portion of the public highway upon which said vehicle is parked or abandoned, said vehicle may be removed by or under the direction of any member of the Police Department of the Village of Palmyra who shall be on active duty. A special meeting of the Village Board called by President Weldon Shepard and held in the Trustees Room Village Hall, Tuesday December 9th, 1952 at 7:30 P.M. Present: Mr. Weldon W. Shepard, President, Mr. Donald A. Dohse, Mr. James R. Webster, Mr. George W. Contant and Mr. Russell H. Fisk, Trustees.

The purpose of the meeting was to endeavor to arrive at a definite understanding with Mr. Edwin P. Hoskins, Patrolman in charge of the Police Department regarding the activities and operation of said department. Mr. Hoskins was advised of various reports and complaints which have reached the Board and also the attitude of the Board regarding these complaints. Mr. Hoskins was instructed to take up the various matters with all members of the police department and to take immediate steps to see that all rules and regulations set up by the Board, be complies with in the future.

No further business appearing the minutes were read and on motion by Mr. Fisk, seconded by Mr. Contant same were approved.
