Mayor Elliott requested that a moment of silence be observed prior to conducting Village business.

Triou Est.: Mayor

Elliott opened the advertised hearing regarding dedication of Dar-Lind Lane - the approach to the Triou Sub-Division off Canandaigua St./Rd. requesting the Clerk to read the Legal Notice; Mrs. Theresa Otte, 350 Canandaigua St. addressed the VB in relation to street dedication...she asked how many homes proposed to be built and told by the Mayor "23." She asked when contractor put in the Mayor "23." She asked when contractor put in the street, did they provide for 23 laterals for sewer lines so easier for Village crews to make repairs, have to be torn up, repaved, etc...the Mayor answered in the affirmative. Mrs. Otte then asked what steps were taken to ensure that the sewer lines have no cracks, citing example of Salzburg Village (Laurentian Drive) which were not acceptable to the VOP. Mayor said they were all 'lamped'; W&WW Supt. H. Kruger sd. that strong/bright lamps used to look through main...from manhole to manhole. Mrs. Otte asked if pictures taken and informed that Engineer D. Means did not but they were pressuretested ... lines held pressure put on the main. Can't ensure 'forever'....process done 3-4 mos. ago.

Mrs. E. Hartnage asked re 'access' road...had it been brought up to specs at present...the Mayor sd. not an access road and explained the process the Bd. required prior to dedication. Mrs. Hartnage asked about meeting specs...had Village Foreman accepted same...value of Engineer's rpt. as well as Hwy. Supt.

Hwy. Supt. Retan spke. of Minutes in which he sd. the Bd. stated street wld. not be accepted until two (2) yrs. after completed. Trustee Pope spke. of two-yr. bond...Mayor sd. two-yr. Performance Bond. Atty. Paul Rubery sd. that Mr. Means recommended \$20,000. bond...VB recommended \$50,000. - no need for Maintenance Bond if not accepted for dedication. Trustee Pope asked if ltr. sent to Mr. D. Triou and told "Yes" by Mayor. Atty. Rubery sd. couldn't obtain Maintenance Bond until accepted for dedication. Marine Midland processing it, he sd. Time begins when accepted - couldn't post until known if road has been accepted..then "Letter of Credit." Offer of Dedication - deed - easements taken care of per the Mayor. Mr. Rubery spke. of recreation and park area...Mayor sd. five per cent (5%) of Mr. T's purchase price of land. Atty. Nesbitt asked if any encumbrances on the rd. and told "No" by Atty. Rubery. Mayor Elliott suggested amt. of \$1,000. for wk. on Foster St. be retained frm. payment. (Trustee Gilmore arrived @ approx. 7:15 p.m.). Atty. Rubery spke. of cash amt. of \$1,000. & released when repairs done.

P. Retan asked about sidewlk. completion along Route #21 and informed May-June...they wld. be in contact wth. him to see what required. Trustee Pope sd. it must be dry before putting in sidewlks.

Mayor Elliott asked for further comments or questions; Trustee Gilmore asked if VOP had anything

frm. Engineer Means, or his office, about the subject street and informed by the Mayor that the final inspection rpt. received previously...1/3/89, to be exact, per Trustee Pope. Trustee Gilmore asked about #3 of rpt. (near bottom) regarding.... construction...and what considered 'normal traffic'. Trustee Pope sd. that all types of trucks go up and down streets all the time in VOP....weight of trucks compared to snowplow..P. Retan sd. 36-40 thou. wth. load of salt....16,000 empty. Mr. D. Matthews spke. of maximum loads.

Mrs. Hartnagle asked if road destroyed, where does VOP stand...informed by Mayor Elliott & Trustee Pope that is the reason for Bond...Trustee Pope felt better to accept now than wait until construction finished. Atty. Rubery agreed. Trustee Gilmore commented...he'd rather it would break up before...if not VOP's, wouldn't make much difference. P. Retan sd. it doesn't take long to 'eat up' \$50,000. Trustee Gilmore was recalling something about last August...something about waiting for street dedication to which Trustee Pope sd. it had to do wth. 15th of Oct....Mayor Elliott sd. Bd. had lot of discussion but didn't believe a formal resolution. Trustee Gilmore sd. he'd rather see it go so VOP wouldn't have to worry about it. The Mayor sd. that after acceptance, VOP has direct control over quality of repair work. Mrs. Hartnagle asked what if beyond \$50,000. and told by Mayor that it would then be the VOP's responsibility...no road in VOP that 'goes on' forever. Atty. Rubery spke. of 'an addition'...would be repaired. A liability, per Trustee Pope.

At 7:25 p.m., when there were no further questions and/or comments, Mayor Elliott declared the public hearing closed.

Trustee Pope moved...effective March 15, 1989, subject to the \$50,000. Letter of Credit for two yrs....\$1,000. cash deposit toward repair of East Foster St.;\$4,000. in lieu of parkland. Trustee Frontuto seconded. Voting "aye" were Trustees Pope, Frontuto & Mayor Elliott. Trustee Gilmore voted "Nay." Carried by majority.

Assessor Roney:

Assessor Roney thanked the Bd. for nine (9) years of their cooperation and for the opportunity to serve the VOP...as VOP appointments occur in April, he wanted to inform the Bd. that he wld. be 69 yrs. of age and wld. be retiring at the end of September, 1989. He spke. of VOP options - cease being an assessing unit; appoint Clerk to take over assessment function of signing papers, and the VB cld. appoint Assessor Roney for one yr. as in the past. He explained what wld. occur if the VOP ceases to be an assessing unit..he spke. of prior VOP employee appointed approx. ten yrs. ago to handle paperwork, however, it didn't work out..then Mr. R. Schwing appointed for one yr. until TOP mde. decision as to which direction they wld. go. Discussion on how much time wld. be spent in VOP - ea. mo., per Mr. Roney...creating tax roll, process new construction...deaths (sen.cit.) - remove frm. tax roll..TOP to make a re-evaluation update.

Trustee Frontuto asked if he had any knowledge of direction TOP to go and Mr. Roney indicated he had none. No action taken by VB during mtg.

Trustee Frontuto:

Trustee Frontuto C&P Supt.'s report in which it was stated the \$1200. salary shortfall due to overtime hrs. not being budgeted. She attended Bicentennial Commission meeting recently; ltr. to VB rec'd frm. Mrs. Marilyn Dahneke in which she requested use of the Vill. Prk. @ 7:00 p.m. on 7/8/89 for a Talent Show, sponsored by the Mormon Church. Trustee Frontuto so moved; Trustee Gilmore seconded. Voting "aye" were Trustees Frontuto, Gilmore & Pope & Mayor Elliott. Carried. Trustee Frontuto requested the Central Office to communicate wth. ASCAP again re Vill. Pk. concert contracts. The Antique Car Show, to be held in the Park on Sun., 8/13/89, looking for local organization to handle food booth - Clerk to check wth. Civic Club. She said fireworks display to be held on 7/3/89 (actual Bicentennial date), however, no site established as yet.

Mrs. Frontuto spke. of NYCOM attendance wth. Mayor Elliott prior week which was interesting and in which they were able to "lobby" - State Legislators were in attendance...of interest was Gov. Cuomo's proposed budget. She thanked the Bd. for opportunity to attend. She touched briefly upon the "Real Estate Transfer Tax" which the Bd. shld. look at.

Cable supposed to give VOP 36 mo. notice of intent to renew - State Law. VOP can negotiate - Clyde, Lyons & Newark are jointly working wth. the company...projections - all municipalities band together to come up wth. new cost for Franchise - better for municipalities..wld. be collecting monies that shld. be due VOP....with more knowledge, better able to negotiate. Cable paying VOP just base rate...basic subscriber service is \$18.75....if additional programs (Disney, etc.) - additional outlets, VOP not getting anything frm. them. Sales program out of Fla....corporation owner receives five percent (5%) off the top. VOP does not see three percent (5%)...will pay the VOP to research more...will cost approx. \$5,000., however, wld. pay off in year or so. Trustee Pope asked further and told UNICOM (Larry Monroe) operates the above.

W&WW:

Mayor sd. he had rec'd communication frm. Dept. of Health - VOP must come up wth. written "Water Emergency Plan" due to drought conditions.
