Noment of Silence - The Mayor requested a moment of silence () prior to conducting the business of the Board. 12/15/86 Ninutes - Trustee Frontuto moved acceptance as written; seconded by Trustee Vrubel. Voting "aye" were Trustees Frontuto, Vrubel, Elliott & Gilmore. Carried. 1/5/87 Minutes - Trustee Frontuto moved their acceptance as written; Trustee Vrubel seconded. Voting "aye" were Trustees Frontuto, Vrubel, Elliott & Gilmore. Carried. Amended by Trustee Frontuto, seconded by Trustee Vrubel to include omission by Clk. that Bd. approved 11/3/86 Bd. Mtg. Ninutes during 12/15/86 Bd. Mtg. All "ayes", carried.

Committee Reports -, Trustee Elliott sd. that public hearing re re-zoning of 505 W. Main St. (J. Provoost-Mayo) established for 2/16/87 @ 12/15/86 Bd. Mtg.; chnge. to date of 2/17/87 as Office closed on 2/16/87 for "Presidents' Day". Trustee Elliott so moved sd. chnge. in date; Trustee Frontuto seconded. Voting "aye" were Trustees Elliott, Frontuto, Gilmore & Vrubel. Carried. Mr. Elliott sd. letter rec'd frm. Engineer D. Means re proposed construction/Park Hill - avoid 'lagoon' if possible; should be drained off; situations have occurred where problems have come back to municipalities who have to maintain lagoons. Bd. disc. Mayor mentioned curbs/sidewalks in area, citing Stafford St., Laurentian Dr., Aldrich Dr., etc. - Vill. could require developer put in curbs and sidewalks. Pk. Trustee Elliott spke. of State Preservation Bd. calling which he will handle; disc. on old water treatmnt. plnt. on Prosp. Hill. Dangerous/J. Hollingsworth to give Vill. est. for demolishing same. Method disc., i.e. push in, cover wth. surrounding dirt. Permits & fees (\$200.) re Sewer Ord. & hooking up to sanitary sewer disc. Vill. loses money on same....rewriting Ord./perhaps a permit fee pd. when applic. filed - money put into Sewer Fnd. or St. Repair Fnd. (in addition to connection fee chg. which wld. follow); Trustee Elliott proposed \$500. for sewer permit/\$200. storm sewers/\$500. for all other structures!
