## **TRUSTEE REPORTS**

**Trustee Husk** asked if the Workplace Violence Training is mandatory for all employees. The Clerk Treasurer will check with DOL. He plans on attending either way.

**Trustee Luke** reported that there were a total of nine vendors at the Community Garage Sale; the food vendor said there was a steady flow of customers and they are interested in coming back to do the fall sale. Performance agreements have been sent out for the summer concert series. Trustee Luke spoke to Bill Campbell about moving the clothing donation box that is in their parking lot; they would prefer not to move it but suggested that they would block access to the back. There is a problem with that arrangement as the homeowners on Claremont are responsible for mowing the grass on that side of the fence and by blocking it off, the homeowner will not be able to mow. Trustee Luke will go back to discuss with the Bill Campbell.

The Village has scheduled a jazz performer in the park during the same weekend as the Gus Macker Tournament. Tournament organizer Vicky Record wondered if the Village would consider moving her performance to the Fairgrounds. After discussion, it was agreed that the performance is better off left in the park.

**Trustee Nolan** reviewed the monthly operational report for the water and wastewater treatment plants. The report will be on file in the office of the Clerk Treasurer.

Trustee Perry – no report.

Attorney Williams - no report.

**Mayor Piccola** reviewed the report from Hwy. Supt. Boesel highlighting that the Municipal Auction broke another record with \$4.9 million in sales. The larger pieces of Village equipment sold as follows:

Caterpillar quick coupler forks \$ 4,000.00 2012 Bobcat E42 mini excavator \$44,000.00 2012 Bobcat 48" ditching bucket \$ 3,000.00

The proceeds of these pieces of equipment will offset the cost of the new equipment already purchased.

The Phase II Archeological Study on the Park Drive property will be done next week; the village will be doing the excavating.
