NOTICE IS HEREBY GIVEN, that there has been introduced before the Village of Palmyra a proposed local law, known as Local Law #1. 2019, which, if adopted would amend Chapters 144 "Sewer Rents and Charges" and Chapter 147 "Sewer Use" of the Village Code. The local law adds an explanation of the term "EDU" for the future Regional Wastewater Treatment Plant.

NOTICE IS FURTHER HEREBY GIVEN that, pursuant to section 20 of the Municipal Home Rule Law, the Village Board will hold a public hearing on the 7th day October, 2019 at the Palmyra Village Hall, 144 East Main Street, Palmyra, NY beginning at 6:30 p.m. for the purpose of hearing comments for or against the adoption of the proposed local law.

RESOLUTION – PUBLIC HEARING ON LOCAL LAW #1 2019: Motion was

made by Trustee Perry, second by Trustee Warters to adopt Local Law #1, 2019 which will amend Chapter 144 of the Village Code. Vote, 3 ayes. CARRIED.

(Local Law #2, amending Chapter 147 of the Village Code needs to be addressed at the October 21 meeting as per Attorney Williams as there will be changes to two chapters of the code; there is no need for another public hearing)

TRUSTEE REPORTS

Trustee Nolan shared the monthly operating report for September for the water and wastewater treatment plant which will remain on file in the Village office. **Trustee Perry** – no report.

Trustee Warters shared the fire department's report for September calls and truck inspections. Motion was made by Trustee Warters, second by Trustee Perry to accept Richard Townsend for membership into the Fire Department following completion of the appropriate training and a satisfactory physical examination. Vote, 3 ayes, CARRIED.

Attorney Williams – no report.

Mayor Husk reported that the time has not been confirmed yet but it looks like Oct, 28th will be the meeting date for a financial meeting to discuss and review the project time frame and the debt service payment schedule for the RWWTP.

Macedon, Palmyra, Walworth and Marion are joining forces to create a new Chamber of Commerce; the kick-off event is November 4th.

Mayor Husk urged the Board members to read through the amended Reserve policy so that it may be discussed at the Oct. 21st meeting.

Trustee Luke arrived at 6:45 p.m.

Trustee Luke has met with Patricia Baynes to discuss the joint holiday event; it will be Dec. 6^{th} or the 13^{th} . And once again Trick or Treat in the business district will be Oct. 26^{th} 2-4p.m.
