CALL TO ORDER: Mayor Daly called the public hearing to order at 6:30 p.m.

PLEASE TAKE NOTICE that, for the purpose of adopting a codification of the local laws, ordinances and certain resolutions of the Village of Palmyra, said codification to be known as the "Code of the Village of Palmyra," a public hearing will be held by the Board of Trustees at the Village Hall in the Village of Palmyra, on the 17th day of November, 2003, at 6:30 p.m., to consider the enactment of the proposed local law described and summarized below:

PROPOSED LOCAL LAW NO. 2-2003

A LOCAL LAW TO PROVIDE FOR THE CODIFICATION OF THE LOCAL LAWS, ORDINANCES AND CERTAIN RESOLUTIONS OF THE VILLAGE OF PALMYRA INTO A MUNICIPAL CODE TO BE DESIGNATED THE "CODE OF THE VILLAGE OF PALMYRA"

This local law:

(1) States the legislative intent of the Board of Trustees in adopting the Code.

(2) Provides for the designation of the local laws, ordinances and certain resolutions of the Village of Palmyra as the "Code of the Village of Palmyra."

(3) Repeals local laws and ordinances of a general and permanent nature not included in the Code, except as provided.

(4) Saves from repeal certain local laws and ordinances and designates certain matters not affected by repeal.

- (5) Retains the meaning and intent of previously adopted legislation.
- (6) Provides for the filing of a copy of the Code in the Village Clerk's office.
- (7) Provides for certain changes in or additions to the Code.
- (8) Prescribes the manner in which amendments and new legislation are to be incorporated into the Code.
- (9) Requires that Code books be kept up-to-date.

(10) Provides for the sale of Code books by the village and the supplementation thereof.

(11) Prohibits tampering with Code books, with offenses punishable by a fine of not more than \$250 or by imprisonment for not more than 15 days, or both.

(12) Establishes severability provisions with respect to the Code generally

The wording has been changed to the sidewalk ordinance in order to clarify its meaning. Resident Kathy Ioele asked if there had been any changes made to the requirements for fence installations. Mayor Daly reported that none of the zoning requirements had been changed at all.

TRUSTEE REPORTS:

Trustee Salomon reported that the Town of Palmyra has received correspondence from Johnson Road residents requesting public water. The easiest place for the Town to get it would be from the Village. Although flows on Howell and East Foster Street are low, he believes that Johnson Road would be supplied through a different line. Trustee Salomon is looking into it further, as well as checking with the Town if they would be willing to share any expenses for the Village engineer.

Trustee Palmer reported that the fire truck damaged in the motor vehicle accident suffered minor frame damage and is repairable. It also looks like the Fire Department has found a way to fix the siren for less than \$1000. The fence bordering the cemetery along Crescent was damaged in the recent wind storm. A couple of residents have donated their downed evergreen trees to the Village. Roger will be using them as Christmas tress in the park.

Trustee Piccola reported on the Holiday Open House on December 6. Santa will be at the Palmyra Elementary for breakfast from 8:30 to 11:30, \$4 for adults \$2 for children, under 2 will be free. There will also be a photographer available for pictures with Santa

APPOINTMENTS: The Micro-enterprise loans will be reviewed by a committee from the WCIDA. Stu Brown suggested that the Village add two residents to this committee. Mayor Daly offered the names of Robert Culver and Richard Kirchhoff to serve in this capacity.

The Comprehensive Plan (Master Plan) Committee will be meeting once again. Stuart Brown requested that this committee be expanded. Returning committee members are Michael Boesel, James Elliott, Cindy Surline and Vicky Daly. Mayor Daly offered the names of Fred Alderman, Daniel Pope and Joseph VanScott to join this committee. Motion by Trustee Palmer, second by Trustee Piccola to appoint those names as recommended by the Mayor. Vote, 3 ayes. CARRIED.

<u>RECODIFICATION/LOCAL LAW NO. 2, 2003</u>: Trustee Palmer offered the following motion:

WHEREAS a public hearing was held the 17th day of November, 2003 by the Board of Trustees of the Village of Palmyra, notice of which was given as required by the Municipal Home Rule Law, the Open Meetings Law and the Village Law of the State of New York;

WHEREAS at said public hearing the Board of Trustees considered the enactment of proposed Local Law No. 2, 2003 - entitled A LOCAL LAW TO PROVIDE FOR THE CODIFICATION OF THE LOCAL LAWS, ORDINANCES AND CERTAIN RESOLUTIONS OF THE VILLAGE OF PALMYRA INTO A MUNICIPAL CODE TO BE DESIGNATED THE "CODE OF THE VILLAGE OF PALMYRA; and

WHEREAS all interested persons were given an opportunity to be heard with respect to the enactment of said local law;
