#### **TRUSTEE REPORTS:**

Trustee Hopkins - no report.

Trustee Piccola moved to accept the resignation with regrets from Steve Landgrebe of the Zoning Board. Second was made by Trustee Hopkins. Vote, 3 ayes. CARRIED. The Board instructed the Clerk Treasurer to contact Mr. Kurek about "moving up" from the alternate's position. For the highway, Trustee Piccola reported that Superintendent Boesel has been reviewing the OGS state contract for heavy trucks. If purchased off state contract, we will not have to bid out the dump truck.

Trustee Piccola seconded the motion. Vote, 3 ayes. CARRIED.

Attorney Clar reported that she has been working on the easements for the Howell Street project. Regarding the situation with Hub Lange, Attorney Clar was able to get an extension in which to file our response from Mr. Schnittman, counsel for Godwin Pumps, to April 20, 2005. She left a copy of the proposed law for the Cross Connection program (Back flow prevention) for Board review.

Attorney Clar researched the proposal from Finger Lakes Ambulance. Finger Lakes would like to enter into an agreement with the Palmyra Fire Dept. Ambulance in order to get reimbursement from Medicare when they are asked to provide ALS support to our ambulance. Although she had left that research at the office, she believes that Villages are not allowed to enter any such agreement. She will forward that research to the village.

# **NEW/OLD BUSINESS:**

Tom Rapp and Eric Smith attended the Board meeting to voice their concerns about parking on the south side of E. Charlotte and on Canandaigua Street at that intersection. The neighborhood has a high concentration of children and when cars park in front of Mr. Rapp's and Mr. Smith's homes the visibility is very poor. The Board will inform Superintendent Boesel that a couple of no-parking from here to corner signs need to be posted. If that doesn't alleviate the problem, the Board asked Mr. Rapp to let the Village know.

Trustee Hopkins seconded the motion. Vote, 3 ayes. CARRIED.

PITNEY BOWES POSTAGE MACHINE: The Clerk Treasurer reported on the Pitney Bowes postage machine. By February 2006, the end of our current lease, all machines must be upgraded to a digital machine. The Village can make the upgrade now and lock into the current pricing structure which will mean a higher payment of about \$29.00 per month. However, it will cost less to download postage to the new machine. The Board asked how long the price is good for and how long would the new lease run. The Clerk Treasurer will report back at the next meeting with the information.

**SURVEILLANCE EQUIPMENT:** Questions came up about the \$10,000 grant for the surveillance equipment, ie: is a new proposal coming in? what is the exact dollar amount for the system? have we received the money? Not being a big proponent of adding surveillance equipment to the marina, Deputy Mayor Palmer suggested that it be tabled until the April 4<sup>th</sup> meeting.

**SEWER CONTRACTS:** Tabled until April 4<sup>th</sup>, Board members should have information regarding number of users on Town sewer.

SEWER CONNECTION REQUEST: Correspondence from Attorney P.T. Rubery indicates that the buyer of Dr. Krause's Animal Hospital would like to connect to the Village sewer system. This requires crossing the Schade property and tying into Terry Vanderwall's sewer lateral which goes under Route 21. The Animal Hospital will allow the Schades to tie into "their" line and we may get a request for connection from them as well. Both parties understand that there may be a connection fee as well as annual charges. The closing for the veterinary clinic cannot take place until the issue about sewer use is finalized. Deputy Mayor Palmer is concerned that there is no permission in writing from Mr. Vanderwall. Richard Clayton, STES, expressed concern about the capacity of that lateral. Mr. Clayton will look into, DM Palmer will talk with Terry Vanderwall and the clerk treasurer will talk with Mr. Rubery.

Motion by Trustee Hopkins, second by Trustee Piccola, to enter executive session for contractual at 7:45 p.m. Vote, 3 ayes. CARRIED.

## **EXECUTIVE SESSION**

Motion by Trustee Piccola, second by Trustee Hopkins to re-enter public session with no action having been taken. Vote, 3 ayes. CARRIED.

**ADJOURNMENT:** Motion to adjourn at 8:00 p.m. by Trustee Piccola, second by Trustee Hopkins. Vote, 3 ayes. CARRIED.
