<u>CALL TO ORDER:</u> Mayor Daly called the meeting to order at 6:30 p.m. and had the following legal notice read:

NOTICE IS HEREBY GIVEN, that there has been introduced before the Village of Palmyra two proposed local laws, which, if adopted would amend chapter 183 of the Village Code entitled Vehicles and Traffic and Chapter 163 of the Village Code entitled Streets and Sidewalks. Proposed Local Law #1, 2004 will empower the Village Board to make future additions/deletions by Board resolution and publication, prohibits the parking of tractor trailer trucks and the like on residential streets and amends parking restrictions throughout the Village. Proposed Local Law #2, 2004 redefines the construction, removal and maintenance of any Village sidewalk.

NOTICE IS FURTHER HEREBY GIVEN that, pursuant to section 20 of the Municipal Home Rule Law, the Village Board will hold a public hearing on the 15<sup>th</sup> day of November, 2004 at the Palmyra Village Hall, 144 East Main Street, Palmyra, NY at 6:30 p.m. for the purpose of hearing comments for or against the adoption of the proposed local laws.

Any person may appear in person or by representative. Copies of the proposed local laws may be examined in the Village Clerk Treasurer's office during normal business hours.

Mayor Daly opened the floor for comments from the public, instructing them that the Board would listen to comments first on the proposed changes to the sidewalk law. As there were no forthcoming comments, she opened the floor for comments on the proposed changes to Chapter 183, Vehicles and Traffic. About 12 residents offered comments regarding the restriction of parking on village streets by tractor trailer trucks. Most of the residents in attendance feel this addition to the law is too restrictive. There were others that feel it is a safety measure that needs to be implemented. The Mayor closed the public hearing at 7:25 p.m.

LOCAL LAW #1, 2004: Motion was made by Trustee Salomon, second by Trustee Piccola to adopt Local Law #1, 2004 which amends Chapter 163 entitled Streets and sidewalks. Vote, 3 ayes. CARRIED.

 Dec. 7, VFW and American Legion – Dedication of WWII identifying signage. Request from Veterans for old signs – Motion was made by Trustee Palmer, second by Trustee Salomon to declare the olden wooden WWII veteran signs as surplus. Vote, 3 ayes. CARRIED. Motion was made by Mayor Daly, second by Trustee Salomon to donate the wooden signs to the VFW and American Legion. The signs have no monetary value. Vote, 4 ayes. CARRIED.

#### TRUSTEE REPORTS:

Trustee Palmer reported that Buildings and Grounds Superintendent Weaver has responded to Wayne County Water and Soil Conservation about the \$1600 grant.

Trustee Piccola submitted a letter from Kevin Bell indicating his interest in serving on the Planning Board. Motion was made by Trustee Piccola to appoint Kevin Bell to the Planning Board, his term from December 1, 2004 through November 30, 2009. Second by Trustee Palmer. Vote, 3 ayes. CARRIED. Once again Trustee Piccola outlined the activities for the Holliday Open House on Dec. 4<sup>th</sup>. There will be breakfast with Santa at the Elementary School at 8:30 am. with caroling, the book fair, the home business expo. Pictures with Santa will be available. Horse wagon rides will run in the Village from 10 am to 1 pm and the tree lighting in the Village Park.

Trustee Salomon moved to adopt the following resolution:

### PERMISSIVE REFERENDUM

**NOTICE IS HEREBY GIVEN** that the Board of Trustees of the Village of Palmyra, Wayne County, New York, adopted a resolution during a meeting on November 15, subject to Permissive Referendum as follows;

BE IT RESOLVED that a sum up to and not to exceed FORTY FIVE THOUSAND DOLLARS (\$45,000) shall be expended from the Capital Reserve Sewer (HR4) for the purpose of purchasing a new trailer mounted sewer cleaner.

Following publication, the foregoing resolution shall be posted in six (6) conspicuous places and in accordance with Section 9-902 of Village law, shall take effect in thirty (30) days.

<u>LOCAL LAW #2, 2004 – VEHICLES AND TRAFFIC:</u> The Board decided to table voting on LL#2 Vehicles until December 20, 2004.

Motion by Trustee Piccola, second by Trustee Palmer to enter executive session at 8:55 p.m. for discussion of possible litigation. Vote, 3 ayes. CARRIED.
